# SENATE

Friday, April 23, 1965

Senate called to order by the President.

Prayer by Rev. Royal Brown of Gardiner.

On motion by Mr. Hilton of Somerset, the Journal of yesterday was read and approved.

#### Order

Out of order and under suspension of the rules, on motion by Mr. Harding of Aroostook,

Which was read a second time. Mrs. SPROUL of Lincoln: Mr. President, this bill bothers me a little. As I see it, residents of the state would be required to pay a sales tax on boats which are being constructed within the state and non-residents would not be required to pay a tax. Now when I was campaigning some time agonot too long ago either - I went Boothbay into a boatyard in Harbor. reputable boatvard а building fine yachts and other boats. I wandered around there by myself for a while and I finally ended up in the office of the man who ran the boatyard, and he sat me down and said, "Do you intend to vote for such and such a tax?" I won't say which one or the President of the Senate will say it is not germane to the issue but before I had a chance to even answer he proceeded to spend about three-quarters of an hour on why he did not wish to pay this particular kind of tax or to have me vote for it, and he further said he would not vote for me if I "Well, how about the sales tax? Doesn't the sales tax on boats bother you?" Mind you, this was a good and reputable boatyard. He said, "No, the sales tax doesn't bother me as much as the other would.'

And so, for those reasons, I object to this bill, and I also object for another reason. If we keep exempting taxes just what kind of a tax are we going to have and where does the majority party figure they are going to get money enough to pay the bills that are before this session? I move the bill be substituted for the report.

The PRESIDENT: The Chair would inform the Senator that the

pending question is engrossment. Does the Senator wish to move indefinite postponement of the bill?

Mrs. SPROUL: I move indefinite postponement of the bill.

Mr. MAXWELL of Franklin: Mr. President, this bill, L. D. 1470 was introduced by me as Chairman of the Taxation Committee and this was to allow the larger boatbuilding yards in the State of Maine to be exempt from the sales tax on boats sold outside of the state, and this includes vessels running into several millions of dollars, and we penalize these shipyards by making them add this four cents on a dollar tax to vessels constructed for out-of-state use they would be licensed and documented in some other state; in fact at the present time there is the possibility that Bath Iron Works may bid on five vessels, a total bill of approximately \$55,000,000. This is economy that we want to come into the State of Maine because this creates jobs. In talking with the Tax Assessor, Mr. Johnson, he informed me that presently this would only cost the State of Maine in exemptions at the present time somewhere around \$10,000. If these yards are to get into this big business they must be exempt from having to add four cents more on a dollar for this purpose. I therefore hope that the motion of the Senator from Lincoln does not prevail and I would ask for a division. I would like also to say that at the hearing there were absolutely no opponents to the bill as I remember it and several of the smaller yards came in and supported it and all of the Boat Builders Association of Maine was in support of it.

GLASS of Waldo: Mr. Mr. President, I am somewhat concerned with the figure that Maxwell mentioned as Senator having come from Mr. Johnson. Just coincidentally, I might say, I was in Southwest Harbor a few weeks ago talking with the proprietor of the Hinckley boatyard. Now he is building fibreglass yachts of some thirty-five or forty feet that sell for a sum in excess

of fifty thousand dollars. I should apologize for my ignorance because I am not familiar with the tax but I would assume that the four per cent would be based on the sale price of the yacht of fifty thousand dollars. These yachts for the most part, I was informed, are being sold outside the state. He also informed me that they are being completed at the rate of one or two per week. Now it is altogether possible that this gentleman is not paying the sales tax, but if he is and if my figures are correct, in the space of a month his yard alone is responsible for the ten thousand dollars that Mr. Johnson says is involved here. I would appreciate someone tabling this bill until I can acquaint myself with the exact amount of revenue that will be lost.

On motion by Mr. Mendell of Cumberland the bill was tabled until the next legislative day pending the motion of the Senator from Lincoln, Senator Sproul, that the bill be indefinitely postponed.

#### PROCLAMATION

WHEREAS the State of Maine has been historically known for among other things the potato, one of the largest cash crops in the state, and the vegetable used throughout the world, and

WHEREAS the Maine Potato Commission through coordinated advertising, merchandising, marketing and publicity has a continuous program for the purpose of increasing sales and building public acceptance of the Maine potato at retail and consumer levels, now therefore,

I, John H. Reed, Governor of the State of Maine, do hereby proclaim April 23, 1965 as Maine Potato Day. Be it known that Maine is recognized throughout the United States as the source of quality potatoes.

Given at the office of the Governor at Augusta and sealed with the Great Seal of the State of Maine this fifteenth day of April one thousand nine hundred and sixty five and of the independence of the United States of America, the one hundred and eighty-ninth.

The PRESIDENT: The Senate is very pleased today to have as its guest the living trademark of the Maine potato industry, Miss Brenda Baker, and the Chair at this time would request that the Senators from Aroostook, Senator Harding, Senator Manuel and Senator Violette escort Miss Brenda Baker to the rostrum and present her to the Senate and to make any remarks he might care to make.

Miss Brenda Baker was escorted to the rostrum by Senators Harding, Manuel and Violette amid the applause of the Senate.

Mr. HARDING of Aroostook: Mr. President and members of the Senate: I am very pleased at this time to be here to represent Aroostook County and to have with me on the rostrum Senator Manuel and Senator Violette on this Maine Potato Day. As has already been mentioned, there was placed on your desks a bag of Maine potatoes. I know you will enjoy them, and let me assure you that despite what you may hear there are plenty more in Aroostook County just like them if not better, so if you have any problem in finding potatoes I am sure that any of the senators from Aroostook County will be able to find a source for you that you will be pleased with.

Today we have with us Miss I know that you Brenda Baker. will find her attractive and pleasant, and let me also say that she is an example of the kind of girls we have in Aroostook County and there are plenty of other girls there like her. I am sure you will enjoy coming to Aroostook County not only for that reason but for many other reasons as well. At this time I am extremely pleased to present Miss Brenda Baker to you who I think has a few words to say on her own behalf.

Miss BRENDA BAKER: Mr. President, Mr. Secretary and gentlemen: It is a real pleasure to be here and I thank you so much

for letting us interrupt you this morning. As you may or may not know, I am a living talking trademark for the Maine Potato Industry and it is my pleasant task to travel throughout the country-I have been as far west as Dallas. Texas---bringing news and facts to the public and the housewife on Maine potatoes. I must tell you right now that not only do we talk of Maine potatoes but we talk of the State of Maine and all of its other wonderful resources. It has been a wonderful job for me and I have enjoyed it immensely. We have brought you, as you know, a gift of potatoes which are on your desks, and it is like finding gold from what I understand, no matter what you say, because they are hard to get. Thank you very much. It has been nice talking to you this morning. (Applause)

The PRESIDENT: This is what is known as an Aroostook County take-over here.

Mr. Cahill of Somerset was granted unanimous consent to address the Senate.

Mr. CAHILL: Mr. President, up until this point Senator Harding has stated that they represent Aroostook County but from here on in as far as I am concerned he does not represent Aroostook County. (Laughter)

On motion by Mr. Manuel of Aroostook, the Senate voted to take from the table the 20th tabled and unassigned item (S. P. 421) (L. D. 1356) Senate Report, Ought to pass in new draft (S. P. 490) (L. D. 1453) under same Title from the Committee on Agriculture on bill, "An Act Relating to Use of Moneys Received from the Potato Tax"; tabled by that Senator on April 9 pending acceptance of the report; and the same Senator moved acceptance of the committee report.

Which report was accepted, the bill read once, Senate Amendment A (presented by Senator Manuel of Aroostook) was read and adopted and the bill as amended was tomorrow assigned for second reading.

# Order

Out of order and under suspension of the rules, On motion by Mr. Carter of Kennebec,

WHEREAS, there are only 2,300 dairy farmers left in the State of Maine, the core of a 40 million dollar industry of vital importance to the economy of the State, and much discrimination exists among this group, inasmuch as there are 800 on the Maine market and 1,500 on the Boston market with those on Maine Market getting 47 cents per cwt. more than those on the Boston market; and

WHEREAS, much of their market is seriously affected by the importation of out-of-state milk coming into the State to supply Federal Bases—and this in itself constitutes a considerable amount of the Class 1 milk consumed in Maine; and

WHEREAS, the cost of production of milk on the producer level has shown a steady increase due to local tax increases and rising costs of freight and farm equipment, and there has been a corresponding decrease in the amount of profit for the producer; and

WHEREAS, there are varied interpretations and applications of the Federal Standards by individual inspectors and the present standards applied seem to vary from dairy farm to dairy farm; and

WHEREAS, the milk produced in Maine is of the highest standard and quality, but there is no means of discerning where the milk comes from when purchased by the consumer either through labeling or other means of identification to protect both the producer and the consumer; and

WHEREAS, in the year 1964 only Maine and New Hampshire showed a definite decline in shipments to the Massachusetts - Rhode Island market and all other states, Massachusetts, Connecticut, Upper New York, Rhode Island and Vermont, were either stable or showed an increase; and

WHEREAS, the Federal Standards as interpreted by the individual inspectors are not consistent in their application between these seven states on the Massachusetts-Rhode Island market; and

WHEREAS, there is a variation in the charging of rates for trucking of milk from producer to the dairy regardless of the distance involved; and

WHEREAS, the producer on the Maine market has no definite time period whereby he can expect payment for his milk delivered to the dairy, and this causes undue hardship on the producer; and

WHEREAS, there have been charges of inequities of pricing at the consumer level; and

WHEREAS, there is much disagreement on many factors which now and in the future will affect a sound milk marketing program in Maine. There is need of further research, study and dissemination of the elected information to our dairy industry and to Maine consumers; now, therefore, be it.

ORDERED; the House concurring, that a joint interim committee be created consisting of the President of the Senate and 3 Senators to be named by the President of the Senate, and the Speaker of the House of Representatives and 4 Representatives to be named by the Speaker of the House, organized to conduct hearings and research to carry out the purposes of this order; and be it further

ORDERED; that said committee shall have the power to call and summon witnesses and records and to administer oaths; and be it further

ORDERED, that said committee shall report its findings and recommendations to the 103rd Legislature; and be it further

ORDERED; that the sum of \$5,000 be appropriated from the legislative appropriation to cover expenses of said committee. (S. P. 517)

Sent down for concurrence.

Mr. MOORE of Washington: Mr. President, I would like to inquire if I would be in order to table this pending passage.

The PRESIDENT: The motion to table would be in order.

Mr. MOORE: Mr. President, I move that the order be tabled until May 6.

Thereupon, on motion by Mr. Harding of Aroostook

Recessed to the sound of the gong.

# After Recess

Senate called to order by the President.

Thereupon, Mr. Moore of Washington was granted permission to withdraw his motion to table S. P. 517.

The PRESIDENT: The pending question is passage of the order.

Mr. HOFFSES of Knox: Mr. President, I would like to move that this item be tabled until Wednesday next pending passage.

Mr. President, I ask for a division.

Mr. HOFFSES: Mr. President, my reason for requesting tabling is in lieu ---

The PRESIDENT: The Senator is out of order in debating a tabling motion.

The motion before the Senate is the motion of the Senator from Knox, Senator Hoffses that the bill be tabled and a division has been requested.

A division of the Senate was had.

Five having voted in the affirmative and seventeen opposed, the motion to table did not prevail.

Thereupon, Joint Order S. P. 517 received a passage, and on motion by Mr. Carter of Kennebec was ordered sent forthwith to the House for concurrence.

On motion by Mr. Harding of Aroostock

Adjourned until Tuesday next at ten o'clock in the morning.
