Senate called to order by the President.

Prayer by Rev. Irvin E. Koelker of Berwick. On motion by Mr. Norris of Ox-

ford, the Journal of yesterday was read and approved.

Mr. Boisvert of Androscoggin was granted unanimous consent to address the Senate:

Mr. BOISVERT: Mr. President, The word is out and Maine's agog, from Kittery to Fort Kent

They're discussing busted gavels and the money that's been spent To keep the Senate President supplied with "spears" to wreck If this keeps up we'll have to use the "surplus" soon, by heck! The Senate's on the job — to the rescue we have come

Senator Violette of Aroostook presented the following Order and moved its passage:

# SENATE ORDER PROPOUNDING QUESTIONS State of Maine

WHEREAS, it appears to the Senate of the 102nd Legislature that the following are important questions of law, and that the occasion is a solemn one; and

WHEREAS, there is pending before the Senate a Bill entitled "An Act to Authorize Municipalities to Finance Industrial and Recreational Projects," (H. P. 1091), (L. D. 1487); and

WHEREAS, the constitutionality of said Bill has been questioned; and WHEREAS, it is important that the Legislature be informed as to the constitutionality of said Bill: NOW, THEREFORE, BE IT ORDERED, that the Justices of the Supreme Judicial Court are hereby respectfully requested to give to the Senate, according to the provisions of the Constitution on its behalf, their opinion on the following questions, to wit:

#### Question 1:

Will revenue obligation securities issued under the provisions of said bill constitute the creation of a debt or liability of a city or town within the meaning of Article IX, Section 15, of the Maine Constitution which will have to be taken into account in computing the maximum aggregate of debts and liabilities which may be created by a city or town as therein provided for?

#### Question 2:

Does subsection 1 of Section 5331 of said bill, which provides that no securities shall be issued thereunder until the general purposes for which the securities are

to be issued and the maximum principal amount of such securities "have been approved by a majority of the votes cast on the question and the number of votes cast is at least 20 percent of the total vote for all candidates for governor cast in the municipality at the last gubernatorial election, violate Article IX, Sec. 8-A, of the Maine Constitution which provides that the "registered voters" of a municipality may, "by majority vote" authorize the issuance of notes or bonds? Question 3:

Do Sections 5339, 5340 and 5341 of said bill, which provide that projects financed under the bill shall be exempt from taxation so long as title thereto remains in the name of the municipality, that the leasehold interest of the lessee of any project is subject to taxation and that, as an alternative to taxation a municipality may provide in the lease or contract for payments in lieu of taxation, violate the provisions of Article IX, Section 8, of the Maine Constitution?

#### Question 4:

Will revenue obligation securities issued under the provisions of said bill for the purpose of paying the cost of acquiring, constructing, reconstructing, renewing or replacing revenue producing recreational facilities, be issued for a proper municipal purpose?

Mr. JUTRAS of York: Mr. President, I move that we accept the Minority report and I would like to state my reasons why.

The PRESIDENT: The senator

The PRESIDENT: The senator is out of order. The motion before the Senate is the motion of the Senator from Aroostook, Senator Harding, that we accept the Majority "Ought to pass" report of the committee. That motion is debatable and the Senator may speak to that motion.

Mr. JUTRAS: Mr. President, this cigarette tax by the State of Maine I believe is unwise in view of the fact that for the first time we will have a tax on a par and in some cases below the cigarette tax of surrounding states. We have many tourists coming into the State of Maine in the summertime and we hope to have them on a year-round basis.

When they do come, before they reach York County, because of a lower cigarette tax in other states, especially in New England, they buy all of their cigarette supplies in those states. They would not have to do that if we did not at this session raise our cigarette tax just because other states are raising their cigarette tax this year. It would afford us an opportunity to derive as much income by not raising this tax, I believe. I could produce statistics but I will not bother to produce these statistics because, while I believe in them you can make statistics say a lot of things that they do not really mean if you are prejudiced. I am simply stating this as a matter of record: that for the first time the State of Maine has a chance to be below other states and sell more cigarettes achieve as much revenue by not raising the cigarette tax at this For that reason, I against the "Ought to pass" port.

The FRESIDENT: The motion before the Senate is the motion of the Senator from Aroostook, Senator Harding, to accept the Majority "Ought to pass" report of the committee. All those in favor of accepting the Majority "Ought to pass" report of the committee will please say aye; those opposed no.

A viva voce vote being had, the motion prevailed and the Majority "Ought to pass" report of the committee was accepted, the bill was given its first reading, Committee Amendment "A" was read and adopted and the bill was assigned for second reading on the next legislative day.

Mr. SNOW of Cumberland: Mr. President, I would ask if L. D. 320 is in the possession of the Senate. That is An Act Increasing Salary of Legislative Finance Officer H. P. 252, L. D. 320.
