That the 102nd RESOLVED: Legislature extend congratulations to the lady Senator on this august occasion; and be it further

RESOLVED: That a copy of resolution be sent to Senator Smith by the Secretary of the Senate: and be it further

RESOLVED: That the Secretary of the Senate send the Senator a rosebud from the 102nd Maine Legislature on this auspicious occasion.

Thereupon, on motion by Mr. Harding of Aroostook, the Senate Recessed for five minutes.

### After Recess

Senate called to order by the President.

The PRESIDENT: The question before the Senate is the acceptance of either report on L. D.

Thereupon, on motion by Mr. Moore of Washington, the Majority Ought to pass report was accepted, the bill read once; and on motion by Mr. Harding of Aroostook, the rules were suspended, the bill read a second time and passed to be engrossed.

Sent down for concurrence.

On motion by Mr. O'Leary of Oxford, the Senate voted to take from the table Item 6-3 on page 3 of the supplemental calendar, Bill, "An Act Exempting State Owned Motor Vehicles and Trailers from Registration and to Provide Special Plates for U. S. District Attorney and Assistant U. S. District Attorneys," (S. P. 462) (L. D. 1393) tabled by that Senator earlier in today's session pending adoption of House Amendment "A": and on further motion by the same Senator, House Amend-ment "A" was adopted and the bill as amended was passed to be engrossed in concurrence.

Out of order and under suspension of the rules, on motion by Mr. Jacques of Androscoggin:

WHEREAS, the Legislature requires for its use, comprehensive factual information concerning both spirituous and vinous liquor and malt industries as they affect the State of Maine in order to make complete study of the liquor laws and the State Liquor Commission rules and regulations relating to these industries and in dedition, to study the licensing of persons operating licensed premises and the penalties for liquor law or commission rule and regulation violations in connection therewith; and

WHEREAS, such study shall embrace the Liquor Commission structure of sales through state stores and taxes imposed on all

liquor; and

WHEREAS, such study shall be comprehensive with a view of codifying, clarifying, and modernizing such law, commission rules and regulations and the committee shall report back to the 103rd Legislature with recommendations together with proposed drafts of recommended legislation; now, therefore, be it

ORDERED, the House concurring, that there shall be a committee of nine appointed to carry out the purposes of this order, as follows: The President of the Senate and the Speaker of the House shall appoint 2 members each from their respective branches, 2 members to be appointed by the Governor, 2 members to be appointed by the State Liquor Commission and the Attorney General, who in addition will act as counsel for the committee, and be it further

ORDERED, that there is appropriated from the Legislative Appropriation the sum of \$7,500 to carry out the purposes of this Order. (S. P. 574)

On motion by Mr. Jacques of Androscoggin, the Order received passage and was sent down for concurrence.

The President laid before the Senate Item 6-5 House Report from the Committee on Judiciary, Ought to pass in new draft (L. D. 1559) on Bill, An Act Relating to Relocation Payments in Eminent Domain (H. P. 739) (L. D. 976) tabled earlier in today's session by Senator Violette

of Aroostook pending acceptance of the Committee report; and on further motion by the same Senator, the Ought to pass report was accepted and the bill read once.

On motion by Mr. Violette of Aroostook, House Amendment A was read and indefinitely postponed.

The same Senator presented Senate Amendment A and moved

its adoption.

Which amendment was read (S-268) and adopted and the bill as amended was tomorrow assigned for second reading.

The President laid before the Senate Item 2 under Tabled and Specially Assigned matters, (S. P. 560) (L. D. 1567) Bill, An Act Relating to Definition of Licensee under Liquor Law"; tabled earlier in today's session by Senator Harding of Aroostook pending passage to be engrossed; and that Senator yielded to Senator Shiro of Kennebec.

Mr. SHIRO of Kennebec: Mr. President, I wish to submit Senate Amendment A and move its adoption.

The Secretary read Senate Amendment A S-266.

Mr. SHIRO of Kennebec: Mr President, may I say a few words on this amendment?

The PRESIDENT: The Senator may.

Mr. SHIRO of Kennebec: President, I would simply like to state for the record that this particular amendment has to do with the definition of hotel under the liquor laws and that the definition which is contained in the amendment will relate solely hotel as definition of a applied under the liquor laws of the State of Maine and it would not affect the definition of hotel under other laws. Also, it simply provides that a hotel may lease a portion of its premises to a lessee and that a liquor license may stand in the name of a lessee, whereas under the present laws, it cannot be done. That is the only purpose of the particular amendment.

Thereupon, Senate Amendment A was adopted, the bill was

passed to be engrossed and sent down for concurrence.

On motion by Mr. Duquette of York, the Senate voted to take from the table Item 1 under Tabled and Specially Assigned Items (H. P. 248) (L. D. 316) on page 3 of the calendar, Resolve Providing Increases in Retirement Allowances for Certain Retired Fish and Game Wardens tabled by that Senator earlier in today's session pending final passage; and the same Senator moved final passage.

Mr. SHIRO of Kennebec: Mr. President, I present Senate Amendment A and move its adoption.

Thereupon the Senate voted to reconsider its former action whereby the bill was passed to be engrossed; Senate Amendment A (S-264) was read and adopted

and the bill as amended was passed to be engrossed in non-concurrence.

Sent down for concurrence.

Mr. JACQUES of Androscoggin; Mr. President, is the Senate in possession of L. D. 767, S. P. 230, An Act Providing for a New Charter for the City of Lewiston?

The PRESIDENT: The Chair would inform the Senator that it is having been requested by the Senator.

Thereupon, on motion by Mr. Jacques of Androscoggin, the Senate voted to reconsider its former action whereby the bill was passed to be engrossed and to further reconsider its action whereby it adopted Senate Amendment A.

The same Senator presented Senate Amendment A to Senate Amendment A and moved its adoption.

Senate Amendment A to Senate Amendment A (S-263) was read and adopted, Senate Amendment A as amended by Senate Amendment A was adopted, and the bill as amended was passed to be engrossed and sent down for concurrence.

On motion by Mr. Harding of Aroostook

Adjourned until tomorrow morning at nine-thirty o'clock.
