The enactment of bill is practically assured cause the Governor indicated the outset of the session that he was in favor of this Memorial Cemetery for Veterans. I do think that in our lifetimes we shall see this Veterans Memorial Ceme-tery become a focal point of historical value here in the State of Maine. I know it is a fine tribute to the veterans of this State. Thank you.

D. 1526) Mr. O'LEARY of Oxford: Mr. President, in regard to Item 8-6, L D. 1526, I was the author and sponsor of this legislative document that this bill is a redraft of, and there has already been passed an order for the Legislative Research Committee to study these laws, and I believe it would be best at this time, as sponsor of this legislative document for me to move to indefinitely postpone this bill and all its accompanying papers,

The PRESIDENT: The Senator from Oxford, Senator O'Leary, moves that Item 8-6, L. D. 1526, S. P. 535, be indefinitely postponed.

Mr. MENDELL of Cumberland: Mr. President, we had a lengthy hearing on this bill, we redrafted it many times. This bill has the approval of the Secretary of State, the Attorney General, the head of the Motor Vehicle Department, it has been gone over and over and all the inequities have been taken out of it. The bill as written is a good bill, it is a revision, and, although no bill may be perfect. I think this comes pretty close to doing the job that we wanted to do, and I hope that we defeat the motion of Senator O'Leary.

Mr. O'LEARY of Oxford: Mr. President, I would just like to read into the record the following letter:

"This is to respectfully advise the Senate that this association. the Maine Automobile Dealers Asthe Used sociation, Cars. the Trucks and Parts Association have on this date agreed unanimously that L. D. 1526 should be indefinitely postponed at this session of the Legislature. As members of this Senate are aware, the contents of this bill and accompanying amendments have gone from House to Senate and back again for several weeks, with the results that the three associations involved and those who are most seriously affected have not been able to reach an accord on such short notice and this late legislative hour. In view of the fact that a joint order referring the entire matter to the Legislative Research Committee appears to

have the support of both legislative bodies, the aforementioned associations feel that L. D. 1526 should not be enacted. Each of the associations represents an important part of our State's economy and has concluded that the only way the laws can be written to satisfy the requirements of each is to get together with the Legislative group and spell out the individual needs and to enact appropriate proceed legislation. Accordingly, we urge the Senate to exercise its privilege of indefinite postponement."

This is all I am requesting as the original sponsor of this bill. I have had my problems with the people who have been administering this in the past, and I think that the Legislative Research Group will come up with something we can all live with. I request a division.

Mr. MENDELL of Cumberland: Mr. President, to repeat an old phrase, this bill is a good bill. Actually as far as these different associations are concerned, one or two of them, I believe at this point, are in agreement with this bill. Actually all this bill is going to do as far as money is concerned, it is going to cost the new car dealers about a dollar per plate, and I do not think that is too much to ask of the new car dealers. Once again, I wish that the Senate would defeat Senator O'Leary's motion.

The PRESIDENT: The motion before the Senate is the motion of Senator O'Leary of Oxford that L. D. 1526 and all accompanying papers be indefinitely postponed. A division has been requested.

Mr. O'LEARY of Oxford: Mr. President, I move that we reconsider our action where this bill was passed to be engrossed.

Mr. HARDING of Aroostook: Mr. President, I oppose the motion and ask for a division.

Mr. O'LEARY: Mr. President, may I speak briefly to my motion?
The PRESIDENT: The motion is debatable.

Mr. O'LEARY: Mr. President and members of the Senate: This morning I had distributed to each of your desks a green sheet that outlines the deer hunting zones throughout the State of Maine. I would like you to know that in this southwestern zone there are nine counties, Oxford, York, Cumberland, Androscoggin, Lincoln, Sagadahoc, Waldo, Kennebec and Knox. I would say that better than two-thirds of the population of this State is in this area.

I have here in front of me the Annual Report and Review of Operations of the Department. They want more money. We have granted them more money under the raise in hunting and fishing licenses. At the present time your non-resident hunters pay into this fund approximately 31 per cent where the resident hunters would pay perhaps 22 per cent. However,

what you are doing under this bill— this is Vacationland and there are a number of people who have already made their reservations in the resort areas throughout this southwestern zone for the coming season, so the camp owners will notify these people that they can still have their reservations but that they are not entitled to hunt in the State of Maine. This amendment that am offering will just set the effective date of the bill to January 1, 1966 and we can go on from there. I request the support of all the people in these counties who are affected by this bill.

The PRESIDENT: The motion before the Senate is the motion of the Senator from Oxford, Senator O'Leary to reconsider our action whereby we passed this item to be engrossed.

Mr. HARDING of Aroostook: Mr. President and members of the Senate: I speak on this amendment and not on the merits of the bill. This bill has been debated in this legislature at great length, there have been two Committees of Conference, and we are, as you know, I hope, nearing the end of this session. We are coming to the point where many of us are going to find that some things we wanted so badly we are not going to get. It does trouble me greatly to oppose the motion of my good friend and colleague, the Senator from Oxford, Senator O'Leary, but if we are ever to get out of here we must finally accept the decisions which have been made, and, if his motion were to prevail, as you know, this whole thing would go back to the House with the amendment on it, it would there be debated again, we would have to wait for this to be re-engrained again, and it would mean a great deal of delav.

I am sorry, as I think many of you are, that this is not to the complete liking of the good Senator, but I would hope that in a spirit of cooperation on this matter that has been reported out by two Committees of Conference you would support me in my position of opposing his motion.

The PRESIDENT: The motion before the Senate is the motion to reconsider our action whereby we passed L. D. 1375 to be engrossed. A division has been requested. All those in favor of the motion to reconsider will please rise and remain standing until counted.

A division was had. 9 having voted in the affirmative and 23 opposed, the motion to reconsider did not prevail.

The bill was then passed to be enacted.

Bill, An Act Increasing Compensation of Members of the Legislature, the Governor, Court Justices and Certain Department Heads. (S. P. 520) (L D. 1497)

Mr. MENDELL of Cumberland: Mr. President, I move that we reconsider our action whereby we passed this L. D. to be engrossed.

Mr. HARDING of Aroostook: Mr. President, I rise in opposition to that motion and would ask for a division

Mr. MENDELL of Cumberland: Mr. President, I know I will probably lose this motion, but, notwithstanding that I would like to point out that we are 13th from the bottom in the nation as far as Maine is concerned in per capita income. I think we should bring the legislature at least up to 13th place. At the present time as far as legislative pay is concerned we are in third position from the bottom in the United States. In fact, we receive less here in this great State of Maine than an unskilled laborer. This pay raise that we voted up to \$2000 will bring us up to approximately \$110 a week whereas now we receive about \$70 per week. I would like to have this as a matter of record, and I ask for a division of the Senate.

Mr. HARDING of Aroostook: Mr. President and members of the Senate: It is not easy for me to oppose my good friends and colleagues on these matters and especially the good Senator from Cumberland, Senator Mendell. I can agree with the merits of these matters which he has mentioned, but again we have to face the moment of reality when we are not going to be able to accomplish all of those things which so many of us hoped we would accomplish for the State of Maine.

I would like to mention to the members of the Senate, as I am sure you know, that the leadership has spent literally weeks working out this financial package. We have had to sacrifice some things. If I may make a personal note, a bill which I very much treasured and which is on the Special Appropriations Table will be sacrificed because I recognize there are just not the funds to do it. The reason that I have to oppose the good Senator from Cumberland, Senator Mendell, is that we do not have the money to pay the increase which his bill first called for. I know it is going to take courage for us to recognize some of our limitations, but I believe that this great body in its deliberations has shown great courage in facing the issues during this session and I hope you will bear with me and show the same kind of courage in opposition to this motion.

The PRESIDENT: The motion before the Senate is the motion of Senator Mendell of Cumberland, that the Senate reconsider engrossing; a division has been requested.

A division of the Senate was had.

Five having voted in the affirmative and twenty-five opposed, the motion to reconsider did not prevail.

Mr. O'LEARY of Oxford: Mr. President, I would ask, of any member in the Senate who may know, if this is not a private school?

The PRESIDENT: The Senator from Oxford, Senator O'Leary, directs a question through the Chair to any Senator who may answer if he so chooses.

Mr. HARDING of Aroostook: Mr. President, as a member of the Appropriations Committee I would answer the Senator's question by saying this is a private academy, however it is the school which serves a large area. I believe it serves the areas of China, South China, Palermo, Liberty and parts of some other small towns in the area. It is the only high school in that area. I know a lot of us would wish this area would form a school administrative district and take care of some of their problems in that manner. However, I would point out that under this arrangement by virtue of this bill it will cost the State a great deal less than it would have cost the State had a school administrative district been formed. I understand that this has been done in the past in given instances. This bill was reported out, unanimously I believe, by the Appropriations Committee. It is one of the compromises I suppose you make if you want to do these things that should be done for the State to provide adequate educational facilities for our students. This will serve a great number of students. The expenditure called for is not great, it is \$25,000. It will be

seat money, so to speak, to give the area the courage and incentive it needs to build this new building. So, on that basis I would hope that the Senate would go along with the unanimous report of the Appropriations Committee.

Mr. O'LEARY of Oxford: Mr. President, I think in this instance I am not aware of any other private school that the State is financing and I believe that we are going to be setting a dangerous precedent, although we may have done it in the past in some instances of which I am not aware. I think this is an area that we should not get into and we should not ask the people of the State of Maine to support private schools. I move for the indefinite postponement of this bill and all its accompanying papers and I request a division.

Mr. CAHILL of Somerset: Mr. President, I would like to inform the Senator from Oxford that the State does and has in the past granted money for private schools if they serve as a public school in that area, which I believe Erskine does. Higgins, for instance, six years ago got fifty thousand dollars out of the state for new buildings over there or renovations of some of their old buildings, and they do serve as a public school in that area. For that reason the State went along with the appropriation. I would hope that the motion to indefinitely postpone this bill would not prevail.

Mr. SHIRO of Kennebec: Mr. President I know the area well in which this school is located and I am sure that the Appropriations Committee has given this very careful thought before allowing this appropriation. I can only state that most of us know that our educational facilities, especially in rural areas, and particularly in the area in which this school is located, are somewhat less than adequate. I know that with this appropriation, just as Senator Harding has stated, it would be of great benefit to the children attending this school. So I would wholeheartedly say that it would be extremely unfortunate if this

particular bill were not enacted by this Senate. I would hope that the Senate would strongly support the motion made by Senator Harding that this bill be enacted.

Mr. O'LEARY of Oxford: Mr. President, in view of the facts that have been stated by the other senators here this afternoon, I would request to withdraw my motion.

The PRESIDENT: The Senator may.

Thereupon, the bill was passed

Mr. O'LEARY of Oxford: Mr. President, I ask for a division.

The PRESIDENT: The motion before the Senate is the motion to recede and concur.

A division of the Senate was had.

Mr. GLASS of Waldo: Mr. President, I approach this with fear and trepidation because I am showing my ignorance, but would some member of the Appropriations Committee explain exactly what this is. I rise not to object to the order but to the fact they are increasing undedicated revenue. How is this accomplished? Would someone answer that question?

The PRESIDENT: The Senator from Waldo, Senator Glass, directs an inquiry through the Chair to any Senator who would care to answer.

Mr. HARDING of Aroostook: Mr. President and members of the Senate: In attempting to answer the question I will say that this is a part of the agreed financial package, let us say, that the Democratic leadership and the Republican leadership arrived at some two or three weeks ago. If you recall, there was a question then as to whether or not we would spend surplus and apparently there was objection to spending surplus for recurring items, and so the Governor consulted with his department heads, and after his own thinking on it he believed that it was provident to raise the estimates for the coming year \$3,750,-That is what this is with one exception. The Democratic leadership in its wisdom felt that it was provident to raise the sales tax estimate by another \$42,500. This is the way we may accomplish what was proposed here two or three weeks ago. I might mention that I discussed this joint order with the Governor about an hour ago and that this was with his blessing except for the \$42,500, and that is the amount which we have added.

Mr. GLASS of Waldo: Mr. President, I would like to thank the

Senator from Aroostook for his reply.

Thereupon the order received passage and was sent forthwith to the House for concurrence.

The President placed before the Senate, Bill, "An Act to Authorize the Establishment of an Area State Operated Vocational Technical High School in York County and the Issuance of Not Exceeding One Million One Hundred and Fifteen Thousand Dollar Bonds of the State of Maine for the Financing Thereof" (H. Mr. HARDING: I now move that we reconsider our action whereby we adhered, and I would like to speak briefly to my motion.

The PRESIDENT: The Senator may.

Mr. HARDING: The reason I would like to ask your forbearance in my motion for reconsideration is that several senators have approached me and mentioned that they did not understand the motion I made to adhere and therefore they did not understand the consequences of it. During this session I have tried the could to be fair with all members of the Senate and it troubles me that there are members here who feel that I was unfair in this matter. I asure you that it was not intentional. During the rush of the day there have been many matters brought to my attention, and so if you will forgive me for the oversight if there was one, I would like to have you go along with this motion so the bill may be debated because there are some people here who have view-points they wish to express and they were not able to because of this situation I mentioned.

The PRESIDENT: The motion before the Senate is the motion of the Senator from Aroostook, Senator Harding, that the rules be suspended and we reconsider our action whereby we adhered on L. D. 1135.

Mr. JACQUES of Androscoggin: Mr. President, this bill was indefinitely postponed once, it went to the other body and came back here and again it was killed, so why don't we give it a decent burial and kill it right now once and for all. When the vote is taken, Mr. President, I move for a division.

Mr. JUTRAS of York: Mr. President, I do not believe that Senator Jacques is qualified as a funeral director, he is a private eye, so therefore if there is to be a committal or a burial I request I be considered. (Laughter)

The PRESIDENT: The motion before the Senate is the motion to reconsider our former action whereby we adhered to our former action to indefinitely postpone L. D. 1135. This takes a two-thirds vote. All those in favor of the motion to reconsider will please rise and remain standing until counted.

The PRESIDENT: The Chair understands that Senator Duquette of York has rendered a final report but it is not printed and the Chair feels that the Senate owes Senator Duquette a rising vote of thanks for the wonderful work he has done as Chairman of our Appropriations Committee.

(Applause, the members rising.) Mr. DUQUETTE of York: Mr. President, I wish to thank you and every Senator here. We have a good Senate, especially after I had to kill so many bills this afternoon. I thank you very very much for this ovation.

At this point, His Excellency, Gov. John H. Reed and the Executive Council entered the Senate Chambers and Governor addressed the Senate as follows:

Governor JOHN H. REED: Mr. President and members of Senate: The time has arrived for the adjournment of this session of the 102nd Legislature and I wish to extend my thanks and that of the people of Maine for the service you have rendered in their behalf.

This session in my opinion has been most productive and has been marked by fine cooperation. I submit to you herewith a tabulation of the results of your action.

There were 578 acts approved. There were 58 resolves approved. There were 5 vetoes presented.

When I addressed you in January I presented a program designed to move Maine forward during the next two years on many fronts in education, in economic growth, in human welfare. I am pleased with the results of the action you have taken on a substantial majority of my proposals.

Without hesitation you provided a general fund operating budget which will insure the adequate functioning of state government and the provision of needed services during the coming biennium.

Our accelerated highway program will go forward on schedule and will be soundly financed.

In the field of social service and institutional care we are keeping pace with the increased demands for services to the ill, the aged, the unfortunate members of our society.

Our loyal and dedicated state employees and those who have retired from active service will be more adequately compensated through increased wage and benefits.

The general work force in the state will be guaranteed a more realistic minimum wage, more protection and more benefits under the workmen's compensation law and, of great significance, a more equitable employment security law has now been enacted.

An historic stride forward has been taken on the economic front with the enactment of sound legislation to encourage more economic growth. I refer specifically to the establishment of a Maine recreation authority, expansion of the Maine industrial building authority and municipal revenue bonding.

Time does not permit me, in this late closing hour, to enumerate all of the significant accomplishments, but I would like to mention one area of what I consider vital importance in which tremendous progress has been made.

I said in January we believe that education is the key to advancement. You have indeed sustained me in that belief.

Our educational subsidy programs and obligations will be met. The principle of uniform local effort has been established. Teacher preparation has been strengthened as never before.

Vocational education has been expanded to provide more opportunities for our youth. We shall undertake a needed study of higher education and, finally, the University of Maine upon which so much of the future of the state rests, has been assured the resources necessary to fulfill its responsibility to our young people.

We have, in this session, in a spirit of cooperation removed many roadblocks, traveled many miles along the road to greater progress. Most of all, we have—with reasonable financing — preserved the sound fiscal integrity of our Senate of Maine. Without this I do not feel that we could have realized the objectives that have been accomplished.

I wish to congratulate the leadership in this legislature of both of our great political parties for the cooperation they have given each other, and most certainly and sincerely for the cooperation they have extended to me. I feel that as a result of this cooperation, this team work that has been so apparent from start to finish, together, we have added a bright, new chapter to the distinguished legislative history of our government.

It has been a pleasure for me to have known and worked with you. Mrs. Reed and I will always remember the pleasant occasions when you have been our guests as Blaine House and I look forward to greeting you in the future when your business or social travels brings you to the capitol.

In closing, I want to commend everyone connected with this legislature, the members of the House and Senate, the staff, and everybody who has had a part in this joint undertaking of the last few few months. I feel that the diligence that you have applied to your legislative tasks have indeed been a credit to this 102nd Maine legislature. As I bring my remarks to a close, I want to wish for each of you a safe journey home and a future filled with great success and happiness. Thank you very much.

Thereupon, His Excellency, Governor John H. Reed and the Executive Council withdrew from the Senate Chambers.
