Monday, January 17, 1966

In compliance with a Proclamation of His Excellency, Governor John H. Reed, the Senators convened in the Senate Chamber at ten o'clock in the morning, Eastern Standard Time, and called to order by the President.
Prayer by the Rev. Howard O.

Hough of Portland.

The Secretary read the Proclamation:

> STATE OF MAINE PROCLAMATION By the Governor

WHEREAS, I deem it advisable that the Legislature of this State should meet in special session for the purpose of considering the following legislation:

NOW, THEREFORE, I, JOHN H. REED, Governor of the State of Maine, by virtue of the power vested in me as Governor, convene the Legislature of this State, hereby requiring the Senators and Representatives to assemble in their respective chambers at the Capitol at Augusta on Monday, the seventeenth day of January, 1966 at ten o'clock in the morning in order to receive such communication as may then be made to them and to consider and determine on such measures as in their judg-ment will best promote the welfare of the State.

Thirty-four Senators having answered to the roll call, the President declared that a quorum was present.

Mr. Dunn of Kennebec was granted unanimous consent to address the Senate.

Senator DUNN: Mr. President, since the regular session ended, two of our legislative employees have passed on. I would hope that the Senate might have a moment of silence for A. Marie Patterson, who served as clerk of the Committee on Sea and Shore Fisheries, and Carlisle Lincoln, who served as our doorkeeper.

Thereupon, the Senate stood in a moment of silence.

Our of order and under suspension of the rules, on motion by Mr. Jutras of York,

ORDERED, that a message be conveyed to the House of Representatives informing that body that a quorum of Senators is present for the consideration of such business as may come before the Senate.

Which was read and passed, and Mr. Harding of Aroostook conveyed the message.

At this point, a message was received from the House of Representatives informing the Senate that a quorum was present for the consideration of such business as might come before the House.

Out of order and under suspension of the rules, the following orders were presented:

On motion by Mr. Hilton of

ORDERED, that a message be sent to His Excellency, the Governor, informing him that in obedience to his Proclamation a quorum of Senators is assembled in the Senate Chamber for the consideration of such business as may come before the Senate.

Which was read and passed.

The President appointed Senators: Harding of Aroostook, Hilton of Somerset, and Hoffses of Knox to convey the message.

The Committee retired and subsequently reported that they had delivered the message with which they were charged.

On motion of Mr. McDonald of Piscataquis,

ORDERED, that a message be sent to the House of Representatives proposing a Joint Convention to be held at 11:00 A.M. in the Hall of the House of Representatives for the purpose of extending an invitation to the Governor to attend the Convention and present such communication as he may be pleased to make.

Which was read and passed.

The Secretary conveyed the message.

Subsequently, a message was received from the House of Representatives, through Mr. Plante, its Clerk, concurring in the foregoing proposition for a Joint Convention.

On motion of Mr. Harding of Aroostook,

ORDERED, the House concurring, that unless received by unanimous consent in both branches, no bill or resolve be considered at this Special Session except those designated Legislative Documents Nos. 1592 to 1792 inclusive, and such bills or resolves as may be returned by or recalled from the Governor.

This order shall apply to such bills or resolves as are intended only to facilitate the business of the Special Session. (S. P. 698)

Which was read and passed and was ordered sent forthwith for concurrence.

On motion of Mr. Smith of Cumberland,

ORDERED, the House concurring, that three hundred fifty copies of the Legislative Record for this Special Session convened on January 17, 1966, be printed and bound, one copy each for the members and officers of the Sen-

ate and House of Representatives, the remainder to be deposited in the State Library for exchange and Library purposes; and be it further

ORDERED, that suitable index be prepared for such Legislative Record, under the direction of the Secretary of the Senate and Clerk of the House. (S. P. 699)
