HOUSE

Tuesday, January 24, 1967

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Roger Smith of Augusta.

The members stood at attention during the playing of the National Anthem.

The Chair laid before the House the first tabled and today assigned matter:

Pending — Motion of Mr. Gill of South Portland to reconsider reference to Committee on Legal Affairs

The SPEAKER: The Chair recognizes the gentleman from South Portland, Mr. Gill.

Mr. GILL: Mr. Speaker and Ladies and Gentlemen of the House: After a great deal of soul searching over the weekend and conferences I would like to withdraw my motion to reconsider this matter.

The SPEAKER: Is it the pleasure of the House that the gentleman from South Portland, Mr. Gill, withdraw his motion to reconsider?

The motion prevailed.

Mr. Jalbert of Lewiston was granted unanimous consent to address the House.

MR. JALBERT: Mr. Speaker and Ladies and Gentlemen of the House:

On your desks is the large manilla envelope containing the three reports written by the professional firm retained by the Legislative Research Committee of the 102nd Session, dealing with all major aspects of civil service in Maine's state government.

To say to you this morning that these reports are vital to the operations of state government would be an understatement.

It is my understanding that our study of the specific operations and administration of the State Personnel System is the first that has been completed since the creation of the classified service. I sincerely believe that the reports now before you contain recommendations that can and will affect the future of career employment in our State, and that each report is deserving of your serious and undivided attention now and in the weeks to come.

We, on the Research Committee, have attempted to come up with answers in three distinct areas of state employment:

(1) Up-to-date, professionallyanalyzed classifications of over 900 different job titles;

(2) A realistic appraisal of the salaries attached to each of these different job positions;

(3) The administrative setup of the Personnel System which governs the day-in, day-out policies and programs affecting approximately 10,500 state employees.

We believe, generally speaking, that we are offering a practical, yet progressive set of recommendations in all three areas. We also believe that these recommendations look to the future.

Naturally I will not attempt to outline in detail this morning all of the recommendations contained in these three reports. I urge you to study them carefully. I urge you to make note of questions that may come to your minds.

These reports, in my opinion, are of such importance that it is

your duty and obligation to raise any point on which you may be uncertain. To this, may I inform you that the director of the professional firm that conducted this overall study will be with us, presumably a week from today, to answer any and all questions and points that you may have in mind.

When anyone, let alone the Research Committee, recommends that the civil service system be completely revamped, then I believe that this and the other body should make every attempt to insure that our final decisions are made after careful deliberations.

I call wour attention to the following:

The firm of Cresap, McCormick and Paget devised a new and completely streamlined pay plan, after making comparisons with salaries and pay grades within industry and commerce in Maine, and with comparable pay levels in other New England States.

They recommended a beginning level of pay of \$57.00 a week, which was logical in our State from the point of view of in-state comparisons. However, at our request, the professional firm also offered an alternative which would upgrade their proposed minimums.

In view of changing economic conditions, in view of considerable sentiment that many of us on the Research Committee have detected within this House, and in view of our attempt to look not only to today's problems but tomorrow's as well, we are recommending that the minimum hourly rate be increased from \$1.38 to \$1.50 an hour, and that the minimum starting salary in state government for permanent positions be \$60.00 weekly, instead of the report's proposed \$57.00 a week,

At this time, I cannot give you accurate figures as to the cost of implementation of either the new pay plan or the new personnel system as recommended.

I can tell you that by raising the hourly minimum rate from \$1.38 to \$1.50, the annual cost will not rise by a large amount of dollars.

Ladies and gentlemen of the House, this, at times, has been an arduous task, but it has been a satisfying one in that all of us on the Research Committee who have concentrated on these reports believe that we have accomplished considerably towards the betterment of both career state employment and, hopefully, an improved state government structure.

If there are weaknesses in these reports, if there are areas that need strengthening, if there are phases that need correcting, then I for one, and I am sure that the entire Committee is in agreement, am more than willing to consider the need for

changes.

Thank you for your kind attention. I hope that you, too, agree that generally speaking, you have before you recommendations of importance to our State. arrived at only after thorough and thoughtful deliberations.

(Off Record Remarks)

SPEAKER: The Chair gentleman from recognizes the China, Mr. Farrington.

Mr. FARRINGTON: Mr. Speaker, I move that we reconsider our action whereby we referred item 2, page 2, House Paper 183, Bill "An Act relating to Conveyance of Secondary Pupils" to the Committee on Education.

The SPEAKER: The gentleman China, Mr. from Farrington. moves the House reconsider its action whereby it referred this Bill to the Committee on Education

(On motion of Mrs. Baker of Winthrop, tabled pending the motion of Mr. Farrington of China, and tomorrow assigned.)

Mr. Ross of Bath was granted unanimous consent to briefly address the House.

Mr. ROSS: Mr. Speaker, Ladies and Gentlemen of the House: I would like to make a few brief remarks for the benefit of new members. I believe that you have found out by now that you receive so much material on your desks that it is hard to determine what to keep and what to throw away. As a matter of fact, it even requires the most conscientious person to read all of it.

But today, you have received the first of a great many most important items. You have received a blue sheet of paper headed Committee Amendment "A" and at the bottom it says House Filing H-1. It is most advisable that you save all of these because if you did not, you would never know exactly the status of most of the bills since most of our bills are amended at some point or another.

Now there are several ways to save these and several things to do with them. Many persons fold them such as this (indicating) and put them in the book of L. D.'s along with the Legislative Document to which they pertain. Others keep a notebook either by themselves or with their neighbors together. For instance, my most agreeable, cooperative and pleasant seatmate, the gentleman from Wilton, Mr. Scott, and I, keep a notebook together. Sometimes he will punch the holes in the things so we can put them in and other times I do, but in the final analysis, we always have these up-to-date. In that way we can tell what the status of the bills are, without which you never would be able to do it. Thank you very much.
