LETTER OF TRANSMITTAL

September 14, 1966

To the Members of the 103rd Legislature:

The Legislative Research Committee has the honor to transmit herewith a three-phase study on State Personnel Laws and Administration pursuant to the following directive of the 102nd Legislature.

ORDERED, the House concurring, that the Legislative Research Committee is directed to study the classification processes and procedures governing the employment of professional and technical employees in the Federal Government and other states for the purpose of determining necessary and possible improvements in the classification of such personnel in this State; and be it further

ORDERED, that the Committee report the results of its study to a special session of the 102nd Legislature or to the 103rd Legislature.

ORDERED, the House concurring that the Legislative Research Committee is directed to employ professional consultants to obtain the information necessary to determine whether changes are needed to improve the State Personnel Laws, special emphasis in the study to be given to the areas of classification and salary, present rules and regulations governing the hiring and discharging of state employees, and all phases of Personnel Department policies, functions and administration; and be it further

ORDERED, that a report of such study together with any recommendations deemed necessary be made to the 103rd Legislature. Due to the broad scope of this assignment the Committee deemed it necessary to treat the study under three separate publications: Committee publication 103-5, A Proposed Classification Plan; Committee publication 103-6, A Proposed Salary Plan for State Employees; Committee publication 103-7, Proposed Organization and Policies for State Personnel Administration.

This assignment was contractually studied for the Committee, under authority of the Legislature and contains the findings and recommendations of the Legislative Research Committee as developed by the consultant firm of Cresap, McCormick and Paget, New York, New York.

The Committee sincerely hopes that the information herein contained will prove of benefit to the members of the Legislature and the people of the State of Maine.
