Mr. ROSS: Mr. Speaker, in reference to item 20, I would respectfully suggest that this go before another Committee, and I would like to speak briefly to this suggestion.

The SPEAKER: The gentleman may proceed.

Mr. ROSS: This bill proposes a major change in the laws governing Atlantic Sea Run Salmon. This is a subject very dear to my heart, because Salmon fishing is the creme de la creme of all sport fishing. My only desire is to improve and conserve this sport primarily for the benefit of the citizens of the State of Maine.

The administration is in the hands of the Atlantic Sea Run Salmon Commission and this Commission is made up of the Commissioners of Inland Fish and Game, Sea and Shore Fisheries and a public member. Parts of our salmon rivers are tidal and parts are fresh water, so both departments are interested in this.

A joint hearing might well be warranted, but I think it would be best to have an impartial board and one that can readily see the over-all picture, and I can think of no other group better qualified than the Natural Resources Committee, and I move that this be referred at this time to that august body.

"R. S., T. 17, \$502, repealed and replaced. Section 502 of Title 17 of the Revised Statutes is repealed and the following enacted in place thereof:

'\$502. Construction assembling or possession

Except for lawful purposes in any instance, whoever knowingly constructs, assembles, or knowingly has in his possession any device, bomb or infernal machine capable of being exploded, or knowingly possesses materials appropriate for the construction thereof, shall be

punished by a fine of not more than \$1,000 or by imprisonment of not more than 15 years, or by both.

When I learned of this Order, I was somewhat concerned, particularly due to the fact that heretofore the Committee on State Government had handled most bills relating to the two Indian tribes. I was a little apprehensive — I thought that perhaps there was an effort being made to set up in this House, in this Legislature, a permanent committee on Indian

Affairs, and with that I could not quite agree. However, I find that such is not the case, that this is simply a Joint Select Committee for this session to handle the heavy load of bills pertaining to Indian Affairs; and this explanation is very satisfactory to me and I think to all concerned. And with this, Mr. Speaker, I now move the passage of this Order in concurrence.
