Wednesday, February 8, 1967

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. David Van Strien of China.

The journal of yesterday was read and approved.

Papers from the Senate Tabled and Assigned

From the Senate: The following Order:

WHEREAS, under the present probate court system, one judge is elected in each county and is paid on the basis of a part-time position; and

WHEREAS, it is becoming difficult to secure the services of qualified attorneys as probate judges, especially in the smaller counties where the salary is lower, and restrictions are placed on the law practice of an attorney who is also

probate judge; and
WHEREAS, the Legislature requires for its use comprehensive factual information concerning the operations of the probate courts in the 16 counties in order to consider the feasibility of establishing a Probate District Court System of full-time judges to be appointed by the Governor, with the advice and consent of the Council; now, therefore, be it

ORDERED, the House concurring, that a Probate Court Revision Committee is established to consist of the following members: One member representing the public to be appointed by the President of the Senate, one member representing the public to be appointed by the Speaker of the House, 2 probate court judges to be appointed by the Chief Justice of the Supreme Judicial Court, the Chief Judge of the District Court and 2 attorneys to be appointed by the President of the Maine State Bar Association; and be it further

ORDERED, that the committee shall study the feasibility of establishing a Probate District Court System with full-time judges to be appointed by the Governor, with the advice and consent of the Council; and be it further

ORDERED, that the study shall include but not be limited to a review of current workload as well as trends in the work of the 16 probate present judgeships; translation of case load into manhours of the time of the probate judges: consideration of time and other factors implicit in full-time judgeships; the administration, staffing, structure, organization and operation of the probate court system; and be it further

ORDERED, that the committee elect a chairman from its member-

ship; and be it further

ORDERED, that the committee report the results of its study with recommendations to the 103rd Legislature by May 15, 1967; and be it further

ORDERED, that the committee members shall serve without compensation but shall receive their necessary expenses incurred in carrying out their duties under this order; and be it further

ORDERED, that the committee is authorized to employ consultants in carrying out the purposes of this order; and be it further

ORDERED, that there is appropriated to the committee from the Legislative Appropriation the sum of \$4,000 to carry out the purposes of this order (S. P. 254)

The SPEAKER: Is it the pleasure of the House that this Order receive passage in concurrence?

The Chair recognizes the gentleman from Houlton, Mr. Berman.

Mr. BERMAN: Mr. Speaker and Members of the House: I rise somewhat reluctantly this morning to call the attention of the House to what appears to me to be somea disorganized situation. what First, this order in conjunction with two other matters which are appearing on today's calendar seems to be riding in three separate directions. First we have this order for a study, then on Item 16 we have on the calendar "An Act Directing Review of Probate Laws and Method of Choosing Judges and Registers of Probate," which is suggested to go to the Committee on Judiciary. Then, on Page 4 of today's calendar we have an Item 32, a resolve proposing an amendment to the Constitution concerning the judges and registers of probate as constitutional officers, and the Committee on State Government is suggested.

Now, it does seem to me in the exercise of orderly procedure, that there should be some way of working out these problems, that we don't fragment them into orders in references to various committees. A second thing with regard to this particular order as it is presently constituted, it does appear to me on its face that the Legislature is abrogating some of its powers, in effect, by having only two of its members serve on a seven-man committee: and while I make no comment here on the actual merits of the order, it would seem to me that this order should receive further consideration and should not go just under the hammer where only two members of the Legislature will be serving on a seven-man committee.

The SPEAKER: The pending question is the passage of this Order in concurrence.

Upon receipt of a petition of electors resident in that municipality in writing addressed to the Secretary of State and signed by at least 15% of the number of voters voting for the gubernatorial candidates at the last state-wide in that municipality, election which petition shall be filed with the Secretary of State on or before the first day of July April preceding the day of the biennial election, the ballots for that municipality shall carry in accordance with the petition any or all of the following additional questions:

The SPEAKER: The Chair recognizes the gentleman from Perham, Mr. Bragdon.

Mr. BRAGDON: Mr. Speaker, I would like to ask a question in regard to the effect of the amendment of the gentlewoman from Bethel, Mrs. Lincoln, if she wishes to answer.

The SPEAKER: The gentleman may ask his question through the Chair.

Mr. BRAGDON: Mr. Speaker, my question is, more or less, as I hastily read this, whether or not this wholly defeats the purpose of the bill and it now makes it so that any municipality, and we will say if I felt that—Republicans in my area felt it was to their

benefit to vote on the liquor questions in the regular election, yes, they can do so, and the other one, if in some area they felt the opposite, yes, they can do so, which is the way probably, so it makes it of no effect. I might say that. That is just a comment.

However, the question, and it is probably explained in the amendment had I read it more carefully, does this permit a municipality to extend, in other words, could they vote not to vote on a local option question every year or could they make it at their own wish and vote once in every ten years or what? That's the question.

The SPEAKER: The gentleman from Perham, Mr. Bragdon, has addressed a question through the Chair of the gentlewoman from Bethel, Mrs. Lincoln, who may answer if she so chooses, and the Chair recognizes that gentlewoman.

Mrs. LINCOLN: Mr. Speaker, Ladies and Gentlemen of the House: You really have asked several questions in one there. The amendment which I will start with first, is to merely change the date from July to April for part-time licensees to get their petitions in to the Secretary of State's Office. If we change the time of the local option from the general election to the primary election, otherwise, they have to have it in by July for the general election, and if the bill goes through that portion of your liquor laws would have to be changed to have your petitions in to the Secretary of State's Office by April, because July would be afterwards.

Now this other question that you asked, was this once in every ten years? This bill would be every two years. When we vote on the local option now you vote every two years in the general election and it would be to vote at the primary. I could discuss this further, Mr. Speaker, but I don't think you want it right now, do

The SPEAKER: The Chair recognizes the gentleman from Perham, Mr. Bragdon,

Mr. BRAGDON: Mr. Speaker, this was prompted probably by not reading the amendment. I wondered hastily whether or not by the local option amendment we would have the opportunity in our various community every year or voting.

Mr. LEVESQUE: Mr. Speaker, I would like to pose a question to the gentlewoman from Bethel, Mrs. Lincoln.

The SPEAKER: The gentleman may pose his question through the

Chair.

Mr. LEVESQUE: Mr. Speaker, in the case that this is moved from the general election to the primary election, would this indicate that a person that is registered independent could only vote on the option questions and thereby eliminate the possibilities of having a lot of independent voters going to the polls only to vote for the local option questions?

The SPEAKER: The gentleman from Madawaska, Mr. Levesque, has posed a question through the Chair of the gentlewoman from Bethel, Mrs. Lincoln, who may

answer if she so desires.

Mrs. LINCOLN: Mr. Speaker, in answer to Representative Levesque, the independents could go and vote just on the liquor questions, they cannot vote for your candidates as they cannot now at the primary election.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker, I might clarify the gentlewoman from Bethel, Mrs. Lincoln's comment on the independent voter. The independent voter today can go to the polls, enroll in either party, vote for either candidates of his choice of either party, and the next day by calling or appearing before the Board of Registration or the Registrar of Voters again dis-enroll and become an independent voter. But I might suggest that somebody table this so that it would be taken up at

a Republican Caucus and we would know whether to go from there from the mandate of the majority.

The SPEAKER: The Chair recognizes the gentleman from Solon, Mr. Hanson.

Mr. HANSON: Mr. Speaker, I believe I should point out, I believe it is an error in the gentleman from Lewiston, Mr. Jalbert's statement. I believe Section 135 of the Election Laws precludes the request for withdrawal of enrollment within six month of the initial enrollment, so that you could not ask for withdrawal of enrollment the next day.

The SPEAKER: The Chair recognizes the gentleman from Lewis-

ton, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker, I might answer the gentleman that I am not in error. Anyone who enrolls to vote at a primary in either party can go to the Board of Registration the next day, write a letter or call them, properly identify himself and be dis-enrolled, and I am not a gambling man, but.

The SPEAKER: Is the House ready for the question? The question before the House is the adoption of House Amendment "A" to House Paper 57, L. D. 82, Bill "An Act relating to Time for Voting on Local Option Questions Under Liquor Laws." All those in favor of the adoption of House Amendment "A" will say aye; those opposed, no.

Mr. BERMAN: Mr. Speaker and Members of the House: I would not consider myself a Noah Webster and try to improve the orthography of this word. It is my understanding that the present printed spelling is acceptable. As to the pronunciation of the word, again I would not choose to improve upon the accepted dictionary definitions.

As I recall, this is a word of Latin origin, and Latin words are sometimes subject to more than one pronunciation.
