Thursday, February 16, 1967

ORDERED, that the committee report the results of its study to the 103rd Legislature or any special session thereof or to the 104th Legislature, together with any recommendations and suggested legislation needed to implement its recommendations; and be it further

ORDERED, that the committee members shall serve without compensation but shall receive their necessary expenses incurred in carrying out their duties under this Order; and be it further

ORDERED, that there is appropriated to the committee from the Legislative Appropriation the sum of \$4,000 to carry out the purposes of this Order. (S. P. 341)

# Third Reader Tabled and Assigned

Bill "An Act Providing for Life Preservers for all Motorboats Operating on Inland Waters" (S. P. 4) (L. D. 7)

Was reported by the Committee on Bills in the Third Reading and read the third time.

The SPEAKER: The Chair recognizes the gentleman from Houlton, Mr. Lycette.

Mr. LYCETTE: Mr. Speaker and Members of the House: Subsequent to my serving in the last Legislature, I often saw and read of bills that were passed and as I looked at them I thought, well, I didn't vote for that, and then on second thought I realized that they went through by default. I arise in regard to this bill with the same thinking.

I realize that in view of the fact that we're getting more people into the woods, more tourists, it becomes necessary to, may I say, regiment ourselves by new laws and regulations. But of course, no one is against poverty and I suppose no one is against safety, but I think that sometimes we can go too far in making these laws.

If one follows the rules and regulations now set forth by the Fish and Game Department, and you go out with a boat, by the time you load yourself with the impedimenta that is required, it's a project, it isn't a fishing trip. And, for instance, if I took my little boat and a life preserver in it, and I went up the Meduxnekeag River and I happened to find a man in distress up there, and he wanted to get conveyed across the river, I know of a certain game warden who would arrest me. In fact, I think he would arrest his mother if she was in swimming in a closed lake. You know there are officers, and I'm not casting any reflections, you understand, on the game war-dens at all, I think they are a

dedicated group. But, I've been in the law enforcement game for a good many years, and I know that there are officers, and there are officers, and some of them are not qualified to be on the job any more than I'm qualified to be a Legislator.

I have nothing further to say on this, I'm not standing up here to influence anyone. I just wanted to register my protest to this bill, and if it's in order, I move that the bill be indefinitely postponed.

The SPEAKER: The gentleman from Houlton, Mr. Lycette, now moves that Item 1, Bill "An Act Providing for Life Preservers for all Motorboats Operating on Inland Waters," Senate Paper 4, L. D. 7, be indefinitely postponed.

Thereupon, on motion of Mrs. Baker of Orrington, tabled pending the motion of Mr. Lycette of Houlton to indefinitely postpone, and assigned the next legislative day.

Bill "An Act Providing for a Presidential Preference Primary" (H. P. 58) (L. D. 83)

Tabled—February 15, by Mr. Jalbert of Lewiston.

Pending—Passage to be Engrossed.

The SPEAKER: The Chair recognizes the gentleman from Bath, Mr. Ross.

Mr. ROSS: Mr. Speaker and Ladies and Gentlemen of the House: I offer House Amendment "A", which is Filing H-15, and I would like to speak briefly to it.

The SPEAKER: The gentleman from Bath, Mr. Ross, offers House Amendment "A" and moves its adoption, and the gentleman may proceed.

Mr. ROSS: The gentleman from Lewiston, Mr. Jalbert, yesterday questioned the cost of this Act. The amount is negligible and from a state-wide viewpoint only approximately \$24,000 for such things as material, printing, advertising, instruction sheets, delivery and so forth. We really don't need an appropriation clause on a bill such as this. If it were looked on favorably, the Secretary of State's office would furnish the figures and this would be done automatically near the end of the session.

However, so as not to hide or camouflage anything I am now pleased to offer the amendment and since it's only self-explanatory I would hope that the House would adopt it and then we could debate the entire question.

House Amendment "A" was then read by the Clerk as follows:

HOUSE AMENDMENT "A" to H. P. 58, L. D. 83, Bill, "An Act Providing for a Presidential Preference Primary."

Amend said Bill by inserting at the beginning of the first line the underlined abbreviation and figure 'Sec. 1.'

Further amend said Bill by adding at the end the following section:

'Sec. 2. Appropriations. There is appropriated from the General Fund to the Office of the Secretary of State the sum of \$24,000 for the fiscal year ending June 30, 1969 to carry out the purposes of this Act.'

House Amendment "A" was adopted.

The SPEAKER: The Chair recognizes the gentleman from Bath, Mr. Ross.

Mr. ROSS: Mr. Speaker and Members of the House: On today's calendar, on page 4, I made a motion on item 22, relative to Atlantic Sea Run Salmon. This is another one of my bills. It would seem quite a transition in the same day perhaps, to go from salmon fishing to presidential preferential primaries, but one of my colleagues said no, that necessarily is not so because for many years the first salmon caught in the

Bangor Pool was sent to the President of the United States; so perhaps these two things are most compatible.

We have just accepted a n Amendment relative to the cost of holding the proposed Primaries. As I mentioned then, the amount from a statewide viewpoint would be negligible in comparison with the amount of business and publicity which would emanate therefrom. Aside from the business this would generate, which is estimated to be certainly in the millions of dollars, there are two main reasons why I support such legislation. First of all I feel very strongly that the average citizen and not just a select group should have the opportunity of choosing, or at least stating his preference, as to the candidates his party will run for President and Vice President of these United States. Primarily this would give the people and not just a tiny handpicked special group a measure of control in our nominating process.

I would like to cite an example of this as quoted on the floor of this House during the last legislative session. In 1961 a very small group of men met one evening for coffee in a kitchen right here in Augusta. They were all enthused about the candidacy of one Dick Nixon. Normally, State Convention Delegates go to the National Convention uninstructed, but this group of four or five dedicated friends hit on a plan. They drafted a Resolution which late at night they snuck through their county caucus. The next morning at the District Meeting while attendance was still light and persons hardly awake, they eased it through again. By the time the general session started that afternoon, it was too late to stop their little gem, and that year delegates went firmly pledged to Mr. Nixon. Now I do not question their choice, but I do question the logic in this overall procedure which allows such political shenanigans.

The second reason I favor this bill goes back to legislative action taken in 1957 at which time I was selected to play a part. Specifically, I refer to the change in the date of the general election

in Maine. At that time, we did away with our September election from which we had always received a great deal of free publicity. Generally, when we enact a law we can change it later if we find it is not to our liking. This, however, was different. Once we had decided to conform with the rest of the states and hold election in November. our United States Constitution specifically prohibited our changing back. I now feel that our action was wrong and I for one am perfectly willing to admit it. Here, we have a way to recoup a great deal of this free publicity. If we hold preferential primary a week а ahead of New Hampshire, which is now the first in the country, we will once again be getting a little national attention on a phase of our elections.

The opposition will probably make several observations. Last year, for instance, they said that New Hampshire was a very poor example for us to follow. With this bill, we are not following them; we are ahead of them. Certainly we are not copying their idea, because sixteen states already have similar legislation. Candidates select, for one reason or another, the states they will run in. I believe that they would be happy to choose the State of Maine. More and more we are reputed to be a pretty good barometer for elections in general.

The opponents may also argue that these don't mean much anyway Yesterday, in a Republican Caucus, our learned and most respected colleague from Lubec, Mr. Pike, mentioned that at the last National Republican Convention the New Hampshire delegates were pledged to a candidate who wasn't even running. This can happen under their law, but not under the proposal before us today. Our suggestion does not bind the delegates. However, it would enable these persons to act more confidently with the knowledge that they have popular support.

For those who say that primaries do not mean much, let me cite just three examples:

In 1944 Wendell Willkie withdrew his name after being beaten in Wisconsin by Governor Dewey who didn't even bother to campaign there.

General Eisenhower might not ever have run for President, since he didn't even make himself available until he had won both the New Hampshire and Minnesota Primaries.

In 1960 President Kennedy virtually forced Vice President Humphrey out of the race after his victory in West Virginia, a strong Protestant state.

In the final analysis, I sincerely believe that these primaries are the fairest way of selecting Presidential and Vice Presidential nominees, and I certainly hope that this afternoon the bill is passed to be engrossed, and when the vote is taken I request that it be taken by the yeas and nays or a roll call.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker and Members of the House: First I would be remiss if I didn't thank, for my party at least, the gentleman from Bath for letting us in on the inner doings of his party. I would, however, resent the word "shenanigans" because I know that the good Republican Party would never stoop to such tactics.

As the author after presentation six times of the measure that finally passed to allow the people to vote as to whether they wanted a change in the election date from September to November, I found throughout the many years of campaigning for this project that the most cogent argument that was used was the fact that Maine was reaping a great deal of publicity from the fact that we voted in September and we were first to vote as compared with the other states in the Union. One could not combat very easily with this argument.

I am one of those who has been to New Hampshire on more than one occasion and what I saw there was hundreds upon hundreds of out-of-staters spending a good deal of money and leaving it in New Hampshire. And while we're looking for money, it might be well to get it where we can, and these are honest dollars. People have a right to their opinion. Certainly we could not be termed as having meant this as a laughing matter. I am sure that the citizens of this state, whether it be a primary or a general election, or whatever election it may be, vote and vote intelligently.

I think we would reap a great deal of not only monies that would be coming in from out of state, even out of the country, but also reap the harvest of a great deal of publicity. I commend the gentleman from Bath, Mr. Ross, for having presented this very worthy bill and I hope it is passed to be engrossed.

The SPEAKER: The Chair recognizes the gentleman from Kingman Township, Mr. Starbird.

Mr. STARBIRD: Mr. Speaker, may I ask a question of Mr. Ross through the Chair? I would like to inquire as to what the cost to the local towns and cities would be for another election, if he has any figures on that?

The SPEAKER: The gentleman from Kingman Township, Mr. Starbird, poses a question through the Chair of the gentleman from Bath, Mr. Ross, who may answer if he so desires.

Mr. ROSS: Mr. Speaker, in answer to the gentleman's question, of course the cost of this to the towns and cities would be the same as the cost of any other election like this. You would have to have your city officials and your election clerks, your ballot clerks, your wardens and so forth.

But I would like to point out that those towns who would like, could have their Town Meetings on this same day and same time, so you would be accomplishing two things at one time.

The SPEAKER: The Chair recognizes the gentlewoman from York, Mrs. Fuller.

Mrs. FULLER: Mr. Speaker and Members of the House: I yesterday in the Republican caucus felt that some of the negative factors of this bill should be pointed out so that people could evaluate whether the benefits claimed offset the problems created.

I did this because I have spoken to a member in the Republican Party in New Hampshire, feeling that he would have the experience which we had not been through. I used his quotations, as I know of no other way than somebody that has dealt in something like this. He felt that in New Hampshire that it had created a good many problems, that it had a tendency, as I said before, to divide the Party, and that while it may have brought money into the state, it was expensive for the political organizations.

I point out here that in the bill that Mr. Ross, the gentleman from Bath, has presented, there is a time limit for filing the petition with the Secretary of State, not more than sixty days, not less than forty. If I calculate this right, this means that by sometime next February, which seems pretty early in the game, we would be having to file petitions for these presidential nominees.

I also point out that I can't see why any other state can't choose to make their primary earlier than ours if they decide to, and thus negate one of the principal arguments of the proponents. The four million dollar figure which seems to be used to say was brought into the State New Hampshire in other of primary elections, seems to be taken out of the air; and nobody can qualify it, it's just said that that was what was brought in. Representative Pike yesterday described the debacle of the New Hampshire primary two years ago. He is not here today to discuss this.

I say if we want to bring Maine back into the eye of the Nation, it is questioned whether we could do something about the federal regulation, and go back to our September election.

The SPEAKER: The Chair recognizes the gentleman from Madawaska, Mr. Levesque.

Mr. LEVESQUE: Mr. Speaker and Ladies and Gentlemen of the House: At this particular point I'm going to speak as just one member of the loyal opposition, only as an individual member and not as a party measure.

It is my sincere feeling that there might be some benefits al-

though my feeling is that the benefits would be relatively minor, because we in this state are strategically located quite a bit different than New Hampshire. In New Hampshire you have а relatively small state, and much closer to the bigger metropolitan areas. Here in Maine, we find ourselves holding municipal elections in the month of March, and I have seen, and granted I am probably the furthest northeast of any member of this House, but we have found ourselves knee-deep in a fresh snow storm on that particular day or days. So I question the amount of people that would actually come into the State of Maine to invest money, if you want to put it that way, into a candidate that they feel should be selected in this particular fashion. So I very much question the revenues that would be derived or the publicity, granted there would be some because more times that they use the name of the State of Maine on a national scale the better off, but I think the gentlewoman from York very well pointed out that what happened to New Hampshire last year, or two years ago, could very well happen to the State of Maine, and there is nothing that prevents any other state, and it could be Florida or California where the climate is so much better to take the lead in this particular fashion.

The SPEAKER: Is the House ready for the question? The Chair recognizes the gentleman from Hampden, Mr. Littlefield.

Mr. LITTLEFIELD: Mr. Speaker and Ladies and Gentlemen of the House: I would oppose the bill from a little different angle. We have a Department of Economic Development that is costing us a million dollars a year, and I don't propose to add twenty-four thousand dollars to the cost of advertising the State. Therefore, I would vote against the measure.

The SPEAKER: The pending question is the passage of this bill to be engrossed as amended. A roll call has been requested. For the Chair to order a roll call it must have the expressed desire of one-fifth of the members present and voting. All those who desire a roll call will vote in the affirmative, and those opposed in the negative. The Chair will open the vote.

Thereupon, the members having voted, the Clerk took a total.

93 having voted in the affirmative and 31 having voted in the negative, a roll call was ordered.

The SPEAKER: The Chair will open the vote. All those in favor of this bill being passed to be engrossed as amended will vote in the affirmative, and those opposed, in the negative.

Thereupon, a roll call was taken.

Mr. JALBERT: Mr. Speaker and Members of the House: I would like to read a communication sent to me by the Planning Engineer of the Bureau of Public Improvements. The letter is addressed to me.
