WHEREAS, February 23, 1967, marks the fiftieth anniversary of the signing of the first National Vocational Education Act by President Woodrow Wilson; and

WHEREAS, on March 6, 1917, the Seventy-Eighth Legislature of the State of Maine, in its infinite wisdom, saw fit to enact legislation to accept the benefits of said Act and to provide for the promotion of vocational education within our State as an integral part of public education; and

WHERÉAS, through a series of enactments since 1917, such benefits have made possible the development of vocational education to serve Maine people who seek employment or are already employed in trades and industries, agriculture, distribution and marketing, home and office, health and technical occupations: and

WHEREAS, the extension and expansion of vocational and technical educational programs are so vital to this State in serving the training needs in all occupational fields not classified as professional or requiring a college degree; and

WHEREAS, Public Vocational Educational Programs have provided a means for the development and construction of area vocational schools so necessary to many young and adult persons who are preparing for employment or improvement of their skills; and

WHEREAS, the State of Maine has long been the beneficiary of Vocational Educational Programs which have contributed immeasur-

ably to the betterment of this State; now, therefore, be it

RESOLVED: That this 103rd Maine Legislature designates February 23, 1967 as the fiftieth anniversary of vocational education in Maine, and takes great pride in recognizing the accomplishments made during the past fifty years and offers legislative support and encouragement to Vocational Educational Programs which are proving to be of greater and greater service to the people of the State of Maine and to the Nation; and be it further

RESOLVED: That we the Members of the 103rd Legislature give special recognition to those vocational educators who faithfully develop and motivate leadership abilities in students enrolled in vocational and technical education. (H. P. 774)

# Passed to Be Enacted Emergency Measure

An Act relating to Taking of Alewives in City of Bath (S. P. 84) (L. D. 165)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed.

The SPEAKER: The Chair recognizes the gentleman from Bath, Mr. McMann.

Mr. McMANN: Mr. Speaker and Members of the House: The reason this is an emergency measure, having been a member of the Council in Bath when this was passed, the last few years, there has been wildcat taking of alewives and there has been quite a struggle over it. The City of Bath, in order to take charge of it, has to have this passed by the Legislature, and I wish you would give us the pleasure of passing it. Thank you.

Thereupon, this being an emergency measure and a two-thirds vote of all the members elected to the House being necessary, a total was taken. 123 voted in favor of same and none against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

# **Emergency Measure**

An Act Providing Funds for Educational Loans for Maine Students (S. P. 151) (L. D. 323)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being an emergency measure and a two-thirds vote of all the members elected to the House being necessary, a total was taken. 124 voted in favor of same and none against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

#### **Emergency Measure**

An Act relating to Nonlapsing Funds for Armory Construction (H. P. 52) (L. D. 77) Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being an emergency measure and a two-thirds vote of all the members elected to the House being necessary, a total was taken. 124 voted in favor of same and none against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

Mr. Scott of Wilton offered House Amendment "A" and moved its adoption.

House Amendment "A" was read by the Clerk as follows:

HOUSE AMENDMENT "A" to H. P. 211, L. D. 301, Bill, "An Act Relating to Uninsured Motorist Coverage in Insurance Policies."

Amend said Bill by inserting at the beginning of the first line the following underlined abbreviation and figure 'Sec. 1.'

Further amend said Bill by adding at the end thereof the following:

'Sec. 2. Effective date. This Act shall become effective January 1, 1968.'

House Amendment "A" was adopted and the Bill passed to be engrossed as amended by Committee Amendment "A" and House Amendment "A" and sent to the Senate.

Mr. Hichens of Eliot was granted unanimous consent to address the House.

Mr. HICHENS: Mr. Speaker, Ladies and Gentlemen of the House: Yesterday, we had the privilege to receive the youngest Member of the House, Representative Snowe. Today, I would like to draw attention to the eldest Member of the House, Reverend John Meisner. Mr. Meisner has

served or is serving his third term as Representative in the House of Representatives, and is still an active pastor in the ministry of the State of Maine. Last November during our pre-legislative conference, he and his wife observed their fiftieth wedding anniversary, and Mrs. Meisner is in the gallery today looking down in a beaming fashion upon her husband. We want to commend her for putting up with Mr. Meisner for fifty years.

This coming Sunday, Mr. Meisner will pass to another decade, from his seventy-ninth to his eightieth birthday, and I think it fitting that the Members of the House offer their congratulations and God's wishes for many happy days to come. (Applause)

Mr. Meisner of Dover-Foxcroft was granted unanimous consent to address the House.

Mr. MEISNER: Mr. Speaker and Members of the House: I don't know what to say. This is very unexpected, I thought this was a secret. I knew that one of the reporters had a little write-up on the Members that were here. Mr. Martin from Eagle Lake had the honor of being the youngest Member, and I the eldest. He said I was seventy-nine, so seventy-nine wasn't too bad — I grant he said that before I had my next birthday.

Yesterday, Mr. Martin got rid of his distinction, but I'm afraid mine is going to hang with me.

The Psalmist said - I suppose I should refer to the Scripture, "The years of a man's life are three-score and ten, and by reason of strength they should be fourscore. Yet as their strength, labor and sorrow - is soon cut off and we fly away." I suppose I should agree with the Psalmist. but I can't. Truly, eighty years is quite a long time to live, but it only seems like yesterday, My life hasn't been full of trouble; not too much sorrow, only that sorrow that comes to all of us as we go along life's way, and I've had a very happy life.

Some people have already asked me what is the secret of my life of all these years, and I suppose somebody will be asking me right away. A friend of mine who was

a preacher became eighty and in the sermon he said something about being eighty years old, and when he came down the aisle a lady met him and said: "Eighty years old and you are still alive?" He said she seemed to be surprised that I was alive. If I had been dead why she wouldn't have been. So perhaps somebody will ask me the secret of living so long and being so healthy. If the doctors had depended upon me for a living, they would have all starved, but the insurance men I am sure have prospered in my long life, because if I had all the money that I have paid for insurance I wouldn't have to worry any more in my life

But that as it is, the secret of my life I do not know. I think perhaps in the first place, if I had had time to think this over I might have done it a little better, but I am sure it has been a busy life. I have never known the time when there wasn't something ahead of me that I had to do, and still is. I think I haven't had time to think of myself and of my pains and aches and so they passed by unnoticed.

Perhaps the second one, maybe this should have been first, I have had faith, and I am not ashamed to say that. And that faith and there is One that would care for us all and I have done a minimum of worrying, and I think the third ingredient in a long life is to be happy. I have had a very happy life. This has depended upon a good many things, in the first place perhaps because I have been able to do.

First as a young man I thought I would like to be a preacher, and I accomplished that by hard work. And then I always had a desire having been brought up on a farm that someday I should own a farm, and I accomplished that. And then I always thought that I would like to go to the Legislature, but as the years passed by I almost gave up hope, until at last I came down here. I want to say that one of the pleasant experiences of my life has been spent here in the Legis-

lature and the fellowship I have received here.

Then of course something that adds to your happiness is having a happy home, and as was suggested in this obituary read here that December 6 my wife and I celebrated our fiftieth wedding anniversary. She got all the congratulations because all my friends said: we are going over and shake hands with Mrs. Meisner for her ability to tuck it out these fifty years, and she stayed with me these fifty years, and she says she hasn't any desire to leave me now after all these years.

We had three children, two daughters and a son, and they have been a credit to us and our family and never caused us too much trouble, and we have had a happy life. I think this is due to her good care. She watches me, and she sees to it that I eat my greens and carrots every day, and good home cooking.

Now there is a little story that I close with that her care over me hasn't been feeding me on pills or barbiturates or anything like that to keep me going. You know psychiatrists say nowadays that women should marry men that are at least six years younger than they are because men grow old faster than women. By the time a man is seventy he likes to read his paper and stay home nights a little more, but at around sixty- five or so women just, well, they want to go then, they're like free and they like to go places.

And so on one occasion where this was taking place, the man wanted to stay home at night and read his paper and this woman was full of life and she couldn't get him to go. She couldn't get him to the doctor either. So he wasn't feeling very well one day and so this is her chance and she called in a physician. So the physician came and examined him and said I don't see anything wrong with him, he is all right, he's got a little cold and so on. She said what's the matter with him? He wants to sit here all the time. I want to get up and go and he doesn't want to go anywhere. She said: Can't you give him something, haven't you got some pills

or something you can give him to rejuvenate him, and he said: well, yes, sure, I can. So he gave her some pills and he said: Now remember, be very careful of these pills, don't give him too many. Just one in his soup every night. So in her haste and anxiety and nervousness, she made the soup and went to pour a pill into the soup and several pills went in, but she still gave him the same soup and took a chance on what would happen. Of course he went to bed that night and slept soundly. and next morning came and he was still sleeping and she got up and made the breakfast and then she came in and he was still asleep, and she shook him and she said: Come on, get up, be alive! You should be young this morning. Be young! And he said: All right, he says, I'll get up, but I won't go to school. (laughter and applause)

Mr. Carey of Waterville was granted unanimous consent to address the House.

Mr. CAREY: Mr. Speaker, Ladies and Gentlemen of the House: Last Tuesday the gentleman from Madawaska, Mr. Levesque, spoke on the pace that was being set by the 103rd and compared it to the 101st and the 102nd, and while not wishing to take issue with the gentleman, I would speak as a freshman and say that the pace to me is currently being visibly increased. The gentleman from Portland, Mr. Healy, on the same day spoke about the piles upon piles of reports and surveys that he had, and he mentioned the fact that he was hard pressed to keep up with these matters.

As a freshman, I feel that the current pace along with the gradual speed-up is very suitable to myself, because currently I can just keep my head above water reading what I have presently been given.

To ask or infer that the pace be doubled at this time would do many of us a grave injustice. We would be forced to vote on many issues totally unprepared. Having been elected to this great body, I expect the best of myself as I know my constituents do. I don't
