SPEAKER KENNEDY: The Chair thanks the gentleman for his service and commends him for an excellent performance.

The SPEAKER: The Chair recognizes the gentleman from West Bath, Mr. Hennessey.

Mr. HENNESSEY: Mr. Speaker, Ladies and Gentlemen of the House: Perhaps other members of the House, as I am, are wondering what this Bill is all about, especially since the original budget request, having been drafted as an emergency measure, was pared down from \$80,000 to \$53,000, a reduction of \$27,000. A number serious questions must be of raised. Why was the appropriation reduced from \$80,000 to \$53,000? Is the \$53,000 adequate enough to do the job? And if so, doesn't the original request suggest departmental packing of the budget? If so, this raises another question. What kind of long-range planning is the department doing? If effective budworm control is part of the immediate and long-range plans of the department, why then have several recent Legislatures been faced with emergency money requests for budworm control?

Why should the natural resources of the state be preserved, protected and developed in such a haphazard manner? Indeed, Mr. Speaker, the question must be raised — how can the natural resources of the state be preserved, protected and developed in such a haphazard manner? Why should the Legis-lature be asked to support a program of such dubious results? While the Forestry Department in testimony before the Appropriations Committee referred to the National Academy of Sciences as observing this State's operation in 1961 as part of their studies toward establishing recommendations for aerial spraying, it failed in its advisement to the committee to note the preponderance of evidence developed by the same group, the National Academy of Sciences, is against this method of pesticide control. This method of budworm control is dubious. Its results are questionable. The department itself, again in testimony before the Committee on Appropriations, said "parasitism of the spruce budworm has not been reduced.'

The question can be raised too — is the Department of Forestry lightly treating the preservation and development of the State's wildlife resources? While the department claims to severe lasting effects to game fish, birds and game animals, I would underline their use of the words severe and lasting.

When the department refers to Canada as effecting budworm control, it again fails to advise the committee that control of budworm in Canada through the use of ¼ pound DDT while the department plans two applications of DDT at ½ pound per acre. In other words, twice the amount of DDT.

Mr. Speaker, there are too many serious doubts and questions surrounding this Bill for it to receive simple passage by this body without further study.

Mr. Haynes of Camden offered House Amendment "A" and moved its adoption.

House Amendment "A" was read by the Clerk as follows: HOUSE AMENDMENT "A" "To H. P. 22, L. D. 43, Bill, "An Act Appropriating Moneys for Spruce Budworm Control."

Amend said Bill in the 20th line (16th line in L. D. 43) by striking out the punctuation and words "; and any" and inserting in place thereof the following: 'but in no case shall the state's share exceed 50 per cent of the total cost. If federal funds become available, the state's share shall be reduced to a one third sharing. Any'

Further amend said Bill by adding at the end, before the emergency clause, the following paragraphs:

"There is appropriated from the Unappropriated Surplus of the General Fund an additional sum of \$20,000 to be matched with an equal sum by the landowners involved. This money shall be expended by the Commissioner of Inland Fisheries and Game or his agents for research into the effect on fish and wildlife by the use of DDT and such other chemicals as may be used on forest lands for control of insects. The s e moneys shall not lapse but shall remain in a continuing carrying account until the purposes of this Act have been accomplished.

No moneys may be withdrawn from the State Treasury for any work under this Act until such matching funds have been paid to the State Treasury by the landowners involved.'

The SPEAKER: The Chair recognizes the gentleman from Perham, Mr. Bragdon.

Mr. BRAGDON: Mr. Speaker and Members of the House: I think by this time we're probably all of us experts or nearly experts on the control of the spruce budworm. I haven't had an opportunity to give as careful consideration to this amendment as I would like to and I have prepared some amendments of my own because of requests that have come to me.

We have in this state, by the way, a Pesticides Control Board which was set up for the very purpose of studying the results and effects of use of pesticides, and from two or three members of that Pesticides Board I have received requests that if such studies as are suggested in this amendment are to be made that they feel that they should be included in them. One of them is Agriculture which probably, while I have no figures to substantiate what I'm going to say, uses many many times more quantity of DDT than the Forestry Department has ever used or every contemplates using; and they felt that in such studies they should be included, and I agree with them.

Also, another member of the Pesticides Board is the Sea and Shore Fisheries, Ron Green of Sea and Shore Fisheries, and he agrees that if such studies are going to be made that possibly it should go to the Pesticides Board where this whole Board would sort of oversee any studies of this type. And this morning I had another suggestion which I hadn't even thought of, that possibly our own Research Committee might be the medium that should conduct this study. So in view of the uncertainty that surrounds the whole question at this time, I would hope that someone would table this until Wednesday next in order that we might attempt to come up with what would be proper amendments and so forth, if we're going to have them. I hope somebody would table this.

The SPEAKER: The pending question is the adoption of House Amendment "A".

The SPEAKER: The Chair recognizes the gentleman from Fairfield, Mr. Champagne.

Mr. CHAMPAGNE: Mr. Speaker and Members of the House: I move indefinite postponement of this resolve.

The SPEAKER: The Chair recognizes the gentleman from Millinocket, Mr. Crommett:

Mr. CROMMETT: Mr. Speaker, Ladies and Gentlemen of the House: Nothing has been changed since we voted on this bill last week — only the mind of man. The lake under discussion has not increased in size, neither has it diminished. The records of the meeting held in Lincoln, September 1966, are the same.

Indecision is a disease of the mind; even the psychiatrists have not been able to determine why. All I can say is quote you from Shakespeare — I quote "To thine own self be true, and it must follow as the night the day, thou canst not then be false to any man."

Ladies and gentlemen, I oppose the indefinite postponement of this bill, and when a vote is taken I ask for a division.

The SPEAKER: The Chair recognizes the gentleman from Glenburn, Mr. Cookson.

Mr. COOKSON: Mr. Speaker and Ladies and Gentlemen of the House: I rise in support of my good friend, Representative Champagne, yet in defense of what I feel is a fine conservation measure one which was always in effect until three or four years ago, when a handful of people were successful in getting this pond opened to ice fishing, and not by the Legislature's action either.

It was closed to winter fishing it always was closed to winter fishing same as all of the other lakes and ponds in that area, and there are a lot of them there. There is just one lake up there, a large lake, which is not closed to winter fishing. This bill had a fine committee hearing with a roomful of people in attendance; nearly fifty people were for the closing, and only two people were for leaving it open. At the hearing we had maps that they used at the Lincoln hearing which was supposed to be crooked—these were plain old State Highway maps and the only thing that had been done to them, the lakes in the area had been colored. We could see nothing wrong with them whatsoever.

This survey by biologists which was mentioned by people who were for this bill, it turned out that this survey was made in 1955, and if my arithmetic is correct this was about twelve years ago. Also, the report at that time stated, the spawning areas in this lake are about ten acres which is at the inlet and are fished heavy by these ice fishermen and have been ever since.

I could go on here for a long time, I have a long speech here, but I'm not going to take up your time. This is just something that is not good conservation, and the only argument that seems to be in favor of these people who want to open this lake to ice fishing is that they didn't get a good hearing in Lincoln. We of your Fish and Game Committee are concerned about our hearing that we held. We had a real good one, and we don't want anyone to think that we were crooked in any way and we don't think that the people felt the one in Lincoln was. It's just a few selfish individual people who want to use this lake to fish, and drain it. And I say, let's close it.

The SPEAKER: Is the House ready for the question? The Chair recognizes the gentleman from Portland, Mr. Healy.

Mr. HEALY: Mr. Speaker and Ladies and Gentlemen of the House: While the debate on this subject has been very stimulating, it's not a world-shaking event, and I move that we fish or cut bait here. Thank you.

The SPEAKER: The Chair recognizes the gentleman from Millinocket, Mr. Crommett.

Mr. CROMMETT: Mr. Speaker and Ladies and Gentlemen of the House: No one has accused the Fish and Game Committee of being crooked. No one voting for this measure is of a selfish nature. Surely the Fish and Game Committee had a good hearing. As for the point I am trying to make, was the hearing held in Lincoln last fall, and if you wish to condone actions and uphold these the department and uphold the Fish and Game Committee, then these hearings are useless. All I am trying to do is to maintain integrity within the department, within these hearings, and that is all.

The gentleman from Glenburn, Mr. Cookson, evades the issue. This is not world-shaking, to be sure, but there's a moral issue involved here and I feel very strongly that that hearing was not the proper hearing, or the testimony was not proper, and if you wish to use the map for directional purposes as my good friend has said, well and good. But when you use that for comparison as to size certainly it should be drawn to scale; that is the only argument and the point that I am trying to make. Thank you.

The SPEAKER: Is the House ready for the question? The Chair recognizes the gentleman from Wilton, Mr. Scott.

Mr. SCOTT: Mr. Speaker, I move the previous question.

The SPEAKER: The gentleman from Wilton, Mr. Scott, moves the previous question. For the Chair to entertain the motion for the previous question it must have the expressed desire of one-third of the members present. All those in favor of the previous question will vote yes when the vote is taken; those opposed will vote no, and the Chair will open the vote.

Thereupon, the members having voted, the Clerk took a total.

115 having voted in the affirmative and 20 having voted in the negative, the Chair was authorized to entertain the motion for the previous question.

The SPEAKER: Shall the main question be put now? This is debatable for five minutes by any one member. Does the gentleman wish to debate the motion for the main question? The gentleman may proceed, and the Chair recognizes the gentleman from Woolwich, Mr. Harvey.

Mr. HARVEY: Mr. Speaker a point of inquiry, sir. Just one statement that I'd like to get in before this is voted on.

The SPEAKER: The only question that the gentleman can debate is, shall the main question be put now? The merits of the bill are not under discussion.

Mr. HARVEY: I would like for the members of the House to go along with me that this question should not be put now in order for me to make one statement before this is voted on. Thank you.

The SPEAKER: The Chair recognizes the gentleman from Madawaska, Mr. Levesque.

Mr. LEVESQUE: Mr. Speaker and Ladies and Gentlemen of the

House: I feel very sincerely that at this time to ask for the main question with the thought in mind that there might be somebody that have got some good and constructive remarks to be made, should be allowed at that time to proceed and hear their remarks so that everybody in this House when they take a vote will be informed as well as possible as to the nature of this document. Thank you.

The SPEAKER: Shall the main question be put now? All those by the Chair, a vote of the House opposed no.

A viva voce vote being doubted by the Chair, a vote of the House was had.

58 having voted in the affirmative and 80 having voted in the negative, the main question was not ordered.

The SPEAKER: The question is open to debate. The Chair recognizes the gentleman from Woolwich, Mr. Harvey.

Mr. HARVEY: Mr. Speaker, and Gentlemen of the Ladies House: There's one thing that sticks in my mind on this, and that is — the State Biologist's opinion was that this would not hurt the conservation, and it. might help it. Now we're paying the State Biologist good money every year, and I don't think we should slap him in the face and tell him his opinion is no good on conservation. I think that in this case here we should go by the State Biologist and give him a vote of confidence. And as far as over-fishing and conservation measures. I used to be an ice fisherman, up until I couldn't stand the cold, and it's doubtful if more than three or four people will ever get out there to fish on this lake. I say let's give the State Biologist conservation and it might benefit the lake. Thank you.

The SPEAKER: The Chair recognizes the gentleman from Pittsfield, Mr. Susi.

Mr. SUSI: Mr. Speaker, I move the previous question.

The SPEAKER: The previous question has already been enter-

tained and lost. The Chair cannot entertain the question at this time.

The Chair recognizes the gentlewoman from Portland, Mrs. Carswell.

Mrs. CARSWELL: Mr. Speaker and Members of the House: I've never been ice fishing — I would like to try it sometime. However, I've been fishing many, many times, and it seems to me that we should not forget that we advertise this as "Vacationland," and it also seems to me that it would be a simple proposition to stock the ponds so that we could continue to . advertise this as winter vacationland as well as summer vacationland. I think the motion to indefinitely postpone this bill should not prevail.

The SPEAKER: The Chair recognizes the gentleman from Kingman Township, Mr. Starbird.

Mr. STARBIRD: Mr. Speaker, I didn't intend to speak on this subject, but there is a clear issue involved otherwise than ice fishing. It's a clear question to my mind whether a few people shall ram their wishes down the throats of the many, or not. That's the pure and simple question of it. The majority of the people up in the northern end of Penobscot County I think want this lake opened, and I think their wishes should be abided by. Thank you.

The SPEAKER: The Chair recognizes the gentleman from Glenburn, Mr. Cookson.

Mr. COOKSON: Mr. Speaker, I disagree very much with the gentleman from Kingman Township. Most of the people up there want this lake open. And I would like to answer the other gentleman's remark by saying that I think that it was a biologist's suggestion here just recently to open the lake where Portland gets its water for prebaiting, Sebago Lake. This was a biologist's suggestion, so I don't think we should go along, and if you know what prebaiting is you know this isn't too good a judgment.

The SPEAKER: Is the House ready for the question? The question before the House is the motion of the gentleman from Fairfield, Mr. Champagne, that item 5, Resolve Opening Millimagassett Lake, Penobscot County, to Ice Fishing be indefinitely postponed. A vote has been requested. All those in favor of indefinite postponement will vote in the affirmative; those opposed will vote in the negative. The Chair will open the vote.

Thereupon, the members having voted, the Clerk took a total.

62 having voted in the affirmative and 77 having voted in the negative, the motion did not prevail.

Thereupon, the Resolve was passed to be engrossed as amended by House Amendment "A" and sent to the Senate.

The Chair laid before the House the sixth tabled and today assigned matter:

HOUSE ORDER re Roll Call.

Tabled-March 2, by Mr. Levesque of Madawaska.

Pending—Motion of Mr. Richardson of Cumberland to indefinitely postpone.

The SPEAKER: The Chair recognizes the gentleman from Madawaska, Mr. Levesque.

Mr. LEVESQUE: Mr. Speaker and Ladies and Gentlemen of the House: I don't think this morning that I would want to belabor this order at too great a length, although it is my firm belief that somehow in the system provisions can be made and should be made for each member of this House to receive a copy of an ordered roll call. Just what the system to provide this vehicle to necessarily inform the members that wish to have a roll call, it is my firm belief that the setup that we have presently for services through the Clerk's Office would be the most efficient and adequate way of providing this service. However, some members seem to feel differently, and I certainly hope that each member of this House will vote his true feelings in relation to this order when it comes up for a vote.

The SPEAKER: The Chair understands that the gentleman from Madawaska, Mr. Levesque, requests a vote relative to the indefinite postponement of this House Order.

The Chair recognizes the gentleman from Cumberland, Mr. Richardson.

Mr. RICHARDSON: Mr. Speaker. in support of the motion to indefinitely postpone the order presented by the gentleman from Mada-waska, Mr. Levesque, I wish to make it absolutely clear that in my judgment we have ample provision made for any member who wishes to receive as many copies as he wishes of any roll call which is taken in this House. I explained at some length the last time that we discussed this matter the reasons for doing so. I think this is going to work out very well. I urge you to go along with me and vote in favor of indefinite postponement and give us an opportunity to try this system. Thank you.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker and Members of the House: About two weeks ago I suggested that this earth-shaking order be tabled so that the leadership of both parties could get together and arrive at a momentous decision. I see somewhere along the line that they didn't have what is commonly known as a meeting of the minds.

And there was another reason why I suggested this order be tabled, because I have been requested to give my bad philosophy that I usually expound on every two years wherein it concerns the situation. I was privileged last week, granted a rare privilege last week, it was the day of the hearing that was important to us at home, and I was invited to luncheon by the Chairman of the Highway Committee on the fourth floor. While we were munching on a sandwich, the rare privilege that I was treated to was that there was one magnavox that was open and I found myself participating in a caucus of the friendly opposition. I note that the Speaker is smiling; I didn't hear his voice; I presume that he was munching on a cigar in his office or sitting in his seat. The Chairman of course was the Majority Leader, Republican leader, as the Chairman of our caucuses is always unless he is absent. the Majority the Democratic Leader.

As in our caucuses I was happy to note that the Republican Party took up, voted upon and decided also on as earth-shaking problems as we do in our caucuses. They talked briefly about the Indians. If my hearing serves me correctly. nothing was really solved, but the Chairman of the caucus of course gave everybody that old gung-ho as our friend Mr. Levesque does. go, go, go; do the right thing as long as you do it my way, that is the right way. Also, the next issue that was taken up was the program involving the process that was going to be taken wherein it concerns the Agricultural Bill. I smiled at that because I recall that it was only a week previously in our caucus I had made also that earth-shaking motion that we would stand behind our Governor, and I was chagrined when I didn't even see it on the want ad pages in the next day's periodicals. Naturally, the Republican leader again made his plea to his colleagues to certainly go along with him, and the round of applause that greeted him still rings in my ears.

It recalls to me my days when I was honored by my Party to be the leader. Having then been around these halls a few semesters, I decided the importance of caucuses, and in my entire tenure as leader I called two caucuses. I was clobbered on both of them and believe you me there were no more caucuses as far as I was concerned.

can recall also what goes inside the railing here wherein it concerns itself with approximately three weeks ago our own leader getting up and talking about the slow process, and how we were not moving as fast as we did two years ago; and going home with two or three of my colleagues, one of them mentioned the fact that with his remark it was possible that our leader could get himself into trouble with the Speaker, I mean one of them commented that it was a horrible thing for our leader to take issue with the leader of the opposition. Then lo and behold one of our freshmen colleagues got up with a horrendous thinking that he thought everything was going along great, and on the same day that he made these comments on my way home with the very same individuals they thought it was terrible that this young man would get up and speak his piece, he then would get himself into trouble with Mr. Levesque, and what a horrible thing that would be. So that also as the situation concerning this order was not resolved.

It reminds me also yesterday of my very good friend from Limerick, Mr. Carroll, made the statement that if we tabled matters for too long we would be here a long time. I recall that when I first got here the comment that was used then was that if we tabled matters for too long, and the remark that was used on the motion of a previous question, if we don't hurry, we'll be here until Patriot's Day or until Passover, which is April 19 or April 25 respectively. Now as things have progressed, the motion has become on the 30th, July 4th; I have even heard Labor Day and I have heard Christmas, and oddly enough, my friends, on more than one occasion. if you will check back the record for the last twenty years, you will find that on more than one occasion I have made the motion, that strong, vociferous motion to the effect that we should have the previous question because we will be here if we don't, clearly to the 4th of July or Labor Day or some later date, when all the time if the truth be known, is that when we finally do adjourn here, I am the first one to sneak into a corner and shed a tear because we have adjourned.

Also, as I recall, as of today's debate, when one takes opposition. Now here is the way in my opinion that it goes. If you are going to just take exception with one of your colleagues without too much blood flowing, you will say the gentleman from so and so, mister so and so. If you're going to go a little stronger, you will say the gentleman from so and so, my friend. But brothers and sisters, if you are really going to give it to them, the thing to say as I am saying, to my very, very dear friend and colleague so and so from so and so; and believe you me, that gives you the right to really lay them out in the aisles. It's always been my thinking that somewhere along the line some day, I would like to have people speak well about me after and not before, because what they say about me before means absolutely nothing. It's what they say: Louie's a good fellow, but; then look out.

It's not my intention to take up too much of your time. I have been waiting for this brief dissertation. I am extremely sorry that the leadership of both parties did not see fit to get together and solve this problem. If they can't do so, I'll solve it for them call in the people we rent this infernal machine from, give it back to them, and let's go on voting in the old way. Thank you very much.

The SPEAKER: The Chair recognizes the gentleman from Madawaska, Mr. Levesque.

Mr. LEVESQUE: Mr. Speaker and Members of the House: I don't know if I should refer to my dear, dearest or my very best colleague from Lewiston, the gentleman Mr. Jalbert who has just spoken previously, but I could say this that in regards to the suggestion that he made last week of the two leaders getting together and come up with a solution, the Minoritz London has met with the Minority Leader has met with the Majority Floor Leader, Mr. Richardson, and we had a most understanding meeting, and the Majority Floor Leader was most understanding and cooperative. The answer to the problem presently before us we pursued several avenues, and I think probably the Majority Floor Leader is somewhat in the same position as I am as to what is the best avenue that we should pursue. We know what the avenue is, but we don't seem to be able to have an open street, we seem to find ourselves in a dead end and we cannot go completely to that street, so our meeting was very fruitful; we had a very cordial meeting, and I might say this for the Majority Floor Leader a most amicable meeting.

The SPEAKER: The Chair recognizes the gentleman from Cumberland, Mr. Richardson.

Mr. RICHARDSON: Mr. Speaker and Members of the House: I speak with great regret, seeing that Representative Libhart is here watching me, involved in what I consider a rather childish discussion.

First of all, with respect to the order, I feel that the provision by which the secretaries to the Floor Leaders will provide copies of whatever number you wish is a good system. I think that we should try it and do so without further ado.

Secondly, with respect to the gentleman from Lewiston, Mr. Jalbert, it is always a pleasure to provide him a well informed, thoughtful luncheon period, and this is the reason why the box was left on.

Thirdly, I would remind the members of the House that I did not introduce this order with respect to these roll calls, and finally I would say that I hope we can without further ado move on, indefinitely postpone this order, for Jalbert Day will come sometime in November. Thank you.

The SPEAKER: The question pending before the House is the indefinite postponement of item 6, the House Order regarding a roll call and a vote has been requested. All those in favor of indefinite postponement will vote yes; those opposed will vote no. The Chair will open the vote.

A vote of the House was had.

88 having voted in the affirmative and 49 having voted in the negative, the motion did prevail.

The Chair laid before the House the seventh tabled and today assigned matter:

An Act Permitting Waiver of Citizenship Requirement for Technical and Professional Personnel (S. P. 165) (L. D. 336)

Tabled — March 7, by Mr. Martin of Eagle Lake.

Pending — Passage to be enacted.

The SPEAKER: The Chair recognizes the gentleman from Kittery, Mr. Dennett.

Mr. DENNETT: Mr. Speaker. I now move that this bill be passed to be enacted.

The SPEAKER: The Chair recognizes the gentleman from Hampden, Mr. Littlefield.

Mr. LITTLEFIELD: Mr. Speaker, Ladies and Gentlemen of the House; I said what I had to say on this bill yesterday. I only request a division in order that I can be recorded as voting no on the bill.

The SPEAKER: Is the House ready for the question of enactment?

The Chair recognizes the gentle-

man from Kittery, Mr. Dennett. Mr. DENNETT: Mr. Speaker, I regret that due to the weather yesterday I was unable to be present. I don't know what the gentleman from Hampden, Mr. Littlefield, said about the bill, but nevertheless I think the members of this House are entitled to an explanation as to what this bill is all about. The hour is late; I'll be brief, and I'll be as concise as possible in my explanation of the bill.

It appears that officials from the Department of Mental Health and Corrections particularly appeared before the Committee on State Government in favor of this bill. We listened long and carefully and we came unanimously to the conclusion that this was good legislation. Now here is simply what it intends, and it is very plain in the bill. In case that citizens cannot be found to fill these technical and professional positions, that the Department of Personnel would be enabled to employ them by waiving the citizenship requirement.

Now this particularly apparently takes place in the Department of Mental Health and Corrections, particularly again in the field of psychiatry where it is literally impossible, and bear in mind what I have to say here, with the salaries that the State of Maine pays to obtain citizens to fill these jobs. Now our citizens, psychiatrists particularly, seem to search out the big cities, the large centers, and are very hesitant to come to Maine. Some of them seem to feel that they are being sent to

Siberia if they come to Maine. On the other hand, there are foreign professional men and technicians who look upon this as the land of milk and honey and are very willing to accept salaries such as we have to offer, and it is for this reason, the inability to obtain these people, that this legislation is being promoted.

Now of course we do have alternatives to this. We can certainly double or treble the salaries of these people and I don't think that we have any desire to appropriate money in such sums as would be called for. We could also as another alternative reduce the mental care of these people and sort of throw them to the winds, but officials of this department, and again this department in particular, feel that if they are allowed these people to employ who are fully qualified at the salaries that the State of Maine is willing to pay that they can obtain such assistance and all in all no doubt the State of Maine will be richly rewarded. Again, it is set forth in the bill that under no condition whatsoever will they employ any non-citizen if citizens can be found. I certainly hope this bill will be passed to be enacted.

The SPEAKER: The Chair recognizes the gentleman from Bath, Mr. Ross.

Mr. ROSS: Mr. Speaker and Ladies and Gentlemen of the House: I certainly shall be brief because you have heard me argue twice about the same type of thing pertaining to citizenship of assessors. But you know there is another precedent that might be of interest to persons concerned with educa-tion. Section 556 of Title 5 of the Revised Statutes originally pro-vided that "all state employees shall be citizens of the United States of America," but this was later amended by Chapter 218 of the Public Laws, this section was amended by adding a sentence to read: "This section shall not apply to those employees designated in section 711, subsection 8." Now Section 711, subsection 8 covers a very interesting group: "Officers and employees of the University of Maine, of the several state teachers' colleges and of the unorganized territory school system and the teachers and principals of the school systems and state vocational schools and state institutions."

Mr. Littlefield of Hampden requested a roll call.

The SPEAKER: A roll call has been requested. For the Chair to order a roll call, it must have the expressed desire of one-fifth of the members present and voting. All those who desire a roll call will vote yes and those opposed will vote no, and the Chair will open the vote.

67 voted in the affirmative and 60 voted in the negative.

The SPEAKER: Obviously, more than one-fifth having voted, a roll call is ordered.

The Chair recognizes the gentlewoman from Portland, Mrs. Carswell.

Mrs. CARSWELL: Mr. Speaker, not having attended the hearing, I do have a question. Can these professional people remain noncitizens or is there a limit to the time they can remain as noncitizens?

The SPEAKER: The gentlewoman from Portland, Mrs. Carswell, poses a question through the Chair to any member who may answer if they so choose.

The Chair recognizes the gentleman from Kittery, Mr. Dennett.

Mr. DENNETT: Mr. Speaker, in reply to the gentlewoman from Portland, Mrs. Carswell, I would say there was no information brought out at the hearing that they had to become citizens. Apparently in some instances they do, but there is nothing that makes it compulsory.

The SPEAKER: The Chair recognizes the gentlewoman from Portland, Mrs. Carswell.

Mrs. CARSWELL: Mr. Speaker, I would like to table this matter until such time as we can perhaps come up with some kind of an amendment.

The SPEAKER: The gentlewoman from Portland, Mrs. Carswell, moves this be tabled until when?

Mrs. CARSWELL: Thursday, Mr. Speaker.

The SPEAKER: Until Thursday, March 9. Is this the pleasure of the House?

(Cries of "No")

All those in favor will answer yes, those opposed will answer no.

A viva voce vote being taken, the motion did not prevail.

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Quinn.

Mr. QUINN: Mr. Speaker, through the Chair, I would like to be informed, I assume that these people that are coming here in a professional capacity, are coming here qualifying under our laws of qualification and that the passage of this bill will by no means waive those requirements.

The SPEAKER: The gentleman from Bangor, Mr. Quinn, poses a question through the Chair to any member who may answer if they choose.

The Chair recognizes the gentleman from Kittery, Mr. Dennett.

Mr. DENNETT: Mr. Speaker, in answer to the question raised by the gentleman from Bangor, Mr. Quinn, yes, most certainly these people have to qualify under our laws.

The SPEAKER: A roll call has been ordered. The pending question is the enactment of this bill, An Act Permitting Waiver of Citizenship Requirement for Technical and Professional Personnel, Senate Paper 165, L. D. 336. All those in favor of enactment of this bill will vote yes, those opposed will vote no, and the Chair will open the vote.
