An Act Increasing Number of Medical Examiners in Washington County (H. P. 393) (L. D. 540)

This being an emergency measure and a two-thirds vote of all the members elected to the House being necessary, a total was taken. 135 voted in favor of same and none against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

Mr. GAUTHIER: Mr. Speaker and Ladies and Gentlemen of the House: I would like to congratulate Coach Sturgeon and his Old Town High School basketball team for having won the State LL Championship at Bangor last Saturday night. I would also at this time like to congratulate Coach Rod Shain and his Sanford High School basketball team for the fine game they played, having lost the game by only two points.

House Amendment "A" was read by the Clerk as follows:

HOUSE AMENDMENT "A" to H. P. 46, L. D. 65, Bill, "An Act Revising the Law Governing the Taxation of the Business of Raising Domestic Fowl."

Amend said Bill by inserting after the underlined word "fowl" in the 17th line (13th line of L. D. 65) the underlined punctuation and words ', except breeder fowl.'

Further amend said Bill by inserting after the underlined paragraph A-1 (same in L. D. 65) the underlined paragraph A-2 which reads as follows:

'A-2. The average number of breeder fowl kept for egg production shall be determined on the basis of one bird for each 3 square feet of house capacity, unless the taxpayer shall have complied with section 706, except when fowl are kept in cages or under a high density system of management in which case the average number shall be determined by averaging actual inventories during the preceding taxable year or any portion of that period when the business has not been carried on for a year.'

Further amend said Bill by inserting at the end the following:

(4) The term "breeder fowl" shall mean that kind of fowl which produces eggs for production of chicks.'

House Amendment "A" was adopted and the Bill passed to be engrossed as amended and sent to the Senate.

The Chair laid before the House the third tabled and today assigned matter:

HOUSE REPORT — Ought Not to Pass — Committee on Education on Bill "An Act Providing Subsidy to Driver Education" (H. P. 307) (L. D. 441)

Tabled-March 7, by Mrs. Hanson of Lebanon.

Pending—Acceptance.

The SPEAKER: The Chair recognizes the gentleman from Denmark, Mr. Dunn.

Mr. DUNN: Mr. Speaker and Members of the House. I move that we substitute the bill for the report and would like to speak briefly to that motion.

The SPEAKER: The gentleman from Denmark, Mr. Dunn, now moves that the House substitute the bill for the report, and he would like to speak to that motion. The gentleman may proceed.

Mr. DUNN: Maine has had a commendable driver education program but it is believed that with additional funds, an additional subsidy, it could be greatly expanded. Many states are paying a great deal more toward this program than Maine is, and in Maine the Department of Education estimates it costs about \$60 to educate each pupil, and we only contribute ten.

Now this is part of the Highway Safety Program. I have here a reprint of a status report on the federal role in highway safety, and the National Safety Agency has issued an initial list of thirteen standards for state highway safety programs. Two program components were mandated in the two major safety Acts of 1966 and thus emerge as logical candidates for immediate attention on the part of state legislatures. The two are Motor Vehicle Inspection and Driver Education, and further on in the report under the Highway Safety Act of 1966 every state must have a highway safety program approved by the Secretary of Commerce by December 31, 1968, or risk loss of ten per cent of the federal highway construction funds.

Now I believe that this project and this effort is worthy of consideration. If we pass it, it does go to the Appropriations' table and has to take its chances along the last of the session with other measures, but I think it does deserve possibly going that far. I hope you'll support the motion.

The SPEAKER: The Chair recognizes the gentlewoman from Lebanon, Mrs. Hanson.

Mrs. HANSON: Mr. Speaker and Members of the House: I request a division.

The SPEAKER: A vote has been requested. Is the House ready for the question?

The Chair recognizes the gentleman from China, Mr. Farrington.

Mr. FARRINGTON: Mr. Speaker, Ladies and Gentlemen of the House: I would speak briefly on the prevailing motion. I am very much concerned with the driver education courses in secondary schools. The driver education program in Maine in the secondary schools has been recognized as one of the outstanding programs in the country. The Insurance Institute for Highway Safety has awarded Maine nine plaques for enrolling more than 69 per cent of its eligible students in approved driver education programs.

And on the debit side of this ledger almost 40 per cent of all our youths now being deprived of the opportunity to enroll in driver education courses, are deprived of this opportunity when in 1966 this state was plagued with greatest number of highway automobile fatalities in the history of the State. With this rising trend in automobile fatalities, it seems to me that we should upgrade the amount paid for the support of this program, being consistent with the cost of living in each other field, and I certainly hope that the prevailing motion to substitute the bill for the report stands. Thank you.

The SPEAKER: The Chair recognizes the gentleman from Augusta, Mr. Lewin.

Mr. LEWIN: Mr. Speaker, Ladies and Gentlemen of the House: The

question has been asked — why is driver education not included in all the schools in Maine? Some of the school committees feel that they cannot afford driver education. The cost is approximately \$45 per student, \$10 of which is returned to the town in the form of state subsidy.

Another complaint is that the subject is hard to schedule and too time- consuming. Each student receives a minimum of thirty hours of classroom instruction, and six hours of "behind the wheel" training in a dual-controlled automobile. Some school departments offer driver education programs in the summertime only.

The state law allows tuition to be charged for summer programs. The State Department of Education recommends the program be conducted during the regular school year, and that a supplemental program for students unable to enroll during the year be run during the summer. Approximately 12,000 students graduated from driver education programs in Maine's secondary schools last year, and a larger number is expected this year.

If the driver education program is to continue to succeed the state must help bear the cost. This state currently ranks among the lowest in the nation in its contribution to driver education.

The SPEAKER: The Chair recognizes the gentleman from Rockland, Mr. Huber.

Mr. HUBER: Mr. Speaker, may I ask a question? Has this bill been amended?

The SPEAKER: The gentleman poses a question through the Chair, has this bill been amended?

It came out with an "Ought not to pass" report.

The pending question now is the motion of the gentleman from Denmark, Mr. Dunn, to substitute the bill for the report. The Chair recognizes the same gentleman.

Mr. DUNN: Mr. Speaker, perhaps its my imagination or I've read somewhere else that this has been changed, or there's another bill similar which strikes out the "satisfactorily completing." This I think, if memory serves me cor-

rectly, encourages schools to satisfactorily pass students taking Driver Ed for the sake of the subsidy money, and if someone recalls a bill which strikes that from it I would appreciate it, because I don't care for this, this way.

The SPEAKER: The pending question is the motion of the gentleman from Denmark, Mr. Dunn, to substitute the bill for the report. That is item 3 on your calendars. Is the House ready for the question?

The Chair recognizes the gentleman from Mars Hill, Mr. Dickinson.

Mr. DICKINSON: Mr. Speaker and Members of the House: In answer to the question about an amendment, my records do not indicate any amendment has been made to this present bill. Thank you.

The SPEAKER: The Chair recognizes the gentleman from Mada-

waska, Mr. Levesque.
Mr. LEVESQUE: Mr. Speaker and Ladies and Gentlemen of the House: As indicated on your calendar, this was a unanimous "Ought not to pass" report from the Education Committee.

The SPEAKER: The question before the House is the motion of the gentleman from Denmark, Mr. Dunn, that we substitute the Bill for the "Ought not to pass" Report. If you are in favor of substituting the Bill for the Report you will vote yes; if you are opposed you will vote no. The Chair will open the vote.

Thereupon, a vote of the House was had.

58 having voted in the affirmative and 74 having voted in the negative, the motion did not prevail.

Thereupon, the "Ought not to pass" Report was accepted and sent up for concurrence.

The Chair laid before the House the fourth tabled and today assigned matter:

An Act to Clarify State Aid for School Construction Purposes and Borrowing in Anticipation Thereof (S. P. 63) (L. D. 107)

Tabled—March 9, by Mr. Jalbert of Lewiston.

Pending—Passage to be enacted.

On motion of Mr. Dunn of Denmark, the House voted to suspend the rules and to reconsider its action of March 1 whereby the Bill was passed to be engrossed.

Thereupon, the same gentleman offered House Amendment "B" and moved its adoption.

House Amendment "B" was read by the Clerk as follows:

HOUSE AMENDMENT "B" to S. P. 63, L. D. 107, Bill "An Act to Clarify State Aid for School Construction Purposes and Borrowing in Anticipation Thereof."

Amend said Bill by striking out all of section 4 (same in L. D. 107)

Further amend said Bill by renumbering sections 5 to 8 (same in L. D. 107) to be sections 4 to 7.

The SPEAKER: The Chair recognizes the gentleman from Pittsfield, Mr. Susi.

Mr. SUSI: Mr. Speaker, I would like to have an explanation of the amendment.

The SPEAKER: The gentleman from Pittsfield, Mr. Susi, requests an explanation of the amendment through the Chair and anyone may answer who so chooses.

The Chair recognizes the gentleman from Denmark, Mr. Dunn.

Mr. DUNN: Mr. Speaker, this eliminates on page 3 of the Bill the part that has to do with towns borrowing in anticipation for the regional vocational schools, it eliminates that from the bill.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker and The Members of the House: amendment which eliminates that section that involves area regional vocational schools does not mean that this is the end of the area regional vocational school legislation. There is a bill that will come before you that calls for the financing of these schools. At the last session a bill was presented and passed that would set up the concept of area regional vocational schools. There is a bond issue now that will come before you later. This amendment merely strikes out the program out of this L. D. 107. I think it is a justifiable amendment and I would support it.

The SPEAKER: The Chair recognizes the gentlewoman from Lebanon, Mrs. Hanson.

Mrs. HANSON: Mr. Speaker, I would like to agree with the gentleman from Lewiston, Mr. Jalbert, this does take it out of this bill, but if we vote for the bill coming up to support vocational education that will be taken care of.

Thereupon, House Amendment "B" was adopted, the Bill passed to be engrossed as amended by Committee Amendment "A", House Amendment "A" and House Amendment "B" in non-concurrence and sent up for concurrence.

Mr. Nadeau of Sanford was granted unanimous consent to address the House.

Mr. NADEAU: Mr. Speaker, Ladies and Gentlemen of the House: Last Saturday Sanford High School, Western Maine LL basketball champions coached by Rodney Shain invaded Bangor for the State title. I take this opportunity to congratulate Sanford High School for its excellent play and sportsmanship and, with pride, I am proud to say that I am happy to be from Sanford even though we lost. It was most enjoyable and I thought it was an excellent ball game.

We, therefore, the people of Sanford and Springvale, the Selectmen, the members of the School Board. Dr. Morin, Attorney Willard and Representative Gauthier, Principal Mr. Parker, Superintendent of Schools Mr. Bowers, and the entire staff of Sanford High especially Coach Rod Shain, Captain Nick Scaccia, who incidentally set a new record, and its basketball players, we would like all to congratulate Old Town High School and its staff and its most able Coach, Mr. Don Sturgeon, and its excellent and fine basketball team.

To Representative Joe Binnette, I bow and yield to the State's number one team in LL, Old Town. The date and place for your steak supper, Joe, incidentally lays in your most capable hands.

Mr. Jalbert of Lewiston was granted unanimous consent to address the House.

Mr. JALBERT: Mr. Speaker and Members of the House: I would refer to page 4, item 1 under Leave to Withdraw, wherein it concerns the bridge across the Androscoggin River. I have three people and two notes sent to me concerning this measure. This is merely another bill that set the location that I have had withdrawn. The bill is very much alive and leaves the location to the City Governments and the State Highway Commission. I would now speak off the record.

Mr. Lowery of Brunswick presented the following Resolution out of order by unanimous consent and moved its adoption:

BE IT FURTHER RESOLVED: That these Resolutions be entered in the Journal of the House and an engrossed copy of these Resolutions be sent to the family of the deceased; and

BE IT FURTHER RESOLVED: That as a further token of respect the House do now stand adjourned.

Thereupon, the Resolution was adopted and the House stood adjourned pursuant thereto until ten o'clock tomorrow morning.
