Mr. BERRY: Mr. President and members of the Senate: There have been several legislative documents introduced in this session which have the laudable attempt of trying to simplify and make more efficient our election procedure. I believe that we all realize that superlegislation cannot do some of the things that we may want to do. This has been brought out at hearings before the Election Laws Committee, Accordingly, this order is introduced to set up a committee with full powers to study all facets of the Election Laws problem-and I have enumerated them in the order but they are not necessarily limited to these specific problems. I believe the matter has the support of all legislators of both parties, because it attempts to, and I am sure will result in providing an adequate study committee, buttressed by specialists in the field, adequately financed to employ consultants, with the objective of bringing back specific legislation on the several problems.

It should be emphasized that this will not result in an attempt to convey a change in philosophy on the several points but merely give the legislature the opportunity of deciding if it wishes to make the several changes: It knows the mechanical procedures, the legal difficulties, have been ironed out.

The legislature will have the opportunity to decide on the merits of the principles involved when the report is returned from the committee. Mr. President, I move the passage of the order.

The PRESIDENT: Out of order, the Chair is pleased to welcome a group of 45 Seniors from Wiscasset High School, accompanied by their teacher, Chester J. Napage.

We hope that you enjoy the proceedings here and are impressed by these Chambers. Their history may be interesting to you.

When the State Capitol was moved to Augusta from Portland, Mr. Charles Bulfinch, a noted architect, was engaged to design a building which would be like the State House in Massachusetts on a smaller scale. Ten and a half townships of public land were ordered sold to provide building funds of \$60,000, which is slightly less than the amount used to renovate this single room here seven years ago.

Under the Bulfinch plan, the original Senate Chamber, which was used for the first time in 1832, by the 12th Senate, was a much smaller room located on the other end of the building, which at that time included only the central section of the present building Fireplaces flanked the President's desk and were faced on the other side of the room by stoves to heat the Chamber. As Maine grew, so did the task of conducting its business, and the Senate Chamber often doubled as a committee hearing room. By 1929 the general overcrowding of the whole State House Building required the addition of the north and south wings, and thus exactly

fifty-six years ago the 75th Senate opened its sessions in this room, which is about 60 per cent larger than its original chamber. With the exception of a few repairs and painting, the Chamber remained the same until 1960, when it was completely remodeled as you see it today: new furnishings, mahogany desks, along with every modern device, such as ventilating system and a new public address system. You may be proud of the fact that Maine has one of the most beautiful Senate Chambers in the United States.

I would be very pleased to introduce to you at this time your Senator, the Senator from Lincoln, Mrs. Sproul. And may the Senators greet the students from Wiscasset

Mr. BARNES of Aroostook: Mr. President, I move the pending question.

The PRESIDENT: The Senator from Aroostook moves the pending question, and the pending question is the passage of the bill to be engrossed.

Mr. SNOW of Cumberland: Mr. President, I move that this document, L. D. 41, be indefinitely postponed, and I would like to speak to my motion.

The PRESIDENT: The Senator from Cumberland, Senator Snow, moves that the first tabled and today assigned matter be indefinitely postponed. The Chair recognizes the Senator from Cumberland, Senator Snow.

Mr. SNOW: Mr. President, very briefly, it seems to me that this bill would call for a practice which is not in the best interests of good government in the State of Maine. It has been my feeling, and not in a partisan sense, for some time, that the Governor should have the appointment of the department heads with whom he must work.

Mr. BARNES of Aroostook: Mr. President, being the sponsor of this bill, I feel compelled to speak in its behalf at this time.

I think this is a good bill, I think it is sound legislation. This is not a party bill, this is non-partisan. In my opinion, and in the opinion of many people in the State of Maine, especially those associat-

ed with the industry of agriculture and allied industries, feel that the Commissioner of Agriculture can be better selected by a joint vote of the Senate and the House of Rpresentatives rather than committing this prerogative to the Governor, feeling that this is a more democratic way of electing the Commissioner of Agriculture rather than having one man using this appointment as political expediency. I say this in candor: I say that agriculture is a very important industry and it is important to us that we have the most able and most qualified man in the State of Maine for this position. Regardless of party affiliation, there is always the possibility of one man being selected by the Governor as Commissioner on the basis of political expediency.

The minority party is advocating that we do away with the executive council; they are also advocating appointment of the constitutional office by the Governor. If that is the case, then we are driving towards centralized government. Many of the people in my area of the State of Maine object to this philosophy in government. I believe this is sound legislation, and I hope that the members of this august body concur in my thinking, and I humbly request and solicit the support of the mem-

bers of this Senate.

At this time I request a division when the vote is taken. Thank

you, Mr. President.

The PRESIDENT: The pending question is on the motion of the Senator from Cumberland, Senator Snow, that this item be indefinitely postponed.

Mr. HARDING of Aroostook: President and members of the Senate: It is not easy for me to speak against this bill which is sponsored by the Senator from Aroostook, Senator Barnes, Senator Barnes is not only my seatmate but he is from my own town, Presque Isle, and, not only that, but we live on the same street: Senator Barnes lives on the high side of Hillside and I live on the low side of Hillside, but it is my hope and expectation that, regardless of what happens to this bill

and the other bills that may be pending before this Legislature. that we may continue to go back and forth on Hillside Street and visit with each other.

Seriously though, I think that State Government, if we are to exercise our responsibility, must be efficient and it also must be responsive to the needs of the people. I think it is basic, in our study of State Government in high school and college, that the executive enforces and administers the laws, the legislature makes the laws and the judiciary interprets the laws. Now under this proposed bill, the legislature would, in effect, be administering the laws because we would be selecting the person who would be administering the laws so far as the Department of Agriculture is concerned.

Now to get this right down to the areas where perhaps it is more understandable and specific, I think if we went out and talked with a farmer and said: hired man, sir, do you think he should have two or three bosses?" -he would think I was crazy if I made that suggestion; and yet under this bill as proposed the Commissioner of Agriculture would not have one boss, he would have 185 bosses. But, more than that, is elected for a four-year period, and no matter how poorly he performs there is no way to remove him unless it were by way of impeachment, which involves the commission of a crime. If you told a farmer he had to hire his men on that basis, I think every farmer would say that would be an intolerable situation. Also, so far as the 185 bosses are concerned who would be hiring the Commissioner of Agriculture, out of the four years the term there are 1460 days, approximately, and the bosses would be around some 200 days out of that period of time to see what their hired man was doing.

Now I think we recognize the problem of having too many bosses, and one of them is the loss of a sense of direction. I notice in the papers that some said it would be easier to get the Commissioner of Agriculture's ear insofar as the legislature is

concerned. That may or may not be so, but when I come to the Commissioner of Agriculture, for instance, and ask him to do something, how is he to know that Senator Barnes, for instance, might wish him to do the contrary. So, as a matter of fact we know that historically, the legislature have a caucus to instruct the Commissioner what to do; in fact the Commissioner has not known after he has been elected what the wishes of the legislature were. I think, particularly in the Attorney General's department, who is elected on the same basis - and this is no reflection on the people who have held that office, but certainly there has not been the sense of direction as to what the people would like to do; and I think here there is serious consideration before this legislature to make changes in that regard. And insofar as the Treasury Department is concerned, there has certainly been a loss of sense of direction there, and we know over a period of years what that has meant to the people of the State of Maine, it has meant a loss of some millions of dollars because this treasurer had 185 bosses instead of one.

Some say that if the Governor appoints it may be political. Of course that is so. But I suggest to you that when the legislature appoints it is always political. Never in the history of these appointive offices by the Legislature has a person been elected other than a person of the majority party. Not only that, but he must be a political person to go out and campaign for the job.

Now under the bill as it now is, this Commissioner will serve at the pleasure of the Governor, which means this: that if he performs badly the Governor may fire him; and I think that is the way it ought to be.

But I am not asking that you accept my judgment alone on this; I call your attention to the judgment of a man who is a farmer, and he is from Aroostook County; he served as a member of the House, he served as a member of the Senate, he served as the Senate President, and he served longer as Governor of the State

of Maine than any other man in history. It was his judgment that the bill, when Senator Barnes proposed it, was a bad bill, and that is why he signed the law which now makes it possible for the Commissioner of Agriculture to be appointed by the Governor. So I ask you not only not to repudiate Governor Reed on this particular matter, but I also ask you not to give the Commissioner of Agriculture 185 bosses. I think that is unfair to him. So I join with the Senator from Cumberland, Senator Snow, in support of his motion to indefinitely postpone this bill.

Mr. LUND of Kennebec: Mr. President and members of the Senate: My purpose in rising is to oppose the motion to indefinitely postpone and to explain briefly the thinking of the signers of the majority report of the Committee on State Government.

This bill would reverse a change which was enacted at the last session of the legislature. Prior to the last session of the legislature, for some time the Commissioner of Agriculture was appointed by the Legislature, and in fact the present Commissioner of Agriculture was appointed by the Legislature under the former law and under the law as it would be if this bill passes.

At the hearing there was, as has been indicated, some opposition to the bill. There were two people who appeared in opposition to the bill, including former Senator Ralph Hilton, as has been mentioned. However, of the farmers' organizations that appeared - and there were several that appeared through their spokesmen - thev were unanimously in favor of the passage of this legislation, and it was their feeling, and I think the feeling of the committee that the Commissioner of Agriculture is different perhaps from some of the offices that have been spoken of this morning, that his work touched very intimately, not only upon the lives of the citizens of our State but particularly upon the lives of those who live in the rural areas, and even those who opposed the passage of this bill had no fault to find with the old law as it had worked in the appointment of the present Commissioner.

Mr. BERRY of Cumberland: Mr. President and members of the Senate: I rise with a great deal of reluctance. I feel that every person, every gentleman and lady who speaks from the floor of these august chambers should be an authority on the subject to which they are devoting their attention for the edification of the other members of the body; and, consequently, as I am the Director of Deficit Financing at the present stage of the game, I see little reason for me to stand up and agricultural matters. speak on However, when my confrere from Cumberland County, who has been called "Mr. Education" can stand up and hold forth on the subject I grope for reasons to do it myself; and the reason I find I can stand up is that I think that Cape Elizabeth produces some of the best vegetables and probably has some of the highest value market produce raised by farmers in Cumberland County, and I think probably we produce better vegetables than they do in the town of Falmouth, where my confrere, Senator Snow, comes from.

Now with that strong background, I rise to the bait thrown out by the good Senator from Aroostook, Senator Harding, I may not be an authority on agriculture, but I have a memory, and my memory goes back to the 102nd Legislature. Some of us had the privilege of being in the minority party. It was not earth-shattering but it was educational. And I recall that the hand on the steering wheel of the steam-roller was the good Senator from Aroostook, Senator Harding. This I say in all good bantering, of course. However, I find now, in looking back to what we did in the 102nd Legislature, ladies and gentlemen, on this particular bill, believe me it was partisan politics and don't fool yourselves about it. He says that the Republican Governor signed the bill. Sure he signed it, and, very simply, because of the lopsided majority in the House and the Senate.

I strongly support the motion. I think the bill is a good bill

and I think it should not be indefinitely postponed, but let's not delude ourselves that politics is not involved.

Mr. WYMAN of Washington: Mr. President and members of the Senate: It seems to me it is very simple. We talk a lot about the people, your taxes, and what they want. Your Taxation Committee heard this bill, and agricultural interests were practically one hundred per cent in favor of it. We had the Farm Bureau representative speaking, we had the Maine Pomological Society and we had representative of the Maine Dairymen, and, while I do not have it in my notes, I think we had a representative from the Maine Potato Growers. It seems to me it is just that simple: This is what agricultural people want and I can see no reason why we should not give it to them.

HARDING of Aroostook: Mr. President, I feel compelled to respond very briefly to the remarks of the good Senator from Cumberland, Senator Berry, and the good Senator from Washington, Senator Wyman. First of all, I would say that so far as Senator Berry is concerned in his remarks that this is a partisan measure, I would call to his attention the fact that the Democratic Party did not have a two-thirds majority last time in the House, and every single bill which the Governor vetoed his veto was sustained. It was his judgment that this was good bill when the law was changed and that is why he signed it. If he thought it was a bad bill he certainly would have vetoed it as he did all of the other bills which he vetoed. And so far as the remarks of the good Senator from Washington, Senator Wyman, as to what the farmers want. I can tell the members of this body that I have not received a single letter or a single call from a single farmer saying that he is in favor of this particular bill. I talked to some farmers about it and I did not detect any enthusiasm for this change. I hope, therefore, that the Senate will go along with the motion to indefinitely postpone this bill.

Mr. FARLEY of York: Mr. President, through the Chair, I would like to ask a question. I might have got him wrong, but did Senator Wyman say we heard this through the Taxation Committee?

The PRESIDENT: I will answer for the Senator. I am sure that is what he said, but he didn't mean that, because he too is a member of State Government.

Mr. FARLEY: And so am I.

While I am standing here, I might just as well say a few They have been talking words. They have been talking about there being no politics in it. Will somebody show me, between these two buildings, where that fellow who talks politics has gone to? I hear it day in and day out. And, while I am standing, I will say that I think the Democrats did a favor to the majority members of this Senate two years ago when they appointed the Commissioner of Agriculture. If you will remember, the majority of those who were elected never had their certificate of election from the Governor or the Secretary of State. I think myself that we as Democrats performed a favor to you because a great many who were here the night before I would think were here illegally.

Mr. STERN of Penobscot: I just want to go on record as supporting Senator Snow's motion to indefinitely postpone this particular bill. I will not go into a long argument as to my reasons for it because if I ever saw a hanging jury — and I have been trying cases for 33 years — I am looking right at them now. So I just want to go on record that I am supporting the motion but I am not going to argue on it.

Mr. ANDERSON of Hancock: Mr. President and members of the Senate, there seems to be a constant whittling away of the constitutional rights of the people, a constant whittling away of the powers of the legislature as set up in the Constitution. I certainly hope that the motion to indefinitely postpone does not prevail.

Mr. CURTIS of Penobscot: Mr. President, I might give a little bit of background, because you

may associate me with a different type of work than agriculture.

I graduated from Freeport High School, I was a leader in 4-H Clubs in high school; I competed contests; I attended the University of Maine, graduated from Agriculture, majored in Dairying; I later taught at the academy, taught agriculture full time, under the Smith-Hewes Act, later teaching at Caribou High School in Caribou: Farmers Chapter of America. During World War II I had charge of Victory Farm Volunteers of the State of Maine, taking boys out of the cities and putting them on Maine farms. I would like to say that agriculture is in my heart. I feel I am a representative of the people; I feel that in teaching and coaching agricultural courses that I became acquainted with the farmers, that understood their needs, and I felt sincerely indebted to them. I feel at this time, with agriculture being a hard program for the owners of farms and many people have gone out of the agricultural business due to the labor problems. long hours, no holidays. I could go on to speak of their problems but you all know them. I feel that this is one item that they would like to have as the bill calls for and not an indefinite postponement, and I feel I would not be doing my duty if I did not uphold their wishes. I definitely feel that they want this bill passed and not indefinitely postponed. Thank you.

The PRESIDENT: The pending question is on the motion of the Senator from Cumberland, Senator Snow, that this item be indefinitely postponed. The Senator from Aroostook, Senator Barnes, has asked that when the vote be taken it be taken by a division. As many as are in favor of the motion to indefinitely postpone this bill will rise and stand in their places until counted; those opposed.

A division was had.

22 having voted in the negative and 9 in the affirmative the motion to indefinitely postpone did not prevail. Thereupon the bill was passed to be engrossed.

The President laid before the Senate the second tabled and today assigned matter (H. P. 37) (L. D. 57) House Reports from the Committee on Legal Affairs on Bill. "An Act Relating to Citizenship Requirement for Municipal Assessors. Majority Report, Ought to Pass with Committee Amendment "A" Filing H-10; Minority Report, Ought Not to Tabled February 14 by Senator Good of Cumberland pending acceptance of either report.

Mr. GOOD of Cumberland: Mr. President and Members of the Senate, I move that the Senate accept the Majority Ought to Pass report. This is an amendment to the law having to do with the election or the appointment of assessors of town and cities. This is permissive legislation. This does not compel a city or a town to do anything. It simply gives them a wider scope of authority in the selection of their assessors in the towns or the cities. It doesn't take anything away from the towns or from the cities. It adds to their ability to obtain qualified assessors. The section of the law that it amends is Title 30, Section 2060, Subsection III which states, and I quote: "Qualifications, In order to hold a municipal office, a person must be a citizen of the United States, a resident of the state, and at least 21 years of age." Now. apparently under the law, the only one that is required to be a voter of the town even, is a selectman because Subsection IIIA states, and I quote: "In order to hold the office of a selectman, a person must be a voter in the town in which he is elected."

Now, in some communities, the assessor is appointed, and in a lot of the cities the charter permits the city to appoint the assessor. In most towns as you know, the selectmen act as assessors. Under this proposed change in the law, if a selectman is also an assessor, then this assessor and selectman would have to be a citizen of the United States. Coming to the essence of this amendment, it is this, that in order to be an assessor, it is not necessary that he be a citizen of the United States. That's what this particular bill does, but he still has to be a resident of the United States and he still has to be age 21.

Prior to 1957 there was no requirement that an assessor be a citizen of the United States and this country somehow or other survived, and this simply reverts back to 1957. It is no longer necessary that an assessor be a citizen of the United States.

Apparently there is a lack of qualified assessors in the state. For instance, the City of Bath has been hiring qualified assessors who were schooled in the University of New Brunswick, and they valued their services highly, but they discovered that under the law that they had to be citizens of the United States so they had to let them go. Bath would like to use these qualified, trained assessors and that is the reason for the bill, and other municipalities would also like to use qualified assessors who were trained in that type of work.

The reason we reported this bill out with the majority Ought to Pass, there were several reasons. First of all, one, we felt that the state should make use of qualified professional men to help us progress wherever they are available, whether from Massachusetts, or Connecticut or from Canada. Two, we felt that it was a good neighbor policy with Canada to welcome their qualified people into the state and to work here in cooperation with the state.

If we don't pass this bill, you are going to deprive some of your municipalities of the use of this qualified professional help.

This bill was supported by the State Tax Assessor, Ernest Johnson, and finally, we have a letter here from the Attorney General's office signed by Jon R. Doyle, and I will read two paragraphs in part. The first paragraph, "My research indicates that the requirements of citizenship has only been present in the law since 1957 when there was undertaken a general revision of the law relating to municipalities." In another paragraph, "It is safe to assume that there is no Constitutional requirement requiring tax assessors to

be citizens. On the other hand, there seems to be no reason available for the insertion of the requirement in 1957—that tax assesors be Unied States citizens. In all probability the provision concerning citizenship was copied from some uniform provision available to draftsmen of the Legislature." Thank you.

The PRESIDENT: The Senator from Cumberland, Senator Good moves that the Senate accept the amended Ought to Pass report of the committee in non-concurrence. Is this the pleasure of the Senate.

The Majority Ought to Pass report of the committee was accepted in non-concurrence. The Bill was read the first time. Committee Amendment "A" was read and adopted, and the Bill assigned for second reading the next legislative day.

On motion by Mr. Johnson of Somerset the Senate voted to take from the tabled the fourth tabled and unassigned matter (S. P. 315) Bill, "An Act Relating to Compensating Counsel for Indigents Ac-

cused of Crime," Tabled February 14, 1967 by the same Senator pending reference.

On further motion by the same Senator, the Bill was referred to the Committee on Judiciary. Sent down for concurrence.

On motion by Mr. Young of Hancock the Senate voted to take from the table the first tabled and unassigned matter (H. P. 456) (L. D. 670) Bill, "An Act Relating to Regulations Regarding Atlantic Sea Run Salmon." Tabled February 9 by the same Senator pending reference.

On further motion by the same Senator, the Bill was referred jointly to the Committee on Sea and Shore Fisheries and Inland Fisheries and Game in nonconcurrence and sent down for concurrence.

On motion by Mr. Ross of Piscataquis,

Adjourned until 1:00 p.m. tomorrow afternoon.
