Mr. KATZ of Kennebec: Mr. President, may I inquire if L. D. 107, Bill, "An Act to Clarify State Aid for School Construction Purposes and Borrowing in Anticipation Thereof", is in the possession of the Senate?

The PRESIDENT: The Chair will advise the Senator that this item is in the possession of the Senate, having been requested to be held by the Senator.

On motion by Senator Katz, the Senate voted to reconsider its action whereby it adopted House Amendment "A". The same Senator offered Senate Amendment "A" to House Amendment "A" and moved its adoption. Senate Amendment to House Amendment "A" was read by the Secretary as follows:

SENATE AMENDMENT "A" to HOUSE AMENDMENT "A" to S. P. 63, L. D. 107, Bill, "An Act to Clarify State Aid for School Construction Purposes and Borrowing in Anticipation Thereof."

Amend said Amendment by striking out all of the first paragraph.

Further amend said Amendment by striking out in the 6th line the words "Further amend" and inserting in place thereof the word 'Amend'

Mr. FERGUSON of Oxford: Mr. President, I would like to pose a question to the Senator from Kennebec, Senator Katz, what does the adoption of Senate Amendment "A" mean and what are we accomplishing by not accepting House Amendment "A". I would like to have him give me an explanation.

The PRESIDENT: The Senator from Oxford, Senator Ferguson, poses a question through the Chair to the Senator from Kennebec, Senator Katz, who may answer it has an desires

if he so desires.

Mr. KATZ of Kennebec: Mr. President, it merely changes the intent to say "Amend" as a single amendment rather than "further amend", which would give the impression there is more than one amendment.

Mr. GOOD of Cumberland: Mr. President, I move that the bill be tabled pending the adoption of Senate Amendment "A" to House Amendment "A".

The PRESIDENT: The Senator from Cumberland, Senator Good, moves that we now table L. D. 107, pending the motion of the Senator from Kennebec, Senator Katz, that the Senate adopt Senate Amendment "A" to House Amendment "A".

Mr. KATZ of Kennebec: Mr. President, I would like to debate the time of tabling and express a sense of urgency and ask through the Chair whether the Senator would assign a specific date on his tabling motion.

The PRESIDENT: Would the Senator from Cumberland, Senator Good, care to specially assign the item?

Mr. GOOD: Mr. President, I would be willing to assign it for Tuesday, March 21.

Mr. BERRY of Cumberland: Mr. President, I move this item lay on the table until tomorrow.

The PRESIDENT: The pending motion before the Senate is the motion of the Senator from Cumberland, Senator Berry, that this item now be tabled until Fri-

day, March 17th. Is this the pleasure of the Senate?

As many as are in favor of the motion that this item be tabled until tomorrow will say aye; those opposed nay.

Mr. GOOD: Mr. President, I have no objection to it being tabled until tomorrow.

The PRESIDENT: As many as are in favor of tabling this item until tomorrow, March 17th will say aye; those opposed nay.

A viva voce vote being taken, the motion prevailed and the bill was tabled and specially assigned for March 17th.

Mr. KATZ of Kennebec: Mr. President, may I inquire if the Senate is in possession of L. D. 297, Bill, "An Act Relating to Conveyance of Secondary Pupils."

The PRESIDENT: The Chair will reply in the affirmative, this item having been held at the request of the Senator from Kennebec, Senator Katz.

On motion by Mr. Katz, the Senate voted to reconsider its action whereby the bill was passed to be engrossed. On further motion by the same Senator, the Senate voted to reconsider its action whereby it adopted House Amendment "A".

Mr. KATZ: I move that House Amendment "A" be indefinitely postponed.

The PRESIDENT: The Chair would advise the Senator that the motion to reconsider has the same effect as a motion to indefinitely postpone.

Mr. KATZ; Mr. President, I offer Senate Amendment "A" and move its adoption.

Senate Amendment "A" was read by the Secretary as follows:

SENATE AMENDMENT "A" to H. P. 183, L. D. 297, Bill, "An Act Relating to Conveyance of Secondary Pupils."

Amend said Bill by adding before the period in the 12th line (9th line of L. D. 297) the following:

"except that any municipality with a total population exceeding 10,000 residents in the latest Federal Census shall not be required

## to furnish secondary school transportation'

Mrs. SPROUL of Lincoln: Mr. President, I wonder if Senator Katz will explain to me just what this bill does, with the Senate Amendment.

The PRESIDENT: The Senator from Lincoln, Senator Sproul, poses a question through the Chair to the Senator from Kennebec, Senator Katz, who may answer if he so desires.

Mr. KATZ of Kennebec: President, the adoption of this amendment will put us in the same position that I thought we were in the other day, yesterday, when it was passed to be engrossed. In the attempt to make sure that no youngsters in the State are forced to drop out of school because of lack of availability of transportation, amendment takes awareness of the fact that in the cities there is public transportation available, and probably the problem is not as acute as it is in the areas without public transportation.

Mrs. SPROUL of Lincoln: Mr. President, I had in mind vesterday to keep quiet on this because I knew that the House was opposed to the bill. However, I wish to say that I am very definitely opposed to this bill, not because I don't recognize the problem as far as transportation goes, but there are some towns which are sending pupils to several different schools and the financial problem is just tremendous. In this particular case I speak not only for my own town, but there are several other towns, and there are others in my own county. And they find that they must send pupils - I understand that in South China to eight or ten different schools. I do oppose this bill, and I would move that it be indefinitely postponed.

The PRESIDENT: The Senator from Lincoln, Senator Sproul, moves that we indefinitely postpone L. D. 297, "An Act Relating to Conveyance of Secondary Pupils." The Chair recognizes the Senator from Cumberland, Senator Snow.

Mr. SNOW: Mr. President and Members of the Senate, I rise in opposition to the motion of Senator Sproul. I would like to speak briefly, if I may. Under the proposed legislation, all towns and communities excepting those which are excluded by Senator Katz's amendment, which are the cities and towns with a population of over 20,000, would be required to provide transportation for their secondary school pupils. This is already a requirement of law for school districts. It was the feeling of a majority of the Education Committee that it should apply equally to all communities throughout the state.

Now, in specific answer to Senator Sproul, I would like to note that it is our understanding of the law that a school which is sending pupils to school on a tuition basis, or on some other basis, to several communities may elect to transport those pupils to only one of the communities. In other words, if a town is sending pupils to four or five different academies or other schools, from the town, it does not need to provide transportation to all of them but may only furnish transportation to one of them by vote of the town.

When the Senate acts on this motion, I would ask for a division.

Mrs. SPROUL of Lincoln: Mr. President, I think I am within my rights — I asked a question and perhaps I am speaking twice on this matter.

What the gentleman from Cumberland said sounds very good and it looks fine on the face of it, but some of us are in a position where we have heated school questions and we do not dare contract with any particular place; one wants to go here and another wants to go there, and we never will solve it. I still say, in spite of what Senator Snow says, that we cannot contract with any particular place; some of us do not want to contract with any particular place, and I, for the life of me, do not know how we can go along with this particular bill, and therefore I still hope it will be indefinitely postponed.

Mr. FARLEY of York: Mr. President, when the vote is taken I am going to vote with the Senator

from Lincoln, Senator Sproul. We have a situation in the City of Biddeford which you all know. I am a graduate of the public schools in the City of Biddeford, and for years it was the system that the pupils in the smaller schools of the city were transported. Those of us who went to high school had to walk. I think the lady from Lincoln has got a very good motion.

Mr. FERGUSON of Oxford: Mr. President and members of the Senate: I too must oppose the motion of the good Senator from Lincoln. Senator Sproul, I think this is legislation we should have had years ago. In my own case. I was a little bit reluctant to offer such legislation in prior years because I had some of my own children that were transported to high school, and I felt that possibly it would be a direct benefit to myself, but now my children are out of high school and I can see a real need for some students who would be denied the right to attend secondary schools on account of not having transportation or money to pay for the transportation.

It goes a little bit beyond the municipal officers to decide where these pupils should go, which school they should go to. The school boards in the various municipalities can decide whether or not half of the total tuition population should go to one school or to several. Certainly, I think this type of legislation is pretty well under control, and I hope that when the vote is taken it will be in opposition to the motion of Senator Sproul to indefinitely postpone.

Mr. HOFFSES of Knox: Mr. President and members of the Senate: Like Senator Ferguson, my children are all beyond school age, but I am now speaking for the school district which is in my own and neighboring towns. They have requested me to oppose this bill and to support the Senator from Lincoln in her motion indefinitely postpone the bill. They feel that the relationship is quite adequate now and that to force such a piece of legislation could very well create a hardship on the School Administrative Districts which do have a very affable and friendly atmosphere as far as transportation of children.

Mr. KATZ of Kennebec: Mr President, several years ago a study was made as to the reasons why Maine pupils drop out of school, and one of the significant things that was found was that some kids drop out of school because they do not have any way of getting to school, particularly in the rural areas. Now I would attach a brief label to this bill: I think you can call this bill an attempt to give equal opportunity to youngsters who are not in school administrative districts to get to school like the youngsters who are in school administrative districts. I think on the basis of equal opportunity this bill deserves our support, and I hope that the motion to indefinitely postpone is defeated.

Mr. ANDERSON of Hancock: Mr. President and members of the Senate: I must go along with the Senator from Lincoln, Senator Sproul. We have a similar situation to what she described in the little town of Surry, and if they had to buy busses to furnish transportation it would bankrupt the town. I believe that that town will soon be in a school administrative district. I do hope that we go along with the motion to indefinitely postpone.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Lincoln, Senator Sproul, that this bill be indefinitely postponed. The Senator from Cumberland, Senator Snow, has requested that a division be taken. As many as are in favor of the motion to indefinitely postpone the bill will rise and remain standing until counted; those opposed.

A division being had, 20 Senators voted in the affirmative and 12 in the negative and the motion to indefinitely postpone prevailed. Sent down for concurrence.

On further motion by that Senator, the Bill was passed to be engrossed and sent down for concurrence.
