Kennebec, Senator Katz.

Mr. KATZ of Kennebec: Mr. President, Ladies and Gentlemen: I think a brief word of explanation is in order because this bill was part of the Governor's program, This is an attempt to afford to Maine youngsters available loan money while attending the institutions of higher education. You will recall that earlier we passed a bill sponsored by Senator Ferguson for \$50,000 which sought to be a temporary stop-gap in the requirements to loan funds, but the Committee on Education has voted this out "Ought Not to Pass," but it will be followed very shortly with a complete and different approach to establishing a large revolving loan fund for Maine students to which I hope you will give your favorable consideration at that time.

The PRESIDENT: Is it now the pleasure of the Senate to accept the "Ought Not to Pass" report of the Committee?

Mr. MacLeod for the Committee on Education on Bill "An Act Relating to Public Policy on Higher Education." (S. P. 498) (L. D. 1259)

Reported that the same Ought to Pass As Amended by Committee Amendment "A" (S-94)

The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz:

Mr. KATZ of Kennebec: Mr. President and Ladies and Gentlemen: I call your attention specifically to this bill, because this is the first of four of the higher education bills you will be getting here this session. This one just puts into words a statement of public policy. I think that it will be a good guide for us in the years ahead. The amendment is a very brief amendment which reassures faculties of the institutions around the State that their historic privileges will be safeguarded.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Berry.

Mr. BERRY of Cumberland: Mr. President and Members of the Senate: I speak on this measure with a great deal of reluctance, and I do it from a feeling of necessity borne out by the testimony which the Appropriations Committee has heard this year and it has caused, I feel safe in saying, the concern of all the members of the Committee.

We have been faced this year with numerous financial problems which we have inherited from previous Legislatures. Many of these problems which we have inherited have been because insufficient funds have been provided to implement these programs.

I do not quarrel with the philosophy of this legislative document.

I am very wary of getting ourselves again more deeply into unknown financial expense. I am wholeheartedly behind the theory, but I am very concerned about the pitfalls ahead. I think we could debate this a great deal, but until I believe we are ready to put our money where our philosophy is we should not pass such legislation. Accordingly, Mr. President, I would move that this bill be indefinitely postponed.

The PRESIDDENT: The Senator from Cumberland, Senator Berry moves that this bill and its accompanying papers be indefinite-

ly postponed.

The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ of Kennebec: Mr. President and Ladies and Gentlemen: This is purely and simply a statement of State Code. I agree that many of us have misgivings about financial support of institutions. I would urge all of you to turn to L. D. 1259 presently before you, and refer to Paragraph 7 and Paragraph 8. It is in these two paragraphs - the number again is L. D. 1259, — that statements of financial support, 7, 8 and 9, are mentioned. There is no attempt to offer any structure here. Might I point out to you with some sense of urgency that the State of Maine is one of the very few states in the United States that has never gotten around to adopting some statement of public policy in the area of higher education. It suggests that we assign continuously a high priority in the allocation of public funds to provide opportunities for those who do not share equitably in the advantages of higher education because of limited economic, social, educational and cultural factors. This is one of the statements pertaining to finances.

Under Paragraph 8, "Financial Support," it suggests that we should support financially the programs of our public higher education institutions through appropriations, grants and loans based on comprehensive plans and budgets.

I suggest, Mr. President, and Ladies and Gentlemen, that if we are indeed concerned with economically spending our aducational dollars that L.D. 1259 spells out to future legislatures our intent that educational dollars be spent for the greatest possible good of the greatest possible number. I don't think it is an innocuous document; I think it is a very important document. But in so far as binding us to any particular structure, or any particular financial avenue, it just doesn't do that, I hope that you rise up and defeat handily the move for indefinite postponement.

The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator MacLeod.

Mr. MacLEOD of Penobscot: Mr. President and Members of the Senate: I believe it is well known that I do not favor spending money where it is not needed to be spent. I believe it is well known what my attitude was toward many of the studies that were made by the previous legislature.

This particular study I am referring to now which resulted in this document and the three accompanying documents that will be along later, cost the State of Maine around \$50,000. In my opinion, this was the best spent money for any study which was made by any legislature in recent history.

I am a little shocked and certainly surprised to hear the statements by the distinguished Senator from Cumberland, Senator Berry, this morning in reference to this bill and to the policies to which it pertains. For one thing, if we consolidate, which these bills ask us to do our public higher education facilities into one cohesive system, it will certainly result in savings in the long run and still offer quality education.

Last night in Bangor I spoke to a group of people which included about 35 high school and college youngsters. If you will pardon my making the same statement twice, I would like to read to you part of what I said. "The 103rd Legislature is proposing a c o mplete reorganization of our public higher education system which, if enacted, would consolidate all of our State educational institutions in one cohesive body. This will avoid waste, duplication of courses, and

still will retain the autonomy of each individual institution. It is a blueprint for progress. It will provide the necessary facilities for our young people seeking a higher education. It will be lowering costs and providing the same quality education as under our present system."

To substantiate my surprise at the motion of the Senator from Cumberland to indefinitely postpone this measure, I think of just one bill this Senator presented to the Legislature which calls for the expenditure of just under a million dollars for library facilities split up among five or six institutions in our State.

Under the proposed bills that this study came up with, which Senator Katz introduced to this Legislature, there would be quality library facilities, but no duplication, and the books available in one institution would be available at the other at the other institutions. The University of Maine, the State colleges teachers and the vocational schools would all benefit under the combined purchasing of library books, as just one item. And perhaps the bill which the Senator from Cumberland introduced for nearly a million dollars for library funds, it might be necessary to only have \$500,000 to do the same job.

It is high time that the State of Maine used its limited financial resources in the most feasible economical manner. It is my sincere conviction that this statement of policy as exemplified in L.D. 1259 will be the first step in this direction, and I hope the motion to indefinitely postpone will be overwhelmingly defeated. Thank you.

The PRESIDENT: Is the Senate ready for the question?

The Chair recognizes the Senator from Cumberland, Senator Berry.

Mr. BERRY of Cumberland: Mr. President and Members of the Senate: I refer to L.D. 1259, and I quote a few pertinent sections from it

Under I "Recognition: To recognize higher education as an organized program of instruction authorized" — just jump down a little bit — "which is administered

and systematically pursued on a full-time or part-time basis by persons who have completed secondary schools or who have demonstrated equivalent competence to appropriate means."

Now, we find ourselves at this present session of the 103rd Legislature faced with the exact same situation whereby legislation was passed by the 102nd saying that all qualified students can go to the University of Maine, and we find ourselves lacking several millions of dollars to implement that philosophy. I cite this to you, Members of the Senate, as one of the pitfalls of this legislation. I do not disagree with the philosophy that we need to combine. streamline and organize. I feel that I am safe in saying that probably no one realizes the need for this more than I do.

I am referring now to Section 8, Financial Support: "To support financially the programs of the public higher education institutions through appropriations," and so forth. We are morally committing ourselves here to a long-range, significant, expensive program, and a program on which even experts in the field of education cannot agree. I feel that this has not had enough study and this has not had the unanimous support of our leaders in education in the State of Maine. I exhort you to support my motion.

The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ of Kennebec: Mr. President and Ladies and Gentlemen: There will be subsequent controversies. L.D. 1258 is going to be one that I suspect is going to come in for its share of brickbats. But there is a humorous aspect to this, that if there is one piece of legislation that was presented before a completely critical audience in the hearing — the hearing was loaded with knowledgable people — if there is one piece of legislation that was accepted by all present, all present, and had minor modifications suggested by faculty members, it is this bill before us. There is no controversy attached to this one.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Snow.

Mr. SNOW of Cumberland: Mr. President and Members of the Senate: The motion of my colleague from Cumberland County, Senator Berry, comes as a surprise to me, and I would oppose it. I would note that this document sets forth what I believe are the aims of all of us. It does not commit us to a specific course. It does not commit us to any expenditure. But it does set forth for the future, as I said, the policy which I think we all believe in, in asking for more educational opportunities. It is asking for co-ordination in higher education. It is asking, if you will, for cooperation in education. Mr. President and Members of Senate, I hope that when this is voted upon that you will defeat the motion of the good Senator from Cumberland, Senator Berry, to indefinitely postpone this document, and I would ask that when the vote is taken it be taken by a division

The PRESIDENT: Is the Senate ready for the question? The pending question is on the motion of the Senator from Cumberland, Senator Berry, that we indefinitely postpone this bill and its accompanying papers.

As many as are in favor of the motion to indefinitely postpone will stand and remain standing until counted. As many as are opposed to the motion will stand and remain standing until counted.

A division was had. Eight Senators having voted in the affirmative, and 22 Senators having voted in the negative, the motion did not prevail. Thereupon, the Senate voted to accept the Ought to Pass Report of the Committee, and the Bill was given its first reading.
