HOUSE

Tuesday, February 25, 1969 The House met according to adjournment and was called to order by the Speaker.

WHEREAS, the inhabitants of Limestone now take note of this rich heritage and to commemorate the close of a century of continuing progressive development in the life at their community; now, therefore, be it

ORDERED, the Senate concurring, that the Senate and House of Representatives of the 104th Legislature of the State of Maine unite in congratulating the Town of Limestone for its excellent record of achievement on this its 100th anniversary and offer their continued support and encouragement for the future; and be it further

WHEREAS, the State of Maine is desirous of acquiring for future State House area expansion the land owned by the City of Augusta known as the Capitol Park Athletic Field; and

WHEREAS, the City of Augusta has been losing tax revenue through the continued expansion of the State House area and would welcome the addition of any unneeded land to its tax rolls; now, therefore, be it

ORDERED, the Senate concur-ring, that the Bureau of Public Improvements is directed to study the status of the state-owned land lying east of said Hospital Street, to consult with appropriate state departments and agencies to determine what portion of said land should be set aside for future state use, to consult with the mayor and council of the City of Augusta and planning commission of said city and recommend a plan to the Legislature for the orderly disposal of so much of said land as may not be needed by the State in the foreseeable future together with а draft of implementing legislation, including such restrictions as may be appropriate in the use of said land, said plan and draft to be submitted to the Legislature not later than May 1, 1969. The SPEAKER: The Chair recognizes the gentleman from Kennebunk, Mr. Crosby,

Mr. CROSBY: Mr. Speaker and Members of the House: I move the acceptance of the Minority "Ought to pass" Report and would speak briefly to my motion.

The SPEAKER: The gentleman Kennebunk. Mr. Crosby. from moves that the House accept the Minority "Ought to pass" Report. The gentleman may proceed.

Mr. CROSBY: Mr. Speaker and and Gentlemen of Ladies the House: There seems to be some confusion about the election of a moderator for town meetings. Some towns are electing them for a year, others are not.

Ι will admit that this was brought up due to a situation that exists in our own home town where we have had several town meetings in the course of a year brought on by voting for a school district, appropriation of money-I think we have had five so far. It was the feeling that if a moderator could be elected at the annual town meeting to serve for the ensuing year it would expedite matters, would save the town a lot of money. They would not have to hire clerks, ballot clerks, at each town meeting, call a special town meeting, and the meeting could proceed on time. We have had situations where it has taken three hours to elect a moderator. I realize that this is unusual, but it certainly could be very beneficial to some of the smaller towns, I am sure.

The SPEAKER: The Chair recognizes the gentlewoman from Orrington, Mrs. Baker.

Mrs. BAKER: Mr. Speaker and Members of the House: I would call attention of the members of the House to the report nine to one and simply say that we had quite a bit of trouble with the wording of this bill and we had an amendment prepared by the Attorney General's office, and we still did not feel that we could go along with that. It is a rather delicate matter, the election of a moderator, and many matters hinge on it. One would be the assessment of taxes.

So therefore I move for a division at this time.

The SPEAKER: Is the House ready for the question? The pending question is on the motion of the gentleman from Kennebunk, Mr. Crosby that the House accept the Minority "Ought to pass" Report. All those in favor of accepting the Minority Report will vote yes; those opposed will vote no. The Chair opens the vote.

The SPEAKER: The Chair recognizes the gentleman from Bath, Mr. Ross.

Mr. ROSS: Mr. Speaker and Ladies and Gentlemen of the House: I am not going to join one of those who table things this morning. I present to this bill House Amendment "A" under Filing H-58, move its adoption, and will speak to it.

House Amendment "A" (H-58) was read by the Clerk.

The SPEAKER: The Chair recognizes the same gentleman.

Mr. ROSS: Mr. Speaker and Ladies and Gentlemen of the House: Basically, some of you heard in my non-debate remarks last Thursday that I favor the size of the House the way it is. However, there are some persons who are really serious about cutting it. They maintain it would give more equal representation; that it would be a cost saving; that it would be a chance to increase salaries to where perhaps they should be; there would be an opportunity to provide for proper legislative staff, that it would be more efficient. Most of these things I do not believe.

However, for the benefit of those who do, I say let's go one step further. Several of us have had experience in the other body at the end of the corridor. They do a very fine job down there with thirtytwo members. I believe that perhaps we could do just as good a job, and so let's legislate ourselves their equal.

The SPEAKER: The pending question is the adoption of House Amendment "A." The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker and Members of the House: When I thought I was of voting age, the way that we would attack a unanimous report in order to defeat it was by saying, present an amendment excepting our individual counties from the measure. This is a boy's version, and I move the indefinite postponement of this amendment because I would like to hear debate on the bill itself as it was reported out of the Committee unanimously.

The SPEAKER: The Chair recognizes the gentleman from Bridgewater, Mr. Finemore.

Mr. FINEMORE: Mr Speaker and Members of the House: I would like to move for indefinite postponement of the whole bill and I would like to speak on it.

The SPEAKER: The Chair would advise the gentleman that the only matter before the House now is House Amendment "A," and the gentleman may proceed if he wishes to debate House Amendment "A."

The pending question is the motion of the gentleman from Lewiston, Mr. Jalbert, that House Amendment "A" be indefinitely postponed. Is the House ready for the question? All those in favor of the indefinite postponement of House Amendment "A" will say yes, those opposed, say no.

A viva voce vote being taken, the motion did prevail.

Mr. Stillings of Berwick offered House Amendment "B" and moved its adoption.

House Amendment "B" (H-59) was read by the Clerk.

The SPEAKER: The Chair recognizes the gentleman from Berwick, Mr. Stillings.

Mr. STILLINGS: Mr. Speaker, Ladies and Gentlemen of the House: I noted as I read and listened to some of the comments on this bill last week the statement was made that this proposal to reduce the size of our House of Representatives would bring us closer to "average".

Now I don't think there is anything wonderful about this — being average simply makes you the best of the worst and the worst of the best.

I see nothing wrong with the size of the House remaining at its present strength of 151 members. This number brings us close to the people and makes us more responsive to them, and our State does cover a large geographic area; if we want to change oursize, let's do it in keeping with the motto of our great State — I Lead!

Our neighbor to the west, New Hampshire, now enjoys the distinction of having the largest lower branch of any of our state legislatures. It also has no sales tax. They refuse to even think about an income tax. Until recently it was the only state with a lottery. Sunday sales of spirits are allowed, And I am told that our people go there in great numbers to purchase liquor and cigarettes at a lower price.

I think it is now time for Maine to do something to get an edge on New Hampshire. Since their lower house has 400 members, I propose that the size of this house be increased to 401, which will mean that not only will we have surpassed our sister state in this regard, but Maine will have the signal honor of leading the nation with the largest lower house of any state legislature.

On motion of Mr. Jalbert of Lewiston, House Amendment "B" (H-59) was indefinitely postponed on a viva voce vote.

The SPEAKER: The Chair recognizes the gentleman from Bath, Mr. Ross.

Mr. ROSS: Mr. Speaker, now we get to the crux of the matter,

Twelve years ago I was the House Chairman of the State Government Committee. I had a great deal of respect for that Committee then and I do now. The Chairman. Mr. Dennett, is astute, capable and conscientious, but aside from these qualities, he is one of our most eloquent orators. He is truly a satirical rhetorician, whose verbosity emits the ultimate in exuberance. I hold in esteem the rest of the members of this august group. One is my seatmate from across the aisle, the competent and knowledgeable gentleman from Manchester, Mr. Rideout, One is even a colleague and friend of mine who lives only a few houses from me on the same street in that famous place which is steeped in antiquity, the delightful City of Bath, Miss Watson.

Yes, normally I would trust a unanimous committee report from this august group. However, this time, I believe that they had a slight lapse of memory. Our 151 member House is neither excessive nor ungainly. We, although we are the largest state in the New England states by far, our House is smaller than all of the others by an average of 100 persons. No one has proved that this House is hard to control. As a matter of fact, we have a national reputation of having one of the best run Houses with the highest degree of decorum in the entire Country, and of this we should be justifiably proud.

Any cut would be depriving our citizens the true representation to which they surely are entitled. In my opinion, changes like this are not progressive, but just making change for change sake.

I now move that this bill and all its accompanying papers be indefinitely postponed and request a division.

The SPEAKER: The gentleman from Bath, Mr. Ross, now moves that L. D. 464 be indefinitely postponed.

The Chair recognizes the gentleman from Madawaska, Mr. Levesque.

Mr. LEVESQUE: Mr. Speaker and Ladies and Gentlemen of the House: I think this morning you have one of the more unique pieces

of legislation coming before this branch that has been recommended not necessarily the same number represented in this group, but_as a cross section of our country. For at least the last ten years Nation-al Legislative Research groups throughout the country have recommended in a lot of instances the reduction of branches of the Legislature because of a better system of being able to operate with; and I can also remember in the last six years the National Leadership Conferences have predominantly recommended that the branches of the Legislature, both the House and the Senate, reduce to a workable siz so that as the gentleman from Bath, Mr. Ross has pointed out, better staff, better equipment, better groups to work with, and also a more equitable working salary.

I think if for no other reason other than that, as the theme that was used in the not too distant future, or not too distant past, and it might be used again in the future I might add, I think it is very well time for a change not only for the sake of changing but for the sake of better government to our own people. And I think by reducing the number of House as a matter of fact I have a bill in Mr. Slosberg's office to reduce the House to a seventy-five membership and to the other branch twenty-five, which would be a twothirds comparison, but I am willing to drop that bill in the Research Department if we can agree that this number ninety-six will be favorable by both branches of the Legislature. I think ninety-six will be a good working group and I hope that each member of this House here will take this, the recommendation of the National Research Council, the National Leadership Conferences who for years have been advocating the reduction of legislative groups.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker and Members of the House: I share with the gentleman from Bath, the same feelings that he has, although on not such eloquence of vocabulary toward the gentleman from Kittery, Mr. Dennett.

Also, this as I stated before, was the unanimous report of the committee and certainly we should hear from the people who are on that committee. However, I would like mostly to hear from the gentleman from Kittery, Mr. Dennett. Also, this is a very important piece of legislation, and for that reason, noting that the gentleman is not present, certainly because of the storm, I would hope that some member would table this measure until tomorrow.

Thereupon, on motion of Mr. Rideout of Manchester, tabled pending the motion of Mr. Ross of Bath to indefinitely postpone the Resolve, and specially assigned for tomorrow.

ORDERED, the Senate concurring, that the members of the 104th Legislature commend the Centennial Committee of the Town of Madawaska and especially, Mrs. Julie Albert, editor of the magnificent memorial publication; and be it further

ORDERED, that the members send their greetings and congratulations to the Town of Madawaska on the occasion of its 100th birthday; and be it further

ORDERED, that duly authenticated copies of this Joint Order be immediately transmitted to Mrs. Julie Albert, to the chairman of the Centennial Committee, and to the citizens of the Town of Madawaska through the Town Manager, (H. P. 793)

The SPEAKER: The Chair recognizes the same gentleman.

Mr. LEVESQUE: Mr. Speaker and Ladies of Gentlemen of the House: Thank you for allowing me to take these few minutes of your time this morning to show you or indicate to the members of this House the Centennial booklet that the Town of Madawaska has compiled and put into circulation. I was able to work with the Chamber of Commerce in getting sufficient copies to be distributed to the members of the House and the Senate, and of course I extend my most sincere thanks to the Chamber of Commerce and Mr. Delmar Doody, its President, for giving me this number of booklets to be distributed here in the State Capitol.

Now I think this circulation is unique in its printing, and I hope that every member of the House and the Senate will have a chance to briefly look through it. It is unique in this way, that the expressions used have been a carry-over for at least a hundred years.

Now in the book might be indicated the first settlers in the area and also how they got there through Grand Falls, New Brunswick, Canada, because of their thought that they may not be pushed any further because of the means of communication and travel was by water, and the falls was a natural obstacle.

Now I think probably a brief explanation of what's on the title of the book, the expression of the lady on the cover which you see in the newspaper "Deja cent ans!" is unique in expression on the face of the lady, which means already a hundred years. Now under that the explanation of the wording is: To better know the past, is to better live the future. Now there are other unique expressions in the book that I hope you will enjoy, and certainly the Town of Madawaska since its incorporation February 24, 1869, is promoting the Town, is promoting its history and of which we are very proud of. The indication in the book of the historical back-ground and in some instances some of Longfellow's poem, the Evangeline's quotes have been taken, very well compiled, and I think probably with very sincere appreciation by the community to Mrs. Julie Albert who compiled the information, certainly stands to be commended for her work.

Now as indicated also in the book, the community is ninety-two per cent French Catholic or French Acadian, and I would assume that—and this is a note that I had jotted down here, from a would-be member of the other branch, that ninety-two per cent of the population also voted of one political party, of which I will not mention, although the voter registration indicates otherwise. So we hope from Madawaska that you people will have a moment to briefly review the book and look at it. We think it is a very unique booklet and that the information will be beneficial to one and all. Thank you.

Thereupon, the Joint Order received passage and was sent up for concurrence.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Cottrell.

Mr. COTTRELL: Mr. Speaker and Members of the House: In tabling this bill last week, I understood that there was an appropriation of \$12,000 annually, but over the weekend I found out that it is simply permissive legislation, and within the department there are funds; they may spend these funds according to the purpose of the bill, and so I suggest that we support the passage to be enacted.

Thereupon, the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

The Chair laid before the House the fifth tabled and today assigned matter:

Mr. Dyar of Strong was granted unanimous consent to address the House.

Mr. DYAR: Mr. Speaker, Ladies and Gentlemen of the House: This morning I rise to defend my constitutents and my County, Franklin, on its jail situation.

Last week the newspapers in the State and the television stations carried articles pertaining to the Franklin County Jail: "Prisoners are kept under extremely poor conditions in some of Maine's jails and the Franklin County Jail is the worst of the lot, a spokesman for the State Mental Health and Corrections Department said. If the department had the authority it probably would order the Franklin County jail in Farmington closed."

This past Sunday, February 23 I inspected the County Jail. Sheriff Kenneth French accompanied me throughout the entire facility. I paid particular notice to the sanitary conditions of the jail, for cleanliness, as I expected from the accounts given that there would be various types of vermin skittering throughout the interior. I found the individual cells and cell blocks to be well painted and clean. The mattresses and bedding were in much better shape than some that I had been personally issued while in the service of the United States Army. The bunks are made of welded steel strapping, and the Sheriff informed me that they were to be bolted to the floor in the very near future. He showed me where two prisoners had recently taken their beds and banged them against the wall causing considerable damage to the walls. At 10:00 in the morning four prisoners were still in bed which in itself should testify to the fact that the comfort af-forded could not be condemned.

The Sheriff explained that it was the policy for the prisoners to be up at 7:00 a.m., make their beds, and then if it was their pleasure, they could lie down, but he could not force them out. One prisoner was on a self-imposed fast for the past three weeks refusing to eat for that period of time, hoping to be hospitalized and add to the expense of his imprisonment.

I was shown the financial records of the jail and the proposed budget for the coming biennium. Sheriff French had received a letter from the wife of a former prisoner who was indicted for murder and is now spending time in the Maine State Prison. This letter thanked the Sheriff's Department of Franklin County for the courtesy extended the prisoner and it also stated that he received better treatment and better facilities and had been far happier while in the Franklin County jail than he was at the Augusta State Hos-

pital or finally at Thomaston. It is evident that certain groups feel that prisoners should be coddled and receive extensive privileges while serving their sentences. I, perhaps, may represent a minority, but feel that a person is sentenced to an institution for committing a crime and is in jail to pay his debt to society. It is also obvious that many of our prisoners are receiving better and more wholesome food and are in cleaner surroundings than that in many of their own homes.

In closing, I would like to read a paragraph from a letter that I received yesterday from the Reverend Robert Gale, Pastor of the Henderson Memorial Church: "If the Legislature or the State Mental Health and Correction Department is really interested in the rehabilitation of lives, then let money be provided for the remodeling of the physical plants of the county jails in which there is a greater potential for the rehabilitation of the first and minor offender." Thank you.

Jutras Mr. of Sanford was granted unanimous consent to address the House.

Mr. JUTRAS: Mr. Speaker, this House is known to operate with a lot of decorum and whenever any unfavorable comments are made, I believe that necessary action is quickly taken to correct a situation, an undesirable situation.

This morning, one member of this House made an unfavorable reference and an unfavorable comparison between beds in his County jail and those issued by one branch of the service, particularly the United States Army, I think had he left that as a general statement, it probaby would have gone over, but to single out one particular service to say that the beds issued by the United States Army did not even compare with those, I believe is out of order and should be stricken from the record.

Mr. Cottrell of Portland was granted unanimous consent to address the House.

Mr. COTTRELL: Mr. Speaker and Members of the House: This is simply to correct an error in printing on L. D. 803, An Act Providing for a State Income Tax. It is a long document, twenty pages, and I don't think it is necessary for each member to read all of it, but they certainly should read the graduated schedule of taxation on different levels of income on page 3, and on page 20 the statement of fact, which says that it is estimated that this act will produce \$12,000,000 in revenue to the State.

Now on the basis of 78,296 individual tax returns received at the Internal Revenue office, it is estimated now that the schedule of taxation, the graduated schedule, will produce \$20,000,000 annually. That is a very important change from the \$12,000,000. Thank you very much.
