Comes from the House, Indefinitely Postponed, in non-concurrence.

The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Speers.

Mr. SPEERS: Mr. President, it is very unfortunate that this Joint Order has been returned to this Body in non-concurrence. The attempt on the part of the Legislative Council in introducing this Order was to provide for a central point

at which Legislative expenses would be authorized. This Joint Order would require the authorization of the Legislative Director, Administrative Director before expenses could be incurred on behalf of either the House of Representatives, the other Branch, or the Senate, of the State Legislature.

It seemed to be imminent good sense to have one source for approval of Legislative expenses, because, as we note at the present time with both Branches simply going their own way, expending for their equipment and supplies, etc., there is no way to control the amount of expenses and the amount of purchases that are taking place at the present time.

You will note that there is a second Joint Order on the calendar, Item 1-2, which differs from the first one in the respect that the first provides that at any time such purchases shall be made shall be with the acquiscence of the Legislative Director, and the second Order requires that only in the interim when we are not in Session, shall such purchase be made with the acquiescence of the Legislative Director. The second Order is an improvement over no order whatever, but it is rather inconsequential, because most of the major purchases that are made for the Legislature are made while the Legislature is actually in session.

The other branch saw fit to pass an Order on its own to provide that any of the purchases for the other branch may be made with the approval of the Speaker while they are in Session, and I will be presenting an Order to provide that the Secretary of the Senate may purchase such services, supplies and equipment as may be needed to carry on the business of the Senate while we are in session. This arrangement is not my preference. I would have preferred to have had both branches needing the acquiescence of the Legislative Director, because, as you know, the budget comes out of one single fund. Unfortunately, we have gone a step in the direction of having a separate budget for each of the two branches of this Legislature by rejecting this first order and adopting the second and the individual House and Senate Orders

So, Mr. President, it is with reluctance that I move that we now recede and concur with the

House.

On motion of Senator Speers of Kennebec, The Senate receded and concurred.

sion, purchases of equipment by the Clerk of the House or the Secretary of the Senate shall be subject to the approval of the Legislative Administration Director. (H. P. 251)
