Mr. COLLINS: Mr. President, this is perhaps an occasion that will not be duplicated for many of us, and because it is an historic experience, and because we have today for the State of

and because we have today for the State of
Maine an unusual opportunity, I do want to say
just a word about the nomination of Vincent
McKusick to be Chief Justice of our State.

Educated in the public schools of Piscataquis
County, Bates College, MIT, Harvard Law
School, President of the Harvard Law Review,
Clark to Judge Learned Hand Clark to Supreme Clerk to Judge Learned Hand, Clerk to Supreme Court Justice Felix Frankfurter, with academic honors too numerous to count. I knew Vincent McKusick best as Chairman of the Committee on the Rules of Civil Procedure, set up under the leadership of the late Chief Justice Robert Williamson to rewrite Maine Practice in the

Courts. Serving on that Committee for 10 years, I had the first hand opportunity to know the strengths of Vincent McKusick's intellect, and his ability to work constructively with a group

During the extensive hearing that we held on this nomination, the nominee was asked at one point how he, who has represented the rich, the powerful, the establishment of Maine as it were, could possibly represent all of the people of the State of Maine and address the basic needs and concerns of all Maine citizens regardless of their stake in life, and regardless of their status in wealth in our existing society. Mr. McKusick responded in a way that I feel I must make a part of our record today. He said in part, "The responsibilities of the job are sobering, and indeed I hope I am up to the job. Let me make two comments on that. I grew up on a dairy farm up in Piscataquis County during the depression of the 30's, and my twin brother and I did a full day of farm chores before and after going to school. I worked my way through Bates. I went to MIT and Harvard Law School principally because of the beneficence of the GI Bill, and I have always considered myself one of the working classes, if you want to call it that. I have always been a worker, and necessarily so.

The other point that I would make is that I have been proud of the fact, that I and our law firm too, have never turned anybody away from the door no matter what we like to think. Nothing is too large for us to handle and certainly no matter is too small for us to take, and if I showed you my list of clients, I have an awful lot of the little old ladies in tennis shoes, and indeed since my nomination. I have had more expressions of regret that I was not going to be able to help them any longer from them, than I have had for many of my corporate clients."

So, I recommend to the Senate, that we seize and rejoice this opportunity to have an out-standing man in the prime of life come to the leadership of our Judicial Department. Thank you Mr. President.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Hewes. Mr. HEWES: Mr. President and Members of the Senate, I would like to echo the remarks of the good Senator from Knox, Senator Collins.

I would like to speak not as a lawyer, but as a friend and fellow townsman of McKusick's for the past 17 years. We all know that he is respected, loved and admired by the Members of the Bar, that he has had the fine legal training and background that the good Senator just mentioned, but he is a humble man. A man of complete integrity, fairness, friendliness, conscientiousness, compassion and love of man. The good Senator from Knox mentioned that Mr. McKusick grew up on a farm. I remember seeing him just a few weeks ago out mowing the lawn of his home. He is a worker and is of the working ilk, He and his lovely wife Nancy have raised four children and they are credits to the community. She has been an asset to him.

I feel that Governor Longley could not have nominated a better qualified attorney for this most important position. I shall vote for confir-

mation, I urge you to do likewise.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Conley.

Mr. CONLEY: Mr. President and Members of the Senate, it is perhaps unusual for a layman to stand up and speak of the appointment of an attorney. However, my dealings with Mr. McKusick have been very brief.

But I would like to say that several years ago, when the Legislature used to have a Committee referred to as the Legislative Research Committee, that I had the honor of serving during one of the interims on that particular Committee, and was assigned to a sub-committee dealing with the problems of alcoholism. Mr.

McKusick, probably one of the most menial tasks he has had in his long career, was serving as one of the Uniform Commissioners dealing with uniform acts throughout the Country. The subcommittee that I served on dealing with the treatment of alcoholics was to try to model legislation somewhat after the uniform act, and after working with the Attorney General's Office, working with many citizens throughout the State and have them put the draft pretty much together, the committee requested that perhaps Mr. McKusick take time from his very successful, and perhaps one of the most successful law firms in the City of Portland, and at that time, little did I realize just how important an individual Mr. McKusick was, but I would say that not only on one occasion, but on two occasions he came to Augusta to sit down and make recommendations and offered his support in trying to bring the Legislation that we were to present to the future session of the Legislature, recommendations that he felt would be very acceptable as a whole and would help in putting across Legislation that was adopted.

I am very happy to say that my very brief

encounter with Mr. McKusick certainly was a pleasurable one, and I intend to support the confirmation, and I again would commend the Governor on his very high and excellent choices

of those candidates he has posted for the Court. The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Curtis.

Mr. CURTIS: Mr. President, the Chairman of the Judiciary Committee, the Senator from Knox, Senator Collins, has stated this is an historic occasion, and it is partly historic because of the procedure in which we find ourselves. I do not know if I speak for my colleagues, Senator Snowe from Androscoggin, and Senator Carpenter from Aroostook, but some of us might have a certain part of authorship in the drafting of the Constitutional Amendment in the Committee that recommended it to this Senate a few years ago to provide for this new procedure, and at the time frankly, we were somewhat concerned that the entire process would work smoothly. The most serious comment that I have heard so far in criticism of the process is that, it is unusual to hear a group of Legislators who are usually promoting something positively to be saying more then a hundred no's in one day. So I think perhaps we ought to rephrase the question that is posed to the Senate in the matter of confirmation. Other than that, I think that the process is an extremely important one, and here we have an example of a situation which certainly has led to a greater amount of understanding and cooperation and we hope greater rapport in the future among the branches of State Government. It certainly is remarkable for the Legislature to have an opportunity and the Judiciary Committee in particular to ask questions of the person who will be leading for at tions of the person who will be leading for at least 7 years, and I would hope many more after that, the co-equal branch of State Government,

the Judiciary.

You have had before you, an opportunity to read the testimony of Mr. McKusick, and the document you have is more than 60 pages long. You could tell what some of the issues were that were of concern to the Judiciary Committee. It is interesting that so many members of the Judiciary Committee who are not lawyers had some of the best questions to ask. I was par-ticularly interested in the response that was given to one question asked by Representative Henderson of Bangor, when he inquired of the Chief Justice designate, "Are you nervous right now?" and when speaking to these 13 Members of the Judiciary Committee he answered, "-Quite considerably I expect." It is an exhilarating experience for any attorney who has made his presentation before the Courts of the State and before the Law Court of the State of

Maine, to have an opportunity to ask the Chief Justice some questions. Some of those questions, I think, were right on point considering the Legislation which we have dealt with this past year. In particular, I would like to refer to some of the problems that we have seen this past year regarding court administration, and I would like to read to you part of the answer that Mr. McKusick provided when he was asked by the Senator from Androscoggin, Senator Mangan about his views on the question of court administration. Mr. McKusick said, "Let me answer that by commenting perhaps a little more comprehensively about my views on court management. As I see it, the State has precious resource in the group of its Judges. It has 6 Associate Justices of the Law Court, 12 Superior Court Justices and one active retired - Some 44 Judges. In aggregate legal training and experience it is a most impressive resource there. As I see the purpose of court management, it is twofold; number 1, to build and maintain an atmosphere in which those judges have high morale and so produce at their very best; and secondly, it is to relieve those Judges from attacks that are distracting from their judging. After all, their judging is what the Courts are all about, and they need to be relieved of the burdens of routine, administrative detail, and tasks. Now I have no panacea, and indeed I don't pretend I even have any analysis of things that need to be done or need to be cured. I do think that perhaps I will have, if I am confirmed, some advantage in coming in as a completely fresh face without any prior commitment, and I am going to approach the court management job from the point of view that I am going to have to do an awful lot of listening and learning. I would propose that if I am confirmed to meet privately with the entire group of Superior Court Judges for several talk sessions, as long as it takes. I would do the same thing with the District Court Judges, a thorough talk session, myself and them; and just as soon as I could develop a worthwhile meaningful agenda, I would propose to convene the Judicial Conference of the State of Maine which is provided in 4 MRSA, Section 471. I would hope that would be by mid-winter at the latest. And it is through that process, I can't give you either any analysis of what problems or non-problems there are, or any panaceas for solving them, but I would hope that the process I suggest may produce the ability of the Judges as a team, as a Judicial partnership, identifying what can be done to improve the Judicial system, then move about doing it.'

So I would conclude by addressing myself to some of the issues that have been raised in question of this particular nomination. The first one being that Mr. McKusick has not served on the Judiciary before, and respond by saying first of all that the Law Court is an Appeals Court, it is not a Trial Court, and secondly, that some of the matters that are of extreme importance to the Judiciary today involve the question of court management and administration, and I think that a new face is an appropriate face to introduce into the court system at this time.

The PRESIDENT: The Chair recognizes the

Senator from Cumberland, Senator Merrill. Mr. MERRILL: Mr. President and Members of the Senate, this day is indeed historic. It is the first time that the Maine Senate has gathered solely for the purpose of confirming appointments, and certainly we have before us today many people who are highly qualified and so it is an enjoyable task to be here and to be involved in that confirmation process. But I think that it would be too bad, unfortunate, if someone did not take the opportunity today to praise the conduct of the Democratic Party in particular with regards to the appointments of Members to the Court and all of the appointments that it

has handled. I am proud in fact, that it was during the Democratic Legislature and when there was a Democratic Executive Council that we finally removed it, and in the face of what has been an overwhelming number of appointments which happen to be Republican, that the Democratic Party has not seized upon that as an opportunity to act in a purely partisan manner and to vote against those appointments because happenstance of the enrollment of the people who have been appointed. Which as I say has been overwhelmingly Republican. And as we stand here today confirming for the first time a Chief Justice, by this new process, I cannot help but compare the procedures here today, and the procedures that have led up to today with what took place the last time a Chief Justice was appointed. At that time, everyone will recall, there was an all Republican Executive Council, there was a Democratic Governor, and the person who was being proposed by that Governor to be Chief Justice was in fact a Democrat himself. In the name of a tradition, which was the tradition of the senior member of the court would be appointed to be Chief Justice when the vacancy arrived the Executive Council held up for over two months the appointment of Chief Justice Dufresne. Finally, in the face of growing public discontent with that activity, Chief Justice Dufresne was appointed, and I think has served the Court and the State very well, and has certainly upheld the former Governor Curtis' faith in him, and I hope today that the difference in the procedure, the difference in the fact that there is none of that sort of discussion is a testament to the new process, and I have every reason to believe and certainly hope that when the shoe is reversed, if it ever is, that the other party will conduct itself with the same lack of partisanship to this new process that characterizes the Democratic party's approach to these appointments here today. I never believed that the tradition of appointing someone who has served on the Supreme Court before was a tradition without merit, and I feel some personal regrets that the Governor did not choose somebody from the Supreme Court. Certainly as a person who has among his constituency Justice Wernick, I would have felt very happy had he been appointed. He certainly is a highly qualified individual as are others on the Court. But we have before us today a highly qualified individual who has served the Bar well, and I will be proud to cast my vote today in favor of upholding the Committee's recommendation. And hope that in our activity here today, and in the activity of the Judiciary Committee proceeding that we have set a new high standard that will be followed in the appointment of Judges which will not in the future involve partisan politics the way they have in the past. If we accomplish that, by this new process, we have accomplished, I think, our highest hopes. And I wish the next Chief Justice of the Supreme Court, Mr. McKusick, all the good fortune that one could have in that job because it is a great task indeed to lead the Courts, because they are asked to do what I suppose is an impossible task, and that is to uphold the tradition that we are a nation of laws and not of men, and unfortunately, I suppose, men have to uphold that tradition, and we all come to our jobs with certain bias and prejudices and it is the job of a good lawyer, and a good judge to overcome those and I have every faith that Mr. McKusick will be able to do so and will lead our Court in the same great tradition that it has been led in the past by such men as of Chief Justice Williamson and Chief Justice Dufresne.
