SENATE

In Senate, January 19, 1978

Dear Representative Martin:

In accordance with the provisions of 5 MRSA, Section 1128 (Chapter 573, PL 1977), this is to advise that the Board of Trustees of the Maine State Retirement System has authorized a 4% increase in retirement benefits, effective November 1, 1977, paid to retired State employees, teachers and the retired employees of certain participating local districts, which increase is a cost-of-living increase.

In addition, this is to advise that the Consumer Price Index, published by the United States Department of Labor, Bureau of Labor Statis-tics, United States City Average, All items, 1967 = = 100, reflected an increase, for the 12 months ending June, 1977, of 6.9%.

"A" (H-962). Which Reports were Read and Accepted. The Bill Read Once. House Amendment "A" Read. The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ: Mr. President, I want to apologize to my seatmate, the Senator from Kennebec, Senator Pierce, whose name does not appear on this Committee Report. As it is an error of the Chairman, not of the good Senator.

I move the indefinite postponement of House Amendment "A". This Bill deals with the ques-tion of the evaluation of the handicapped child by pupil evaluation team. Last year we required for the first time, written notification be sent to the parent when this process was going

to be undertaken. We required that it be done by Certified Mail. It was an error on our part. Certfiied mail is cumbersome. Very frequently the parent has to walk down to the post office to get the certified mail if they are working. So the Bill in front of you says that the parent must be notified in writing.

The House Amendment on there comes right back to the question of certified mail. I think that what we should do is to let the communities know what we want done, but do not tell them in a rigid fashion or mandate how they do it. I move indefinite postponement. The PRESIDENT: The Senator from Kenne-

bec, Senator Katz, moves that House Amendment "A" be indefinitely postponed. The PRESIDENT: The Chair recognizes the

Senator from Cumberland, Senator Conley. Mr. CONLEY: Mr. President and Members

of the Senate, I could not agree more thorough-ly with the Senator from Kennebec, Senator Katz. I would give one illustration. As a father of a large number of children as you again all know, I had the problem come to my family of one of our youngsters who was somewhat shy. and it was the youngest one in the family and everyday my wife would accompany the youngster to school, and go over at noontime and pick him up and bring him home. Many times she would be engaged in conversation with the teachers and the principle of the school, and one day after returning home only to find that there was a pink slip waiting in the mail box to pick up a certified letter at the post office which was roughly about three or four miles away from home. So when I got home it was one of my chores to have to drive down to the local post office to pick it up, only to find that Registry Division was closed and have to make another trip down. I just found this to be about the most stupidest thing, and I want the good Senator from Kennebec, Senator Katz, to know that I had him foremost in mind, and I was condemning both him and am still condemning the very fine gentlemen from Portland who still supports this type of Legislation. However, I think that you know, here is a parent, as I say, is at the school, talks with the teachers, talks with the principal, only to come home to be notified by registered mail that they would like to take one of these youngster under the special ed program and to go through this nonsense is sheer ludicrousy and I might add that there was a 72¢ charge that the taxpayers of Portland were picking up, which is even more stupid. The PRESIDENT: The pending question

before the Senate is the Motion by the Senator from Kennebec, Senator Katz, to indefinitely postpone House Amendment "A". The chair will order a Division.

Will all those Senators in favor of indefinite postponement please rise in their places to be counted.

All those opposed please rise in their places to be counted.

24 Senators having voted in the affirmative and no Senators in the negative, the Motion to indefinitely postpone House Amendment "A' does prevail.

The PRESIDENT: The Senator from Penob-scot, Senator Pray, has posed a question through the Chair to any Senator who may care to answer. The Chair recognizes the Senator from Cumberland, Senator Jackson. Mr. JACKSON: Mr. President and Members

of the Senate: I do support the motion to recommit this Bill back to Committee. I do feel that we can clear up one ambiguity in the law which concerns many, many people, and that is the advertising of publications, the advertising from the boardering States or even from the West Coast or wherever the case may be. If we can satisfy that section. I am sure that the piece of Legislation would be an adequate legislation and we would be able to handle some of the problems on transporation of products that is purchased or procurred in another community or another State and brought into the state. I think that, again as I stated earlier, I think that we can clear this up and I think we can make it a satisfactory piece of Legislation which can be enforced. The PRESIDENT: The pending question

before the Senate is the Motion by the Senator from Aroostook, Senator Martin, that this Bill be referred back to the Committee on Taxa-tion. Will all those Senators in favor of that Motion please say yes. Will all those opposed

please say no. A Viva Voce Vote being had, the Bill and ac-companying papers recommitted to the Committee on Taxation in non-concurrence.

Mr. CARPENTER: Mr. President and Ladies and Gentlemen of the Senate, to go along with the remarks of the good Senator from Kennebec, Senator Katz, we are losing either today or tomorrow another member of our staff here in the Senate, and I thought that that person should be recognized.

Any of you who watch the funeral of Senator Humphrey last weekend, undoubtedly were impressed with the changing of the guards, the changing of the old guard, the military honor guard. We have a changing of the guard taking place here. I am not sure whether it is today, or tomorrow beteeen a fellow that has been around here, ever since I have been in the Legislature, in the House and now down in the Senate, and his replacement, and it took me about three years in the Maine Legislature to figure out just exactly what this guy did. I finally figured out that he was here to protect me, I guess. I think-that the Senate-ought to recognize Walt Williams who is being moved as I understand, over to the State Police Headquarters going on to bigger and better things hopefully and also his replacement, who is here with him this morning, Trooper Bob Tupper and I think it would be very nice if the Senate would recognize the accomplishments of Walt.
