After Recess

Senate called to order by the President. The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Hewes.

Mr. HEWES: Mr. President and Members of the Senate: We are never too old to learn. Maybe things have changed as the Senator from York says, Senator Danton, said that during the past 15, 20, or 30 years. I have no personal knowledge of any family violences as have been described, but during the last few minutes, I have spoken with some people, two of whom apparently have been victims and I do not mean to be insensitive and I think that I have compassion. I hope that if this Bill does pass that the \$200,000 is not spent just for administration in making another bureaucracy and not doing a benefit for the victims of any violence. In short Mr. President, I would like to withdraw my motion to indefinitely postpone this Bill.

Certainly an awful lot of people had a great deal to do with passing this Bill and by taking nothing away from the sponsor and the people I have talked to about this, I would especially like to say certainly that in our discussions tonight that the Senator from Androscoggin, Senator Snowe, I think made the final decision on this Bill whether or not this piece of legislation would pass with her support, it is going to pass, I believe, and I would ask for the yeas and nays on this Bill.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Merrill. Mr. MERRILL: Mr. President and Members

of the Senate: Watching what has happened to this bill today, I cannot help but be reminded of that scene in the movie Patton when the general looks over the carnage of war and walks over the battle field and says, "God help me I love it so'

And I do not feel that we are really addressing the needs of those who really at present are being discriminated under the present setup. By directing our attention to those who need it. we are making a blanket across the board change whether the needs are there or not. I would hope that the Senate would support the defeat of this Bill.

Joint Resolution

Joint Resolution memorializing the President, the Administrator of Veterans Affairs for the United States, the Maine Congressional Delegation, the Governor, and the Director of the Maine Bureau of Veterans Services concerning the current hardships faced by Maine Veterans.

We, your Memorialists, the Senate and House of Representatives of the State of Maine in the One Hundred and Eighth Legislative Session assembled, most respectfully present and petition the President of the United States, the Administrator of Veterans Affairs for the United States, the Maine Congressional Delegation, the Governor of the State of Maine and the Director of the Maine Bureau of Veterans Services as follows:

WHEREAS, many veterans in Maine, especially disabled Vietnam-era veterans, face con-

tinuing hardships and discrimination in employment; and WHEREAS, many veterans attempting to

attend institutions of higher education, including the University of Maine or the vocational technical institutes, face great hardships when financial aid promised by the United States Veterans Administration is delayed for weeks; and

WHEREAS, these delays severely affect their abilities to sustain basic necessities, such as food, housing, transportation and school supplies; and

WHEREAS, continuing public attitudes about the Vietnam War and the veterans of that war often result in employment discrimination; and

WHEREAS, there is a lack of communication between many Vietnam-era veterans and the United States Veterans Administration: and

WHEREAS, the foregoing and other factors produce severe demoralization and a sense of frustration on the part of many Maine citizens who are Vietnam-era veterans; now, therefore, be it

RESOLVED: That we, your Memorialists, respectfully_urge_that_these_difficulties_and hardships should not be allowed to continue; and be it further

RESOLVED: That we respectfully urge and encourage the President of the United States and the Administrator of Veterans Affairs for the United States to make additional efforts to effectively serve Maine Vietnam veterans; and be it further

RESOLVED: That we respectfully request each member of the Maine Congressional Delegation to support these federal efforts; and be it further

RESOLVED: That we encourage the Governor and the Maine Bureau of Veterans Services to make every effort to alleviate any delay in administering the benefit programs for Viet-nam-era veterans; and be it further

RESOLVED: That we further encourage the Governor and the Maine Bureau of Veterans Services to provide active assistance in discouraging discrimination in employment and educational opportunities for Vietnam-era veterans; and be it further

RESOLVED: That we recognize that there is a need for a strong advocate for individual veterans; and be it further RESOLVED: That suitable copies of this

Resolution be transmitted immediately to the Honorable Jimmy Carter, President of the United States, to Max Cleland, Administrator of Veterans Affairs for the United States, to each member of the Maine Congressional Delegation, to the Honorable James B. Longley, Governor of the State of Maine and to the Honorable Robert R. Washburn, Director of the Bureau of Veterans Services, (H. P. 2332)

I sat in here and I would suspect on a day to day basis I perhaps put more hours in this Chamber than almost anybody in here and I have seen the abuse of the mailing that my seatmate has just talked about and that is the reason that I am moving the indefinite postponement of this. I have sat in this chamber and I have watched thousands and thousands and thousands and thousands of letters go out and they are not an-swering constituents' problems. I think that it is an abuse. I think that it is a rip off to the people of the State of Maine. I have in my draw stamps that were given to me last session and I have another envelope from this session that I have not touched because all you have to do is drop it over there and you do not have to go a stamp on it. Some individuals who are in this session Body, in this Chamber I think have abused it, and I do not think they need the stamps because they are not going to go home and use it to distribute reports. If they do, they are going to abuse it because they are going to send-out-hundreds-of-them-to-people-who-aregoing to get them either through particular business interest groups that they belong to or other avenues. I sat here a year ago when we discussed the drinking bill and as a liquor licensee received a letter from a member of this Chamber about an amendment that he offered. I think that is waste.

When it first came through here, I opposed the measure in the Conference Committee and I think that it is \$6,000 down the drain and a complete waste to the people of the State of Maine, and I hope that you will pass my indefinite postponement motion. berland, Senator Jackson. Mr. JACKSON: Mr. President and Members of the Senate: I rise to oppose the motion of the good Senator from Cumberland, to indefinitely postpone L. D. 2095.

I am sure that many members of this body, and many members of the Senate here are aware that the town of Oxford which is in my Senatorial District Number 5 is the mobile home capital, or manufactured housing capital of Maine. We have three manufacturing plants in Oxford. We also have three places which sell manufactured housing in that community and I think that it is time that the State of Maine recognizes that manufactured housing represents a large segment of the housing which is stationed or put on stationary foundations in this state. I am sure that many of the members of this Body are aware of the amounts of money which are concerned in this area.

We call, because it does not have the emergency measure on the piece of legislation for \$18,100 in this year and appproximately \$56,000 in the fiscal year of 1979. The figures you see represent the figures that have been represented in the past because we have a few members of our society which exist in this state, which cross the state border, such as some other members of various economic communities, and acquire certain pieces of equipment and, we will say, manufactured housing, to avoid the sales tax.

All we are asking for in L. D. 2059 is sales tax relief of approximately 50 percent and I think that that is equitable. We allow the construc-tion people, the contractors who build houses, we do not tax them on labor, we do not tax them on transportation and registration fees. We tax them on the materials that go into building these places and I think that what we are asking here today and what I am asking when the vote is taken, that you people consider the same thing that we provide for these contractors be provided for these people who manufacture housing to be transported. Gentlemen it is no secret that manufactured

housing is less expensive than stick built housing and with our present economic situation and the population of the state and that we have

heard earlier in debates consisting, I will not say consisting, but relating to the tax package which I can immediately recall and I am sure that other pieces of legislation that Maine people are not the highest paid people there are in New England or in the United States. We are talking about housing which people in Maine can afford to buy, afford to pay the taxes on, afford to heat and pay their electricity bills, people who like and have the pride of self ownership and I know that probably there are people in this body who feel that 50 percent of the sales tax on one of these units does not represent very much money, but I can remember a fellow appearing before the Taxation Com-mittee approximately four years ago that indicated that a one cent increase in the gas tax could bankrupt some people and that I would assume, I think that it was about two weeks later or three weeks later we were discussing at that time an increase in the transfer tax and the possibility of \$10 or \$15 to circumvent the sale of real estate. Well we are talking a unit which might cost \$17,000, \$12,000, \$14,000, you multiply that times five percent and divide it in half and any of you related to the instances that

I just put forth. I think that L. D. 2059 on its own merit deserves the consideration of this body and I am sure that it deserves the vote of confidence and passage to be enacted into law to provide the same equity which we provide for those fellows or those contractors or those corporations which stick build houses in this state.

Mr. President, when the vote is taken, I request a Division.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Huber.

Mr. HUBER: Mr. President and Members of the Senate: Throughout the various meetings and caucuses and so on that we have had this session, I have had to say that we have been having hard decisions to make. The fact is that there would be a lost revenue of \$537,600 estimated on this Bill and the fact is simply that we do not have that much money left after passing the bills that have already received passage in this Legislative session. Therefore, will have to stick by the vote of the Legislative Leadership and hopefully have the Senate go along with the indefinite postponement of this Bill.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Jackson.

Mr. JACKSON: Mr. President, I hate to belabor the debate on this thing, this piece of legislation, but I see a few other pieces of legislation which we funded this evening that I do not feel that personally would have any more importance than this piece of legislation has.

One of them "An Act to Establish a Solar Water Heater Demonstration Program." Another new program, I do not know if it has been funded yet or not but, the Emergency Shelter for Family Members who are Victims of Violence, and I probably can name a few more here. I just think that this is a problem that has existed for many, many years between the manufactured housing industry in this state and the industry of stick build or the individual building houses and what not. I just think that we need a little equity in this field and I think.

that it is time that we provided it. The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pray

Mr. PRAY: Mr. President and Members of the Senate: I rise to support the comments of the Senator from Cumberland, Senator Jackson, but I remember only a day or so ago when we concerned ourselves with the tax package that it was that same Senator that raised the point as to the L. D.'s on the Appropriations Table which I may support. In conversation afterwards, I pointed out that my only concern was the \$150,000 Bill dealing with pre-school handicapped that was my number one priority, my only major concern.

But as I sit here and listen to his debate, I become convinced that this also is a worthwhile matter. I look at the price tag on the sheet that has been passed out to us and I see in 1978-1979 a loss of revenue of \$537,000 and a few other dollars in there also and I ponder over the comments made by that Senator and my concern to be fiscally responsible but also to be equitable and fair. Listening to the rhetoric that we have had the past few days as to the financial condition of the state I have also become convinced the points of views that have been betrayed by the Majority Party here and that Senator being a member of that Majority Party has again convinced me that this is a worthwhile piece of legislation and that we should put equity before we put responsibility if there is a concern there. I think he has made the point that the money is there and that we are giving unnecessary relief to the individuals who need it and for that reason I would urge the members of this Body to follow his lead and defeat the motion to indefinitely postpone and

then pass this piece of legislation. The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Conley.

Mr. CONLEY: Mr. President and Members of the Senate: I do not question the merits of this particular piece of legislation, in fact I support it. This item as one of those that should be passed. However, Leadership, the Appropri-ations Committee itself in listing its priorities did not list this as one of the top priorities be-cause again of the lack of revenue. The good Senator from Cumberland, Senator Huber stated quite emphatically as to what the loss of revenue is going to be concerning this Bill if it is passed. Now if we have the money it is fine, but the question is and the answer to that ques-tion is, we do not have the money. That we have allocated something like \$6.7 million off the table, it has been funded and to pass this it would just be irresponsible. The PRESIDENT: The Chair recognizes the

Senator from Oxford, Senator O'Leary. Mr. O'LEARY: Mr. President, I think that I

would take exception to the remarks of the good Senator from Cumberland, Senator Conley. I think that anyone should listen and listen very carefully to the remarks of the Senator from Cumberland, Senator Jackson because he laid it right on the line, but there was something that was not said here tonight that should perhaps be addressed.

What we are talking about here is a sales tax on labor. And that is really what it boils down to when we talk about this piece of legislation. Now we have in the past indefinitely postponed and if my memory serves me correctly legislation that would tax services and that is what this Bill is all about. I think that the Senator from Cumberland, Senator Jackson, has laid it right out on the line to you that this is a good Bill and it should pass. Mr. CONLEY: Mr. President and Members of the Senate: I have been a member of the Legislature, as many of you know, for approximately 14 years and I have never been so humiliated or ashamed to be a member of this

legislature after what I have just heard while listening to what was going on at the other end of the hall. For a member of my party to attack the personality of the presiding officer of this Body unfoundly charging him with alleged in-toxication made me sick to my stomach.

I have known the presiding officer for many years. I have served on the Appropriations Committee with him for four of those years. He has been the presiding officer here, I believe, for four years. I had the occasion of being out to supper with him and in the period of time, and I know that you are all aware of the fact that I do not indulge, but never on any occasion that I have been in the presence of this presiding officer has he ever been out of line in any way outside, never mind to mention within these Chambers. And I think that it is an outright disgrace that anyone would ever make the remarks or imply through innuendo what was stated in the House of Representatives a few moments ago.

Mr. President, I wish to apologize to you for

the action taken by that individual. The PRESIDENT: The Chair thanks the Senator.

Mr. Danton of York was granted unanimous consent to address the Senate on the record.

Mr. DANTON: Mr. President, and Members of the Senate: I have served in this Legislature for four terms. I like to believe that I have served with honor and dignity. I would like to believe that the men and women that I have served with for the last eight years have also served with honor and dignity. To hear re-marks like I just heard a few moments ago were certainly out of line. To begin with, they should not have been allowed to carry on any further perhaps than the first few words.

I have been a member of the minority party in this Senate Chamber. The first President I served with was Kenneth MacLeod, I found him as the presiding officer of this body to be an honorable man. For the last two terms, President Sewall, you have been the presiding officer and I have found you to be nothing but the same. I want you to know that if you feel that the Democratic Party attacked you, that is not so, maybe one or two individuals did but not my party. I am sure you can appreciate the fact that we Democrats can have different views, can take different positions, but I do not think that we Democrats in toto are going to resort to some of the rhetoric that I heard come from the other body.

So I too Mr. President want to apologize to you for some members of my party who, for attacking you in the manner in which they did. The PRESIDENT: The Chair thanks the Senator.

Mr. MERRILL: Mr. President and Members of the Senate: The first session that I was in this body as we came near the end of the session the good Senator from Kennebec, Senator Katz took me aside and warned me of the pressures that come with the end of the legislative session and told me when in doubt that good council would be to say nothing. Well, I am sure that I am standing testimony of the fact that I did not follow the advice as rigorously as some would have had me do so, but it was good advice and I think that we saw tonight an example of why that advice is well taken. There are pressures and there are concerns in the last hours of the session. People said some things that I am sure they will regret much more than the people who were the targets of what was being said.

My only hope would be that the people who remember this session and the people who report it will focus on the truly important things and will put what was said here tonight in the context that I think is proper context and

that is that people were speaking intemperately and I think that I would hope that the press would focus on what this Legislature has accomplished. It has accomplished a significant amount of tax relief for the people of Maine and I hope that will be a story that will certainly be more important than the intemperate remarks here at the end of the session. We responded to the challenge school funding problem as opposed to us by the voters last Decem-ber and I hope that will be noted. We finally have taken some steps to deal with the automatic fuel adjustment charge in response to the consumers of electricity around the state and I hope that that will be an important story as to what we have done here. We provided significant help for the mentally retarded in our state and I would hope that that would be a more important story for them than a few in-temperate words and we provided for an improved elderly drug program and I would hope that that would be a more important story. In short, I think that there are a lot of things

of significance that happened here today and have happended here in the last few weeks and I hope that those will be focused upon and those will be the important issues that people would remember this Legislature for and not the fact that a few people in the early hours of the morning said some things that were obviously represented of bad judgment, inaccurate, and unnecessary. There is no way to erase what is said, but there is certainly the ability to put it in the context of what you belong and I think that in that context it should be given very little credance either way.

Mr. Carpenter of Aroostook was granted unanimous consent to address the Senate on the record.

Mr. CARPENTER: Mr. President and Ladies and Gentlemen of the Senate: I guess I want to echo the remarks of my colleague, the Senators from Cumberland, Senator Merrill and Conley and the Senator from York, Senator Danton about what has gone on here. Earlier this evening I was quite disturbed about the actions of this Body. Actions which had absolute-ly unequivocally had nothing to do with any allegations that came down from the other Body

I think what concerns me more than anything else is exactly what the Senator from Cumberland, Senator Merrill just commented on, the positive things that will perhaps now be over-looked by the people of the State of Maine and it sort of reflects a pet fear of mine. Each election it seems like we have fewer and fewer people that get involved with the election process. I was thinking about it today as I was over at the Secretary of State's Office looking at blank page after blank page of candidates running for office and I go back home and no matter what we did today we all know what the topic of conversation will be when we all get back home. I think that is just so sad and I feel. I have only been here four years and I am extremely saddened by the events this morning and I would add my apologies to the presiding officer of this Body along with those who have already been echoed and I just implore the people that are in this Chamber both members and here as guests observing the actions to-night and the reporters to accentuate the positive, the things that have been done by this and previous Legislatures and future Legislatures. We are in a legislatures and turne Degislatures. We are in a legislative system by design is im-perfect. We strive for perfection. I consider the 184 members of this Body, this Legislative Body to be the most honorable and forthright hard working and dedicated people and I say this back home people look at me and they wonder how young and naive I am and I come down here, and I came down here four years ago and I am as idealistic now as I was when I came down and it bothers me, it scares me when things happen such as happened this morning. I wonder how many people now will

be turned off on what has proven to be, as far as I am concerned, the finest governmental process ever on the face of this earth and I just deplore what has happened and I guess the anger that I felt earlier over the issues has now been clouded by a saddness over issues that in fact were not the reality and I want to emphasize that to all the people of the State of Maine. I am very sad and I apologize. The PRESIDENT: The Chair thanks the Sen-

ator.

Enacted. In the Senate, March 24, 1978, Indefinitely Postponed, in non-concurrence.

Comes from the House, that Body having Adhered.

The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ: Mr. President, the Committee on Education set its usual record at having more bills before this session than any other committee. Of all the Bills that we had, there was probably none that was smaller in scope than the ones that caused this big flap.

Mr. President if I seem to be a little unsteady on my feet it is because I notice that the sun is getting ready to rise and I am quite tired.

This Bill came before our Committee and it had to do with an alternate way of adopting school budgets. I did not like anything about it I felt that it was the kind of bill that would hurt rather than help. When a conference committee was proposed I served on the Conference Committee and it was in one of my good days when I was very obliging, the sponsor was a fine young man about to get married and in one of my rare bursts of good humor I said to myself I am going to try to help this young man develop a bill that will not hurt the state and might conceivably help it. So along came L. D. 1970 in its present form, and the Senate may notice that I have continued to vote for this bill all through this long night although between me and thee I really do not like it at all, but it seemed to be the best effort that I could to lend a helping hand to a young man who I felt was going to be around and develop into a good leg-islator so I have voted for it consistently and I guess that is about all I want to say, except that I move that the Senate recede and concur. On Motion of Mr. Katz of Kennebec, the Senate voted to Recede and Concur.
