Friday, February 9, 1979

The House met according to adjournment and was called to order by the Speaker pro tem, Representative G. William Diamond of Windham.

Prayer by the Reverend Herbert Pierce of the Full Gospel Church, Vassalboro.

Reverend PIERCE: Let us pray. Our gracious Heavenly Father, we come before Thee this afternoon through Jesus Christ, Our Lord, praising Thee and thanking Thee for the many blessings which Thou has so freely bestowed upon us. Transmitted herewith is a copy of the Highway and Bridge Improvement Program for Fiscal Years 1980 through 1983, as well as a copy of the Highway Maintenance Paving Program for the 1979 and 1980 summer seasons and a copy of the 1978 Highway Sufficiency Report.

The Highway and Bridge Improvement Program includes projects which the Department has determined to be the priority items that

should be authorized for improvement during the next four years. Projects have been identified in the program which are proposed for development in the first biennium in accordance with the recommendations for financing during the next biennium. Additional financing will be required for those projects proposed for the second biennium. The priority projects require a total of \$23.2 million of State funds to enable the matching of \$93.8 million in Federal funds.

The Highway Maintenance Paving Program for the 1979 and 1980 summer seasons provides for the paving of about 2,000 miles. This proposal represents a program that involves the same basic level of effort as the 1977 and 1978 summer sessions.

We trust that this material will be of interest and will provide information and clarification regarding the Department's efforts to maintain and improve Maine roads.

Mr. Nelson of Roque Bluffs offered House Amendment "A" and moved its adoption.

House Amendment "A" (H-20) was read by the Clerk.

The SPEAKER pro tem: The Chair recognizes the gentleman from Roque Bluffs, Mr. Nelson.

Mr. NELSON: Mr. Speaker, Ladies and Gentlemen of the House: I think the Statement of Fact—the purpose of the amendment is that these plows, while they are rolling down the highway, have the blade angled in such a manner that the left edge comes in to the left side so that if an oncoming vehicle happens to strike that plow with a bumper, it will glance off and be deflected to the right; therefore causing less damage than it would have if it plowed into the side of the car.

The SPEAKER pro tem: The Chair recognizes the gentleman from Limestone, Mr. McKean.

Mr. McKEAN: Mr. Speaker, Ladies and Gentlemen of the House: My good friend has an idea; however, I discussed this idea with some people in my area that do run plows quite often. I do realize that there is a chance that an oncoming vehicle striking that plow could be deflected. There is also the chance that the right-hand edge of the plow striking the snowbank would even further cause the rear of the vehicle to go to the middle of the road. There is also the chance, since we have very windy conditions in this state, that a vehicle travelling at 40 or 50 miles an hour on the highway with the plow angled does create some wind deflection and it creates a little harder problem in the steering of that particular four-wheel drive with a plow on it.

I see a lot of problems with angling that plow. There are many plows, especially the older variety, which you cannot angle. There are many tractor plows which are used in our particular area which you are not able to angle. I do see quite a bit of problem with this, so in view of that, I have got to ask for the indefinite postponement of this amendment.

The SPEAKER pro tem: The gentleman from Limestone, Mr. McKean, moves that House Amendment "A" be indefinitely postponed.

The Chair recognizes the gentleman from Roque Bluffs, Mr. Nelson.

Mr. NELSON: Mr. Speaker and Members of the House: There are some inequities in this bill, and there is no guarantee that any of us are going to live to get home today. But as far as the angling of the blades on the vehicles that are not capable of doing it, I think that is already in the amendment. It so states that "vehicles equipped and used for plowing snow on other than public ways on which the plow is capable of being angled."

I still think that that plow, if you angle it in there, I have driven plows, I have seen them

work; and when you angle that plow, the outer edge, the toe of that plow has a tendency to go up and the heel, as it is angled in toward the body, has a tendency to come down. Forty of fifty miles along the highway in a snow storm, I don't know, I think is a little bit far-fetched also.

I would urge you to defeat this motion to indefinitely postpone so that we can vote to have this amendment put on the bill.

The SPEAKER pro tem: The Chair recognizes the gentleman from Limestone, Mr. McKean.

Mr. MCKEAN: Mr. Speaker, Ladies and Gentlemen of the House: My good friend brought up another very good point. He is absolutely correct. When a plow is angled, if it is angled to the left, the left-hand bottom portion of the plow does come closer to the road; therefore, if it does strike an object in the road or a bump in the road or a pothole, of which we are all aware, there are many, I love my potholes but I don't love my plow hitting them and angling my vehicle. Therefore, I would ask for a division.

The SPEAKER pro tem: A vote has been requested. The pending question is on the motion of the gentleman from Limestone, Mr. McKean, that House Amendment "A" be indefinitely postponed. All those in favor will vote yes; those opposed will vote no.

A vote of the House was taken.

99 having voted in the affirmative and 26 having voted in the negative, the motion does prevail.

Thereupon, the Bill was passed to be engrossed in concurrence.

Passed to Be Enacted

An Act to Increase the Limitation of Contracts which the County Commissioners may Enter into for Purchases and Constructions without Competitive Bidding (H.P. 56) (L.D. 65)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed.

The SPEAKER pro tem: The Chair recognizes the gentleman from Sanford, Mr. Wood.

Mr. WOOD: Mr. Speaker and Members of the House: I would request a division on this bill. I don't intend to offer a motion, but I would like to give the members my reasons for voting against this bill, and I think there are three of them.

One is that, I think most of us would agree, that the most unaccountable form of government we have in this state is our county government. It is not accountable to the people. I think many of our constituents do not know who the county officers are or what they do. One political scientist referred to county government as "The dark underside of American politics." I think he is probably correct, and I would like to assure that our tax dollars are being spent in an accountable way. I think this bill will lead to less accountability among county officials.

The second reason is that I think the competitive bid is essential to protect our small businesses. It is an essential part of a democracy when you have a competitive bid that allows all people to bid for a project or for a purchase.

I think the reasons for limiting competitive bid have to be overriding, and in this bill, I don't see any overriding reasons to lift the limits by which county commissioners can raise the limits for competitive bid. I think we fought a long time to get competitive bids on the books, and I hate to see that being eroded.

The third reason is inflation. I think in times of inflation we have to get every penny we can out of our tax dollars, and competitive bids are one of the ways that we can assure that the commissioners are doing their job in getting the best buy. We are forcing them to shop around, to publicize what they want and ultimately get the best buy. So, I would argue that in times of inflation, instead of raising the amounts, we probably should lower the

amounts, that we guarantee the people are getting a good buy for their tax dollars.

It is for those reasons that I intend to vote against this piece of legislation.

The SPEAKER pro tem: The Chair recognizes the gentleman from West Bath, Mr. Stover.

Mr. STOVER: Mr. Speaker and Members of the House: This bill is a very simple bill. The Statement of Fact, I think, explains it very well. The purpose of this bill is to take care of inflation. Under the present statute, anything that costs over \$250 has to be put out to competitive bid.

As you realize, in this day of market, there is very little you can buy under \$250, even something as simple as a typewriter. The value of it, plus the cost of running these ads, time and effort involved, it seems to me just common sense that we should up this ceiling to \$500. We are still keeping competitive bid on the books. The commissioner is still accountable, but it does give him a little more room to maneuver as far as getting things they need in the time element oftentimes involved.

The other thing, of course, is on the building. That was only upped \$500, from \$2,000 to \$2,500, but again, with labor, material being what it is, you would have a very simple matter with the courthouse, storm drains, whatever, and this way you can go out and get the job done by negotiation. I am sure the taxpayer wouldn't be hurt.

As far as I can see, this is just a housekeeping measure that keeps us up with the times. I urge you to vote in favor of it.

The SPEAKER pro tem: A vote has been requested. The pending question is on passage to be enacted. All those in favor of this Bill being passed to be enacted will vote yes; those opposed will vote no.

A vote of the House was taken.

77 having voted in the affirmative and 48 having voted in the negative, the motion did prevail.

Bill "An Act to Permit Signed Statements of Psychologists and Chiropractors to be Admitted into Evidence Before the Workers' Compensation Board" (H.P. 377) which was tabled earlier in the day pending reference.

The SPEAKER pro tem: The Chair recognizes the gentleman from Wiscasset, Mr. Stetson.

Mr. STETSON: Mr. Speaker, after consultation with the gentleman from Lisbon Falls and the gentleman from Saco, and in the spirit of bipartisan cooperation, I now move that this bill be referred to the Committee on Labor.

Thereupon, the Bill was referred to the Committee on Labor, ordered printed and sent up for concurrence.
