The SPEAKER: The Chair recognizes the gentleman from Augusta, Mr. Hickey

Mr. HICKEY: Mr. Speaker, Ladies and Gen-tlemen of the House: In the 109th Legislature, several bills were presented providing assis-tance to the state retirees. As the closing days of the session approached, it became apparent that these bills were doomed to defeat due to the other money commitments.

At that time, opinions were expressed saying these problems would be resolved in the Special Session. However, two retirement bills were submitted to the Special Session before cloture and rejected at the hearing before the Legislative Council.

I am presenting today's Order with the hopeful feeling that the members of the House of Representatives will recognize the crisis facing our 14,000 state retirees. They, too, are victims of today's economy and deserving of our support. They have paid their dues and in their working days served the state productively. Unfortunately, at their ages it is impossible to find work to augment their income and each passing day finds it more difficult to exist within our spiraling cost of living.

I ask your support in passing this Order per-mitting a bill to be submitted that will improve the living standards of our retirees. The SPEAKER: The Chair recognizes the

gentleman from Cumberland, Mr. Garsoe

Mr. GARSOE: Mr. Speaker, Ladies and Gen-tlemen of the House: It seems that we have a slight juxtaposition in our calendar today. I would call your attention to Item 1-1, which has been tabled until later in today's session. Leadership agreed that legislation should be allowed in through the two-thirds route on the floor to deal with this problem of retiree's cost of living increases. In fact, the statute implies that we will address ourselves to this every year.

The vehicle, however, I believe, is very important and we are suggesting that the least partisan route be taken and thus I call your attention to Item 1-1, which the gentleman from Farmington is intending to amend here today. So, I would hope that we could consider these two vehicles in that light equally and would hope that someone would table until later in today's session the Order introduced by the

gentleman from Augusta. The SPEAKER: The Chair recognizes the gentleman from Lisbon Falls, Mr. Tierney.

Mr. TIERNEY: Mr. Speaker, Men and Women of the House: I, too, would like to proceed in as non-partisan manner as possible on that marvelous Item 1-1 on today's calendar. which was sponsored by the Senator from Kennebec, Senator Katz; the Senator from Kenne-bec, Senator Ault and the Senator from Kennebec, Senator Teague; and the Senator from Kennebec, Senator Pierce. I also agree with him that we should probably try to seek a bipartisan approach to this problem and I agree with him and I do hope that someone would make that motion.

Thereupon, on motion of Mrs. Mitchell of Vassalboro, tabled pending passage and later today assigned.

Mr. TIERNEY: Mr. Speaker, Men and Women of the House: The Order is cosponsored by my good friend from Cumberland, Mr. Garsoe, and he and I and the rest of leadership have discussed in some detail the questions of the pending issue which we referred to the Committee on Elections yesterday. We felt that the committee should be given some budget. It is a very complicated, very confusing legal question without precedent in Maine dealing with the residency of a person since the advent of the single member districts. We would hope we would be able to put the issue to rest not just in the case of the Biddeford seat, but also to put it to rest for future purposes as well. Hopefully, we can get some precedence which will guide future legislatures, and that is why we felt some modest appropriation would be necessary.
