#### JOINT RESOLUTION HONORING BENJAMIN JOSIAH DORSKY AS PRESIDENT OF THE MAINE AFL-CIO

WHEREAS, Benjamin Josiah Dorsky immigrated with his family from Russia to Maine in the early 1900's; and

WHEREAS, Benjamin Josiah Dorsky joined the Theatrical Stage Employees and Moving Picture Machine Operators' Union, Local 198, in 1920 as a freshman in high school, and

WHEREAS, Benjamin Josiah Dorsky has served as legislative agent for the Maine Federated Labor Council since 1933; and WHEREAS, Benjamin Josiah Dorsky organ-

WHEREAS, Benjamin Josiah Dorsky organized and served as the first President of the Bangor Central Labor Council in 1935; and WHEREAS, Benjamin Josiah Dorsky has served as President of the Maine Labor Coun-

WHEREAS, Benjamin Josiah Dorsky has served as President of the Maine Labor Council, American Federation of Labor, since 1937, and the Maine Federation of Labor Council, AFL-CIO since 1956; and

AFL-CIO since 1956; and WHEREAS, Benjamin Josiah Dorsky served with singular distinction during a lifetime of dedicated service to working men and women; and

WHEREAS, Benjamin Josiah Dorsky is retiring in February of 1979 and leaving as a legacy a benchmark against which all future labor leaders shall be measured; now, therefore, be it

RESOLVED: That We, the Members of the 109th Legislature assembled in the first regular session, extend our heartiest congratulations upon this great occasion; and be it further
