Everett Wellington Cary, better known as "Eb" Cary, was born January 19, 1879 in Elgin, New Brunswick, Canada. He came to this country three months later.

Everett attended schools in Washburn. He was a natural skater, and skated, swam, fished the Aroostook River. He loved baseball and still does to this day, he is a great Red Sox fan.
The first President that "Eb" voted for was "Teddy" Roosevelt, and had voted straight Re-

publican, until the now President Carter, captured his vote in the last Presidential Election.

He married Flora Kennard, in 1921. They have one daughter, Ernestine Cary Buckley, and two sons, Everett, Jr. and Dwight.

He was a well-known potato starchmaker, woodsman and farmed. He joined the Odd Fellows Lodge in 1905 and the Masons in 1918. He has been a member of the Washburn Lodge for sixty-one years

During his lifetime he saw many firsts come to Washburn: the telephone, the Bangor and Aroostook Railroad, the Aroostook Valley Railroad, electric lights, the telegraph and automobiles. Congratulations, Eb, from the Maine Legislature and Staff. Thank you. Which was Passed.
