The PRESIDENT: Is it the pleasure of the Senate to accept the Majority Ought Not to Pass report of the Committee?

The Chair recognizes the Senator from Androscoggin Senator Minkowsky.

Senator MINKOWSKY: Mr. President and Members of the Senate: I have been evaluating, analyzing this particular document as it has been before us, the past, at least three sessions. My personal opinion is that the people of Maine should have an opportunity to vote on this particular issue.

The sentiment of the people, has already been expressed, on a TV Poll I came across recently, which is basically non-official, but by a 4 to 1 margin. Presently, there are safeguards that are built into our very comprehensive Judicial System in Maine, which protect the rights of murderers.

As you are aware, there are several states that have the death penalty provision, and have inmates on death row. To the best of my knowledge, there has been no mistakes made, insofar as, executions of these individuals.

My concern today is as a father and a citizen

of this State. I am convinced that all the Federal dollars and State dollars that have been poured into our so-called rehabilitation system of criminals are just wasted tax dollars.

Have we addressed here in the State of Maine, the so-called term that's been used, "Hit Men" who are hired to kill or do we feel that we are immuned from this particular category of individual? What about the several police officers who have lost their lives? Do we just pay their widow a pension and forget about that particular point?

What the Legislature has said in the past, is to protect the rights of a criminal. Send him or her to jail for life and reduce their sentence for good behavior. Allow some of these perverted individuals to matriculate back into our society and prey again upon our citizens of this State.

I know from inquiries I have made that the people of Maine want to vote on this particular issue as they have over the years on several other issues. Mr. President, I would ask that a Roll Call be taken on the pending motion.

The PRESIDENT: A Roll Call has been requested. Under the Constitution in order for the Chair to order a Roll Call it requires the affirmative vote of at least one-fifth of those Senators present and voting.

Will all those Senators in favor of ordering a Roll Call, please rise and remain standing until counted.

Obviously, more than one-fifth having arisen a Roll Call is ordered.

The PRESIDENT: The Chair recognizes the Senator from Hancock, Senator Perkins.

Senator PERKINS: Mr. President, I wish permission to pair my vote with the gentle lady from Cumberland Senator Clark. Were she here, she would be voting Nay, and I would be voting Yea.

The PRESIDENT: The Senator from Hancock, Senator Perkins, now Requests Leave of the Senate, to pair his vote with the gentle lady from Cumberland, Senator Clark. If she were here, she would be voting Nay, and the Senator from Hancock would be voting Yes. Is it the pleasure of the Senate to grant this leave? It is a vote.

The PRESIDENT: The pending question before the Senate, is the acceptance of the Majority Ought Not to Pass Report of the Committee.

A Yes vote will be in favor of accepting, the Majority Ought Not to Pass Report.

A Nay vote will be opposed.

The Doorkeepers will secure the Chamber.

The Secretary will call the Roll.

Senator PERKINS: Mr. President, I wish the record to show, the Senator from Cumberland, Senator Clark, would vote Yes and I would vote No.

The PRESIDENT: The record will so indicate.

16 Senators having voted in the affirmative and 12 Senators in the negative, with 2 Senators pairing their vote, and 2 Senators being absent, the Motion to Accept the Ought Not to Pass Report does prevail.

The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator KATZ: Having voted on the prevailing side, I now move reconsideration.

The PRESIDENT: The Senator from Kennebec, Senator Katz, now moves that the Senate reconsider its action, whereby it accepted the Majority Ought Not to Pass Report of the Com-

mittee.

The Chair recognizes the Senator from Androscoggin, Senator Minkowsky.

Senator MINKOWSKY: Mr. President, I move this item be tabled for one legislative day, pending the motion by the Senator from Kennebec, Senator Katz.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Conley.

Senator CONLEY: Mr. President: I request a Division.

The PRESIDENT: The Chair recognizes the Senator from Oxford, Senator O'Leary.

The Chair recognizes the Senator from Cumberland, Senator Conley.

Senator CONLEY: Mr. President and Members of the Senate: This order has been on the table for some time now, I wonder if the Secretary might Read the Joint Order.

Which was Read.

The PRESIDENT: Is it now the pleasure of the Senate that this Joint Order be Indefinitely Postponed?

It is a vote.

On motion by Senator Katz of Kennebec, the Senate voted to take from the table:

SENATE ORDER—relative to 800 telephone number

Tabled—January 11, 1979 by Senator Katz of Kennebec

Pending—Passage.

The PRESIDENT: The Senator has the floor.

Senator KATZ: Mr. President. This Joint Order—this Senate Order which confused me for a moment being a Senate Order because normally we attempt to do things in a Joint basis, seeks to install an 800 Telephone for the benefit of constituents during the Legislative Session.

Upon review of the costs, we found that the cost of a single 800 is about \$600. per month. With respect to our Legislative incoming phone calls, we found that it was almost useless, because so many of you complained that one line was not doing it. You were getting a lot of busy signals. We are now up to two, which is \$1,200 a month. If we hear more complaints it might very well be, that it will be up to 3.

There are an increasing number of 800 telephone lines within the State House Complex, Department of Human Services, other departments have them, and it was the feeling that additional expense just during the legislative session would be inappropriate.

I move that this Senate Order be Indefinitely Postponed.

The PRESIDENT: The Chair recognizes the Senator from Washington, Senator Silverman.

Senator SILVERMAN: Mr. President and Members of the Senate: This was an Order which I placed before the Senate. I am quite certain that many of you found it agreeable.

The Senate, I think, should come into the year 1979, and recognize that communications are important with our constituents. An 800 number, in the year 1979, is important in most businesses, in most government and in most major areas of concern with the public.

I was very surprised that the Majority Floor-leader would stand here and say we cannot afford it. \$15,000 a bed in Thomaston and we can not afford \$3,600 for a telephone number, so that our constituents could call us.

I understand also what has controlled this Senate over the years. The corporate heads can call it tax deductible. The City Managers can call, it is not an expense to them. But when the public wants to call the Senate, are we going to deny them an 800 number to call free of charge because of an expense they say is a little too large.

For me, it is not the expense, the reason that they want to kill this bill. For me, it is those who control this Senate body don't want the people to have a way into the Senate. Most people working haven't time to be here, but they do have time to pick up a telephone; whether you are in Washington County, or Somerset County or Cumberland County, and call their Senators on important matters facing this body. In front of me I have a partial list of the 800 numbers that we afford in State Government. Areas like Agriculture, Children's Emergency, Citizens' Assistance, Committee on Aging, Education, Environmental Protection, Food Stamps, Human Services, Inland Fisheries and Wildlife, Motor Vehicle, State Police, Taxation Administration and Veterans Affairs. There are certainly many others that have 800 numbers that we can afford in our government.

I am certainly sure that we can afford, for this honorable body, the Senate of the State of Maine, to have an 800 number for their constituents. I will ask for a Roll Call vote. I only hope that you people will understand your constituents, may come first, finally in this Senate body.

The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator KATZ: Mr. President. I am impressed by the remarks of the Senator from Washington, Senator Silverman.

I would like to charge him, however, gently, that probably he did not mean to impugn the motives of those of us who oppose this Senate Order.

The PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator CARPENTER: Mr. President and Ladies and Gentlemen of the Senate: I think that I use that 800 number, the two 800 lines that we have coming into the State House, probably more than anyone else when we are not in session.

I would support the Senator from Washington, Senator Silverman, on his opposition to this motion. But perhaps politics being the art of compromise, if this order does die and the 800 number does die, I would appreciate it very much if somebody might look into the possibility of whatever technical changes might be necessary to switch one of those 800 lines that we have to an 800 number for our constituents while we are in session.

Hopefully, those 800 numbers that we use when we are home are very inactive at this point since we are all down here, anyway, most of the week. Why not switch over to a constituent line since one of those lines does not work anyway, never has worked, properly? If you want to get cut off, you want to call in on the #2 line over there. It is guaranteed that you will lose your call.

But while we are down here why couldn't we switch over that line, if this order should happen to die? I think that when you come from as far away from the State House as I do, and when you handle the volume of constituent work that many of us do, especially when we come from outside of Kennebec County, that an 800 number would be most important, not only to allow our constituents to express themselves on the various issues that are in the headlines every day and on the daily news, but also to get in touch with us as far as little constituent matters.

I would certainly hope that one way or another we might allow some easier access to us, by our constituents. Thank you.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Conley.

Senator CONLEY: Mr. President and Members of the Senate: With respect to the Senate Order before us this morning, it does seem to me that we are being somewhat penny wise and dollar foolish.

It seems that we are in Legislative Session for 100 Legislative days in the first regular session. We are in 50 days in the second session.

I know that many of us if we are sitting at home in the evening, we are really, pestered to death, with the number of commercials that come over the TV Set during that evening. It is incredible the 800 numbers that are floating across the bottom of the screen to call immediately, to take advantage of this great deal that is being offered the public, and it is free of cost allegedly. We know that when you purchase the product that you are obviously—you are making some type of payment for it.

Well government should be accessible to the people. I know that the one 800 number that we have to call the State House rather than using our credit card number that we have, again to try and keep the expenses down; you have great difficulty sometimes getting through. When you do get through they ask who's calling, and you have to give your name as Senator Conley or Representative so and so.

It just seems to me that some of the things that the good Senator from Washington, Senator Silverman, are saying is true. People in business do not have any real problem about reaching the State House, but the average guy on the street wants to make a phone call and he wants to get in touch with one of us, he pays New England Tel. and Tel. for that call.

I think that government's role is to provide service to the people, and I do not think that that cost of an 800 number being open to the citizens of this State, regardless of how often it would be used, would be any great cost to us. Therefore, I would oppose the motion to Indefinitely Postpone this order.

The PRESIDENT: Is the Senate ready for the question?

A Roll Call has been requested.

Under the Constitution, in order for the Chair to order a Roll Call it requires the affirmative vote of at least one-fifth of those Senators present and voting.

Will all those Senators in favor of ordering a Roll Call, please rise and remain standing until counted.

Obviously more than one-fifth having arisen a Roll Call is ordered.

The pending question before the Senate is a motion by the Senator from Kennebec, Senator Katz, that the Senate Indefinitely Postpone Senate Order, relative to the 800 Telephone Number.

A Yes vote will be in favor of Indefinite Postponement.

A Nay vote will be opposed.

The Doorkeepers will secure the Chamber.

The Secretary will call the Roll.

JOINT ORDER—relative to Study of Correctional Systems. (H. P. 75)

Tabled—January 16, 1979 by Senator Katz of Kennebec

Pending—Passage.

The PRESIDENT: The Senator has the floor.

Senator KATZ: Mr. President: The Senate will remember that this was a rather lengthy order which came immediately upon the formation of a Select Committee on Correctional Institutions.

Upon reading it, it was an extremely broadly drafted thing that involved a series of studies, of studying studies, of involving such people as Common Cause and other groups. At the time, it seemed to be extraordinarily broad and we have discussed it at some length prior to dealing with it.

You will notice that earlier today, we took a bill that had been referred in the other body to the Select Committee and we referred it to the Committee on Health and Institutional Services. It was our understanding, and it will be our intention that the Select Committee on Correctional Institutions deal with one or two major bills and that is the extent of the involvement of the Committee. That was the basis on which the Committee was founded and it was based on this representation that we have recruited some pretty top people in the Legislature to serve on the Committee.

I call to the Senate's attention the fact that the Senator from Hancock, Senator Perkins, who has a very, very heavy burden of Committee work, being on two very important and busy committees, selflessly accepted the task of heading this Select Committee based upon the representations that we made to him. On that basis, I feel that this is an extraordinary broadening of the intent of this Committee and, consequently, I move for the Indefinite Postponement of this Joint Order.

On motion by Senator Conley of Cumberland, tabled for 1 Legislative Day, pending the motion by Senator Katz of Kennebec to Indefinitely Postpone.

Committee on State Government suggested.

The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator KATZ: Mr. President. As we changed our Committee structure this year, we ran into some rather unexpected problems, out of the corner of our eye, because certain Committees which have confirmation responsibilities, no longer exist, or exist under a different title.

For example the Committee on Liquor Control is no more. The Committee on Veterans and Retirement, is now the Committee on Aging, Veterans and Retirement. Yet within our statutes, those committees are specifically singled out for confirmation responsibilities.

This Bill, which I am presenting on behalf of the Joint Leadership of both houses, makes it very, very clear that many confirmation responsibilities that might have been assigned to Liquor Control for example, are now going to Legal Affairs.

You will get a chance to see this Bill in print well before you're called upon to enact it. But it is completely a non-controversial housekeeping, clean-up, of our language in the confirmation area.

Therefore, I move Mr. President, that this bill be given its first reading, without reference to committee.

The PRESIDENT: The Senator from Kennebec, Senator Katz, now moves that (S. P. 99) be given its first reading at this time without reference to Committee. Is this the pleasure of the Senate?

It is a vote.

The Bill, Read Once.

Under suspension of the rules, the Bill given its Second Reading and Passed to be Engrossed, without Reference to Committee.
