Dear Senator Gill, Representative Prescott, and Members of the Committee:

\$ 2147, Chapter 464, P.L. 1977 as enacted by the 108th Maine Legislature requires the Bureau of Mental Retardation of the Department of Mental Health and Corrections, to prepare a plan which "indicates the most effective and efficient manner in which to implement services for mentally retarded persons while safeguarding and respecting the legal and human rights of these persons."

The Statute further requires that such plan must be prepared biennially and submitted to your Committee no later than January 15th of

every odd-numbered year.

I am submitting this letter and three attached documents in fulfillment of the above

statutory requirement.

The first attachment is a report divided into four subsections for review of the Committee. The four subsections include: 1) Key Legislative Developments During the Past 18 months, 2) Plan for Provision of Services 1979-1980, including Legislative Proposals, 3) Plan for Pineland Center, 1979-80, and 4) Issues Which May Require Attention by the 109th Legislature.

The second and third attachments are Appendix "A" and Appendix "B", respectively, of the Pineland Consent Decree which was signed by all parties and entered by the Federal Court effective July 14, 1978. Since these Appendices are extremely specific in the delineation of requirements placed on the State of Maine, and since both services at Pineland and throughout Maine are covered by this Consent Judgment, these Appendices reflect the major plans and direction for services to Maine's retarded over this Biennium. The Consent Decree incorporates as well the language and goals of 34 MRSA Chapter 186-A and 34 MRSA Chapter Pt. 4-A Chapter 221 ff. which were enacted by the 108th Maine Legislature.

A related, and important part of this plan will be the budget request authorized by the

Governor in the coming weeks which shall be necessary to continue to provide needed care and services to Maine's mentally retarded per-
