February 27. 1979 Senate called to Order by the President.

Prayer by Reverend Edward Merrill, Penney Memorial Church, Augusta.

Reverend MERRILL: Let's pray together. Father we again, thank you for this day, for the beauty that you create each day, in our own lives. We thank you, for your providence, your care for all of your creation.

#### Recess

#### After Recess

The Senate called to order by the president.

The PRESIDENT: Is it now the pleasure of the Senate to Suspend its Rules, in order to take up an additional paper, Out of Order?

The Chair recognizes the Senator from Cumberland, Senator Conley

Senator CONLEY: Mr. President, I would pose a question to the chair, are we talking about Supplement Number 1?

The PRESIDENT: The Chair would answer in the affirmative

Senator CONLEY: Mr. President, I would oppose Suspending the Rules, and when the vote is taken I ask that it be taken by the Yeas and Navs

The PRESIDENT: A Roll Call has been requested. Under the Constitution, in order for the Chair to order a Roll Call it requires the affirmative vote of at least one-fifth of those Senators present and voting.

Will all those Senators in favor of ordering a Roll Call. please rise and remain standing until counted.

Obviously more then one-fifth having arisen a Roll Call is ordered.

The pending question before the Senate is Suspension of the Rules.

A Yes vote will be in favor of Suspending the Rules

A No vote will be opposed.

The Doorkeepers will secure the Chamber. The Secretary will call the Roll. **ROLL CALL** 

YEA – Ault, Chapman, Collins, Emerson, Gill, Huber, Katz, Lovell, McBreairty, Perkins, Pierce, Redmond, Shute, Silverman, Sutton, Trotzky.

A Roll Call was had.

16 Senators having voted in the affirmative and 13 Senators in the negative, with 3 Senators being Absent, and 16 being less than two-thirds of the members present and voting, the Rules are not Suspended.

Senator Katz of Kennebec was granted unanimous consent to address the Senate, on the Record

Senator KATZ: Mr. President, the path that was chosen by the Minority Party this morning, is a dangerous path. It might possibly suit your purposes this morning, to prevent the Senate from considering this Joint Order, it will be on the Calendar tomorrow morning, without Suspension of the Rules. There was a courtesy involved, because the sponsor will not be here tomorrow.

I am not quite sure what was gained by preventing the Suspension of the Rules, but what does concern me, even more, is an attempt to muzzle the Legislature, from doing the job that it was elected to do.

There are only two ways to amend the United States Constitution. Either through a Congressional origination or through the procedure which we are attempting to bring before the Legislature for debate. I have personally grave doubts about the wisdom of passing this Resolution

That is not the issue, the issue is the right and the duty of the Legislature, faced by a Resolution which was introduced in a timely manner, long before cloture, drafted by the sponsor, presented by the sponsor and in what I consider to be an arrogant exercise of improper leadership, the Legislature has been precluded from even debating the question. A question on which I probably will be on the side of most members of the minority party.

I think that it was bad judgement this morning, and I hope that when the vote is taken on the Resolution tomorrow, the Minority Party will realize that what we are talking about is not the basic question as to whether or not we should have a Constitutional Convention in Washington, or whether you have any fears about the possibilities of a run-away constitutional convention. The issue is quite different from that, the issue is the right of a sponsor of a piece of Legislation, who has sponsored something in a timely manner, that is appropriate before the Legislature to have it dealt with by Leadership.

For those of you who weren't here, let me refresh your memory as to the reason for the Joint Rule, that says that Leadership or the Legislative Council has to vote on this. During the Vietnam War, we were deluged with some rather serious, but overwhelming number of foreign policy resolutions. We were overwhelmed with policy Resolutions; which would condemn this group or that group; which express our outrage at the slaughter of Baby Seals; and a whole bunch of issues over which we have no responsibility and no influence.

But when we talk about Resolutions which express the desire of this Legislature to partition Congress, in a manner consistent with the United States Constitution and subsequently as things come along pertaining to such other appropriate measures as the attitude of this Legislature on Dickey-Lincoln; the attitude of this Legislature on the question that I understand is going to be proposed with respect to a Right to Life Amendment to the Constitution, I think that it is extremely short sighted of our body, or of leadership to exercise and flex its muscles and to keep these measures from properly being debated.

I chide the Democrats this morning, I think that the decision was an unwise decision and I hope that you reconsider by the time that this comes up in the calendar tomorrow. Senator Conley was granted unanimous con-

sent to address the Senate, on the Record. Senator CONLEY: Mr. President, and Members of the Senate. I have served in the Legislature, for a number of years and I have always

been interested in what the good Senator from

Kennebec, Senator Katz, has to sav But I would call your attention to Joint Rule 35. Which clearly states "Memorials. No Memorial shall be in order for introduction unless approved by a majority of the Legislative Council." This particular order that is before us today, states very clearly again a Joint Resolution Memorializing Congress to call for a Constitutional Convention for a specific purpose

Now if you take and read the order, the order is directing the Legislative Council to sign, or a majority of the Legislative Council to sign. this Resolution Out. It has been well known for 1, 2. 3 weeks as far back as when Senator Trotzky. the good Senator from Penobscot, initially presented it, walked around both chambers, the House and the Senate trying to obtain the necessary signatures, we stated flatly that we were opposed to it.

Now all this Order is today that we rejected. is a run through the backdoor. First of all it has absolutely no strength, no merit, if you want to have it introduced, then you had better Suspend Joint Rule 35, or Repeal Joint Rule 35. so long as I am sitting in this seat and I have the right to make a decision with respect to any Joint Resolution Memorializing Congress, I intend to weight it. When we get into the areas of Constitutional Convention, for whatever matter it may be, I will not put my signature on it. So if you want to change Joint Rule 35, then I suggest that you attempt to do that.

Senator Trotzky of Penobscot was granted unanimous consent to address the Senate. On the Record

Senator TROTZKY: Mr. President and Members of the Senate. I know that there is a great deal of concern on behalf of members of the Democratic Party and some members of my party, concerning a Constitutional Convention.

Consequently, what this order does is it directs the Legislative Council, to pass this Me-morial Out, but not to pass it directly to the floor of the House and Senate. To pass it to the Judiciary Committee so that it can get at least a Public Hearing, so that we can have both sides of this issue heard.

That is the reason for this Joint Resulution. because esstentially what it does is it does not say reported out to the floor, it says "Reported out to a Committee for Public Hearing." To back it up, give the people of the State of Maine, a chance to make their concerns heard.

The President would ask the Sergeant at Arms to escort the Senator from Oxford, Senator O'Leary, to the rostrum to assume the duties of the President Pro-Tem.

The Sergeant at Arms escorted the Senator from Oxford, Senator O'Leary to the rostrum. where he acted as President Pro-Tem.

The President then retired from the Senate Chamber.
