Senator PRAY: Mr. President, and Members of the Senate. To explain the 3 reports, for those of you who may not be aware of what the differences are.

Starting at the top with Report "A", with Committee Amendment "A" signed by the Majority of the members of the Committee, is a amendment to the Bill which would require a \$3.10 minimum wage effective October 1st of this year, that will precede the increase of the Federal Minimum Wage which will go in effect January 1, of next year to \$3.10. This is a procedure that we have done two of the last three times.

Report "B" speaks for itself.
Report "C", the original bill, calls for a \$4.
minimum wage, with no ceiling. I should regress back to Report "A" at this time, that on Report "A" we also addressed the ceiling and we put the State Minimum Wage Ceiling at \$4, presently the State Minimum Wage, has a ceiling of \$3. If we do not increase that ceiling effective January 1, of next year when Federal Minimum Wage goes to \$3.10 State Minimum Wage will go to \$3. and stay there, so we have a complexity of issues here to discuss

I think it should be understood that while there may be an amendment offered to Report , which could call for the process which we ran through a few years ago when we discussed minimum wage. I think there were a series of amendments at 5¢ increments, and I would hope we would not have to go through that this year, and I would hope the intent of the Assistant Majority Leader the good Senator from Kennebec, Senator Pierce, is not hoping the same route will follow suit tomorrow. I for one am going to support, Report "C", with the understanding hopefully we will in the end, end up with Report "

The PRESIDENT: The Chair recognizes the

Senator from Aroostook, Senator Carpenter. Senator CARPENTER: Mr. President, and Ladies and Gentlemen of the Senate. I would move for the Indefinite Postponement, of this Bill and all of its accompanying papers, and I would ask for a Division on the vote.

There is a bit of dissension among the county delegation as to whether this should go or not, for those of you unfamiliar with Aroostook, my home town of Houlton happens to be the County Seat, which is where the Probate Office is with a nice secure vault and everything nice and secure. Presently unlike what the statement of fact says, presently, the Probate Court is holding hearings in Caribou I believe two or three times a year, and in Fort Kent once a year.

Supposedly according to the Registrar of Probate, there is no need for any more in Fort Kent, when they go into Fort Kent to hold their hearings, now, there are very few cases, most of the attorneys would rather come to Caribou. the facilities are better and what not. I just do not see the need of this bill, and it concerns me a little bit. that we are going to be hauling, what are basically very important and very sensitive records a great deal of distance, as mandated by this particular Law. I suppose that it is something that we can live with if it goes through, but I would hope that you would join me this morning in voting to Indefinitely Postpone this Bill.

The PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Martin.
Senator MARTIN: Mr. President and Ladies and Gentlemen of the Senate. L. D. 320, a Bill, which is sponsored by myself and the Senator from Aroostook, Senator McBreairty, simply allows Judge of Probate to hold Court twice a year in Fort Kent. Maine and four times a year

in Caribou.

Presently depending on where the Judge of Probate is, but assuming that he was from Fort Kent, he could theoretically hold every one of them in Fort Kent, if from Caribou likewise. Probate Court on an annual average is probably held thirty to forty times a year.

The security of the documents, are obviously quite secure, they are in a vault accompanied by the Registrar and the Judge. I would request a Division on the pending motion, also I would remind the good Senator my colleague from southern Aroostook, Senator Carpenter, that the Bill came out of Committee Unanimous Ought to Pass, to my knowledge he is only one in the delegation that has opposition to it, to my knowledge.
The PRESIDENT: The Chair recognizes the

Senator from Aroostook, Senator McBreairty. Senator McBREAIRTY: Mr. President and Members of the Senate: As Senator Martin has already stated, I am co-sponsor of this Bill.

It is 140 miles from Allagash to Houlton, if

holding Probate Court, part-time in Fort Kent and part-time in Caribou, prevents the need for people to drive 140 miles to attend Probate Court it not only should be convenient, but also should save considerably on energy, and should be a step in the right direction, 50% of the Aroostook population lives within a few miles of Caribou

The PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter. Senator CARPENTER: Mr. President, just

to clear up a couple of points, first of all, this in not permissive legislation it would not simply allow, it would mandate, what is being done now, continue to be done, there are at least three other members of the County Delegation, none of them happen to be members of this Body who are opposed to this Bill. I just want to clear up those two points, I would ask for a Division
