Senator PRAY: Mr. President, I would like to pose a question through the Chair to somebody on the Judiciary Committee, if they could explain the Bill and what the amendment does

The PRESIDENT Pro-Tem: The Senator from Penobscot, Senator Pray, has posed a question through the Chair, to any member of the Senate who may care to answer.

The Chair recognizes the Senator from Knox. Senator Collins.

Senator COLLINS: Mr. President, the title of this Bill as it stands is not completely accurate. The original Bill, would have permitted the use of deadly force, in defense of property in all kinds of situations. We permit the use of deadly force, now with respect to protecting the home, and with respect to protecting the person.

The Bill, as amended, simply extends the permissive use of disabling chemicals. The common chemical in use in known as Mace. At the present time, it would not be legal to use Mace for the purpose of defending property, in

your store for example.

The effect of the Bill, as amended, would be to permit a store owner, or motel owner, or anyone protecting property outside of their own home, to use Chemical Mace, to protect that property. They may of course, use Chemical Mace now to protect human beings, but suppose a scrawny unarmed individual came into a store and demanded the proceeds of the cash register, if the person behind the cash register, had a can of mace handy, and we pass the amendment, he could pick it up and use it on that individual, even though there was no danger to human life. So that would be the result of this Bill, if we should pass it.
