Senator from Penobscot, Senator Devoe. Senator DEVOE: Mr. President. I have looked at this L.D. and it seems to me, to be a back door way of laying on the shoulders of the Commission the task of determining what Legislators should be paid. In addition to Legislators, there is a provision for the Commission to study and provide recommendations for the compensation of Attorney General, Secretary of State, the Treasurer of State and the State Auditor.

In my opinion this is strictly Legislative business and need not be taken care of by a newly created State Compensation Commission, for that reason, I move the Indefinite Postpone-ment of this Bill and all of its accompanying

papers. The PRESIDENT: The Senator from Penobscot, Senator Devoe, now moves that L. D. 523 be Indefinitely Postponed.

The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator MARTIN: Mr. President and Ladies and Gentlemen. On the Bill, I would inform the good gentleman from Penobscot, Senator Devoe, that this was a unanimous Ought to Pass Report out of the State Government Committee.

I could think of no better way to increase or to review the Legislative per diem and salaries of Constitutional Officers, than too get input from members of the public. A Commission in the past has been very successful and has worked, I would therefore, Mr. President, oppose the pending motion. The PRESIDENT: Is the Senate ready for

the question? The Chair will order a Division. The Chair recognizes the Senator from Knox, Senator Collins

Senator COLLINS: If I recall correctly, there was a similar commission established by the 106th Legislature or thereabouts. I have heard the Senator from Cumberland, Senator Conley, say who is one of our veterans, with a very good memory, tell us we have never paid very much attention to the report of that Commission.

I would like very much to hear from some person who lived through that era tell us whether that sort of Commission has any impact on the Legislature? How long it takes to perform, and whether it is considered by you veterans a really worthwhile exercise in State Government?

The PRESIDENT: The Senator from Knox, Senator Collins, has posed a question through the Chair to any member of the State Government Committee or other interested Senator who may care to answer.

The Chair recognizes the Senator from Cumberland, Senator Conley.

Senator CONLEY: Mr. President and Mem-bers of the Senate. I hate to put myself in the class that is looked upon as a professional politician in a sense. But I will state that I believe anytime we get a report from a commission or from any other independent board, that has been devised, what we do is we generally use what is present to us and work from that.

Perhaps, a good case in point, would be the most recent labor contracts that has been negotiated over the last 17 months, by the former governor and his administrative officers who sat through negotiations. As a result of alleged-ly a very long and arduous period of negotiations, they finally went to fact finding, and the fact finders report was a unanimous report. It was sent back to the state employees as well as the administration and they worked from that report. It is my understanding that the most recent date anyway that the negotiating team as well as the bargaining team on the part of the State, have come into full agreement and will be submitted to the employees now for their approval.

I think these reports do have some meaning, it is true that not on all occasions that a 1007 adoption is made, but I do believe it gives us an area to work from, therefore, I think that the Bill before us does make some sense.

The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator KATZ: Mr. President, I too recall the previous recommendations from a commission and they were a point of departure, even as any LD dealing with Legislative pay and expense is always merely a point of departure, it is never accepted as it is.

One might ask before we create a new commission with a price tag, you will notice that there is an appropriation on this thing, whether there is an overriding need to spend this money for a point of departure.

When I saw the Bill this morning I certainly was not going to lash out at it, but I have very very serious misgivings as to whether or not the money that we spend is going to buy us something that is absolutely essential, for the taxpayers of Maine

The PRESIDENT: The Chair recognizes the

Senator from Cumberland, Senator Conley. Senator CONLEY: Mr. President, It is my understanding that the price tag for this piece of Legislation is \$1,800. Certainly not a great deal of money, when we talk about the overall, expenditures of the total state budget. it would also seem to me that if the Bill was put into a second reading, and if some members of the Body felt that that was too much money then they obviously could narrow it down. The PRESIDENT: The Char recognizes the

Senator from Oxford, Senator Sutton.

Senator SUTTON: Mr. President. Just briefly as a member of the Committee, I would just

like to second Senator Martin's remarks. We did discuss this and felt that the money was rather small, and that the Commission, al-though I have not had the experience of know-ing how commissions do perform might aid a little in putting together the salary numbers.

Senator CONLEY: Mr. President, I would pose a question, again through the Chair, as to whether any member of the State Government Committee has reviewed this with the Attorney General's Office, as to whether or not this could be done statutorily?

The PRESIDENT: The Senator from Cumberland, Senator Conley, has posed a question through the Chair.

The Chair recognizes the Senator from Aroostook, Senator Martin. Senator MARTIN: Mr. President and Ladies

and Gentlemen of the Senate. In response to the inquiry of the good Senator from Cumberland, Senator Conley. Yes we did check this out and statutorily the Bill would be absolutely meaningless. One Legislature can not be re-sponsible for the forthcoming or official legislatures

The PRESIDENT: The chair recognizes the Senator from Knox, Senator Collins. Senator COLLINS: Mr. President. There is

one matter in this order of sequence that bothers me, I studied the Constitution vesterday, and I would hope that by the time we come to enactment on this there might be read into the record, the Committee's perception of this problem.

This Legislature, the 109th, is here under the old provisions of the Constitution, because the Governor did not see fit to announce the results of the November election in time for operation of the change we enacted last fall. Therefore our term as Legislators commences from Jan uary and the constitutional provision under which we were elected says that we serve for 2 years. Now 2 years would take us to January 1981, if we adopt this change that says we are going to do certain things in December of 1980 as the 110th Legislature. I am not quite clear what happens in the period between the first week of December when the 110th Legislature supposedly sits, and the first of January when supposedly the terms of our 109th Legislature end

Now probably, the answer is our terms just get bobtailed by those 3 or 4 weeks, but I think if that is so, there ought to be a Legislative Record, created at least by statements on the floor, so when the Attorney General's Office is asked this question, a year and a half from now, and the question of who is supposed to confirm the Governor's nomination, between the first of December and the first of January comes up we will have a little basis for an answer here Perhaps the Committee already knows that, if so, I hope they will offer it into the record at a later time. Thank you.
