Senator O'LEARY: Mr. President, I would

ask for a Division, on the Motion and I would like to briefly explain what is happening in this

We are talking about adding an additional 31/2 feet to the cab, not to the box. The amendment that is before you H-124 clarifies that part of the law that says 45 feet.

In the Statement of Fact, it is pretty clear what this Bill is all about. It is to authorize the use and operation of the standard size conventional twin axle tractors, in order to operate within the law, now they are not conventional, they are special built and it does cause an additional expense to the purchasers of these cabs.

Additionally this extra length will provide greatest stability and roadability, in the handling of the unit and at the same time the distribution of the load by moving the fifth wheel back, will help with our break down of our highways and so I think that it is a good Bill, and I

hope that you will vote to keep this Bill alive.
The PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Minkowsky

Senator MINKOWSKY: Mr. President and Members of the Senate.

I would hope that you would support the Motion to Indefinitely Postpone this Bill, as projected by Senator Hichens of York.

Yes, we are speaking of the cab, increasing its length three and a half feet, but I am concerned with the overall length of the box and cab, which brings it up to 60 feet. I am also concerned, Mr. President, with the other section of the Bill which is under Section B which says. if a unit was used exclusively for transportation of tree length logs they may extend beyond the 60 foot limit by 8½ feet provided that not more than 25% of the length of the logs shall extend beyond the body of this vehicle combination, which then brings it to 681/2 feet

My major concern, Mr. President, and Members of the Senate was for the safety of the

people of the State of Maine.

Since there has been such a howling cry about the deterioration of our Secondary Roads, that are utilized by these large trucks, all I can see is an additional expense, to the taxpayers in the State of Maine for rebuilding these roads.

You may remember that 2 years ago, we had quite a controversy about the pulp trucks, the new modern pulp trucks which were costing anywhere from 48 to 60 thousand dollars, and the so-called proper distribution of weight; but the truck weight itself was almost 1/2 the amount of the truck load which meant that in order to qualify so the roads in the State of Maine could handle that particular load of wood that they would have to carry only 1/2 the amount of a load of wood on that particular truck to the pulp mills. There is a very serious inconsistency between the trucking industry and the pulp industry, relevant to that particular aspect using the same roads in the State of

Now if we were to say that these large trailer trucks with the 45 foot box and the balance being the cab itself were to be kept on I-95 or on the turnpike, I do not think that many of us would have much objection. But where the taxpayers of the State of Maine have to pick up the additional costs and since the Department of Transportation has projected that they are in dire need of more money. In fact this morning there was a proposal of changing the gasoline tax, or the excise tax or the sales tax, which more or less proves the fact that they are in dire need of money for maybe, I say, primary road reconstruction or repair. I think that we are moving in the wrong direction by allowing this increase in length.

It says in the statement put out by the industry apparently, we in Maine need this law only to stay competitive with the trucking industry.

I do not think that many other states have the same problem with deterioration of roads that we have here in the State of Maine with the seasons we have, where very serious breaking of these roads is materializing at the present

Again the Federal Law comes in to play in the second paragraph. They say that we need this Bill in order that we may be able to better and more evenly distribute weight and loads throughout the tractor trailer length that will fill the intent of the Federal Bridge formula. Again, the Federal Government comes into play telling us in the State of Maine what we must or must not do, and I resent that very sincerely. If the Federal Government wants to come in and put their money in and assist us in redeveloping or rebuilding many of the bridges which are deteriorating, that is fine, but when they start using us as a ploy to justify the increase in the truck lengths then I object to this.

I think it is about time, Mr. President and Members of the Senate, that we prevent these Highway Freight Trains from expanding as they have over the years, either they are looking to increase the box limit from 45 to 48 feet or the cab length by 31/2 feet, the next time round if they do succeed in putting this bill through to 60 feet, they will come back and try to increase the length of the box itself to maybe 48 or 50 feet. There is no end to this entire matter.

I am more concerned with the safety and well being of the people in the State of Maine than I am concerned with the trucking indus-

The PRESIDENT: Is the Senate ready for

The Chair recognizes the Senator from Penobscot, Senator Emerson.

Senator EMERSON: I would like to point out that in Section B, this proposed law, no way changes Section B. Right now the logs may protrude 81/2 feet beyond the truck and in the future if this law is passed it will still be 812 feet.

The PRESIDENT: The Chair recognizes the

Senator from Oxford, Senator O'Leary. Senator O'LEARY: I would just remind the good Senator from Androscoggin, Senator Minkowsky, that if he would check the Legislative Record, go back to the 101 and 102 that I have consistently voted against double bottoms. heavier trucks, truck weights, and I was a little concerned, at first, when I started voting for this piece of Legislation, but I am convinced in my own mind, it would be moving in the direction that you want to move in, that it will help us with our highways, this distribution of the weight, will preserve our highways and not run them down.

The PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Chapman.
Senator CHAPMAN: Mr. President and

Ladies and Gentlemen of the Senate, I talked at length last evening with a local trucker/mover on the impact of this particular Bill. I again want to emphasize as it has just been emphasized that this Bill does not increase the

weight limits one bit.

Throughout most of the states in this country apparently, especially in the west and the mid-west where it is readily understandable, much longer length of truck vehicles is permitted. even much longer than this Bill will permit. For any movements throughout the country. when you get back to the east coast, they are going to be over length and it does cause problems for these movers of furniture and truck-

Maine is a rural state, and granted the roads could be a lot better, but the vast majority of the trucking of this nature is going to be over the Interstate system and the turnpike. A lot of the terminals are located very near to these systems. They obviously have to get off and on to some secondary roads to get to their terminals where the freight is unloaded and broken down, but with the weight being the same we really are not increasing the problem of deteri-oration of our roads. So I think I want to stress

that.

As far as coming in, in the future, and increasing the length of the box, which increases the weight potential perhaps; we can address that, that is an issue that we can be alert to and prevent

This Bill would allow for more dimension for tractors, which would permit more fuel efficient engines, and in many ways I see this can be helpful in the fuel energy crunch that we have I would urge that the Senate not vote for this motion and also direct their attention to the committee report which was heavily Majority Ought to Pass.

Senator USHER: Mr. President and Members of the Senate. I think that this is a very helpful bill to the trucking industry of Maine. They contribute a lot to the economy in Maine. Very simply, this permits them to buy a different style of cab, it does not add to the weight and this new style cab would be very safe for the drivers. Presently they are confined to a certain style and it would be a lot easier for them to handle the long hours that they have to put on the Maine roads. So I would hope that the Senate would vote against the pending
