Senator PRAY: Thank you, Mr. President. Mr. President and Members of the Senate: As I was reading Enactment of this Bill, I see that we are crossing off the words, "or by aid or use of any light or lights carried thereon in reference to motor vehicles, trailers, aircraft, motor boats or snowmobiles, for the purpose of hunting.

It would be my interpretation of reading the enactor that we will be crossing out that section of the law which will then allow individuals to use lights. Is that the understanding of the Bill?

The PRESIDENT pro tem: The Senator from Penobscot, Senator Pray, asked a question through the Chair to any Senator who may care to answer.

On motion by the Senator from Penobscot. Senator Pray, tabled until later in today's session, pending Passage to be Enacted.

An Act Relating to Self-insurance under the Workers' Compensation Act. (H. P. 396) (L. D.

The PRESIDENT pro tem: The Chair recognizes the Senator from Sagadahoc, Senator Chapman.

Senator CHAPMAN: Mr. President and Members of the Senate: I would like to move that this item and all of its accompanying

papers be Indefinitely Postponed.

The PRESIDENT pro tem: The Senator from Sagadahoc, Senator Chapman, now moves that the Senate Indefinitely Postpone L. D. 526.

The Senator has the floor.
Senator CHAPMAN: This bill has disturbed me considerably. I know I tried to amend and it didn't succeed. I am primarily concerned about the regulation that would be allowed out under this Bill. It really, in my view, there is not the kind of regulation that we have established in this State for insurance matters.

The up-front money necessary for these funds, the self-insurance funds are at the sole discretion of the Superintendent of Insurance. There is no provision for any insolvency fund here to protect the workers, those receiving the benefits. No guarantee that there will be monies available should those disasters that do occur, occur.

There is not really a provision for tax here. the premium tax that we know and that we receive under insurance coverages in Maine. Such self-insured groups will be subject to income tax, but that is a far cry from the premium tax that is now paid for workmen's compensation insurance. I feel that there will very definitely be a loss of revenue to the State, and yet substantial demands for regulatory action will remain.

This Bill is not in good shape, it is not in a sound form, I think that it needs much more thought and study

The remarks of the Superintendent of Insurance, Deputy Superintendent at the public hearing were directed primarily at just this concern. I would like to read to you some of those remarks.

"There is no provision in the Bill setting the standard by which the superintendent would recognize investments by category or by class

of assets, nor inherent character of value, no standards are set for minimum reserves that would be required by the associations of employers.

There is a provision, however, that the superintendent of insurance may provide for the administration of this section of the worker's compensation law. pursuant to promulgation of

reasonable rules and regulations.

It is presumed that all these concerns would be addressed in such regulation. However, the form of such standards could be better defined if such integral factors underlying financial solidarity of any such association were legally and expressly mandated, and were not left to the vicissitudes of changing office holders in any agency of government.

We would strongly recommend that the Committee consider assignment of this piece of Legislation to a Study Commission charged with flushing out reasonable standards which would be incorporated in such legislation prior

to enactment.

Present groups that are permitted under the self insured statute, groups of similar purpose and similar objectives, will not be affected by the defeat of this Bill. I know that some have expressed this concern, but this would in no way defeat those groups which do not have a common interest.

The impact of this legislation is truly far reaching and significant, and it should not be rushed as this one seems to apparently be rushed. The old adage "haste makes waste" comes to me when I think of this and I would urge that we Indefinitely Postpone, so that was thought and concern can be put into this more thought and concern can be put into this

measure

The PRESIDENT pro tem: The Chair recognizes the Senator from Oxford, Senator Sutton.

Senator SUTTON: Mr. President and Ladies and Gentlemen of the Senate: I arose to speak on this Bill the other day. It was pointed out to me by one of my good colleagues that I muddied the waters more than I made any point one way or the other. I am sure that that is so, because that was the way that my mind was working at that particular time.

I have a deep concern about the problems of the workers compensation funds and the effect that it has on the employers, and something needs to be done. My original concerns were in keeping with those of the good Senator from Sagadahoc. Senator Chapman, that we needed something but we were missing lots of elements here. When the amendment came along I supported the amendment. I still am very concerned about the workers compensation fund. I am also concerned that this Bill is not in the form that is best suited and I would therefore support the motion from the good Senator.
The PRESIDENT pro tem: Is the Senate

ready for the question?

The Chair recognizes the Senator from Pe-

nobscot. Senator Pray. Senator PRAY: Mr. President and Members of the Senate: I would just remind those of you that have forgotten since May 1st, when we first debated this bill, and at that time the Senator from York, Senator Lovell, moved the Indefinite Postponement. A motion which was defeated 21 to 8 in this Chamber, that we have debated this bill to great length and the Senate Chamber has seen fit to hold off any attempts to scuttle the bill through amendments or even through the Indefinite Postponement.

Basically, I think, this Bill would allow an unnecessary motorized intrusion into the few remaining places not already subject to such intrusion. This is primarily a summer device. I think our streams, for example, which are level enough for airmobile use, some of them ought to be comparatively inaccessible to mo-

torized access, I feel.
I think this Bill could be made somewhat better if it was amended to salt water use only. although perhaps the time has not yet come for the Legislature to consider, perhaps, Hovercraft access to our major islands and that sort of thing. I, therefore, hope the Senate will support the Motion to Indefinitely Postpone this Bill and all accompanying papers.

The PRESIDENT: The Chair recognizes the

Senator from Hancock, Senator Perkins.
Senator PERKINS: Mr. President and
Ladies and Gentlemen of the Senate: I would oppose the Motion to Indefinitely Postpone, because I can see some potential for airmobiles in the fishing industry of the State of Maine, which is something that the good Senator from Cumberland alluded to.

Senator SHUTE: Mr. President and Members of the Senate: This bill seems to increase the license fee quite a bit on the Atlantic Salmon. Also, it seems that the sponsor of the bill signed the Ought Not to Pass Report on the bill, his own bill. I wonder if somebody on the Committee could explain the rationale for this. Second, to explain the reasons for increasing the resident Salmon Stamp from \$1 to \$5 and the out-of-state from \$15 to \$30, and what other

changes might have been made in the bill?
The PRESIDENT: The Senator from Waldo, Senator Shute, has posed a question through the Chair to any Senator who may care to answer.

The Chair recognizes the Senator from Cumberland, Senator Usher.

Senator USHER: Mr. President, in response to the good Senator from Waldo, Senator Shute, again. The present license fee is \$1 for residents and \$10 for non-residents. Those who followed the papers last year found that this is one of the most popular sports, returning to Maine. I guess there was 100's and 100's of people down on the Coast fishing.

There were 2 bills before the Committee, one was withdrawn, and we used this bill as a vehicle. This amendment would raise the residents to \$5, which will cover the administrative costs, \$1 we didn't think would cover even the administrative costs. The non-residents \$30, we thought this would be very sufficient.

Senator KATZ: Mr. President, I'm confused. The Senator wasn't speaking very loudly, but did I understand that he reported that we are raising the in-state license by 500%, at a time when wages are restricted to 7%. Was that the

Senator REDMOND: I oppose that motion and request a Division.

The PRESIDENT: The Senator from Somerset, Senator Redmond, requests a Division.
The Chair recognizes the Senator from Penobscot, Senator Pray.

Senator PRAY: Mr. President and Members of the Senate: Late last week, we debated several bills out of Fisheries and Wildlife Committee, the question came up in the debate as to the condition of the Department of Fisheries and Wildlife presently, and the rumors that I had seen in the Press that there was a proposal presented before the Committee last week for an additional \$900,000.

I would like to pose a question to the Chair to somebody on the Committee, if they could tell and share with the Members of this Chamber, as to whether or not that Department at this time, presently through increases, operating increases to its budgets, is having financial problems?

The PRESIDENT: The Senator from Penobscot, Senator Pray, has posed a question through the Chair, to any Member of the Committee who may care to answer.

The Chair recognizes the Senator from Somerset, Senator Redmond.

Senator REDMOND: Mr. President and Members of the Senate: It is my understanding that we have from the Governor's call, a bill that would increase all of the hunting licenses and fishing licenses in order to raise more funds so the Department could balance its budget.

I thought perhaps that this one could be considered while we're considering one of those other bills. It's just a move to try and make both ends meet. That's about the size of it.

The PRESIDENT: The Chair recognizes the Senator from Washington, Senator Silverman. Senator SILVERMAN: I'd like to ask a ques-

tion of the President. Do you know what the fees are for fishing for salmon in the Province of New Brunswick for resident and non-resi-

The PRESIDENT: The Chair would advise the Senator from Washington, Senator Silverman, that the non-resident Atlantic Salmon fee in Canada for seasonal license last year was \$75. For a 7 day license, it was \$35

The Chair recognizes the Senator from Washington, Senator Silverman.

Senator SILVERMAN: The fees in Maine are \$1 and \$15. I would hope you would consider this bill, as the Atlantic Salmon becomes a major sport fish to recognize that the Department of Fisheries and Wildlife has to be financed. You can make a joke out of it, but those who are in this field, I think, recognize that the Atlantic Salmon, as a sport fish, is an opportunity that few people realize that is such an enjoyment in fishing.

This bill is asked of me to be presented. I did not present it, but I don't like making a joke out of it, because sooner or later the Department of Fisheries and Wildlife is going to have to have a proper management of the Atlantic Salmon in Maine rivers.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Usher.

Senator USHER: Mr. President and Members of the Senate: to clear a few things. I believe one of the main reasons the sponsor signed it Ought Not to Pass was he was against the part that we raised the resident from \$1 to

5. If you think \$1 is sufficient, well, you're going to vote in a few minutes, and you can vote that way

But I don't think \$1 pays the administration fees. He was for the non-residents being raised, but I feel that we have to pay for administration and presently the Department is in financial trouble and if they operate at the present fee structure next May they will be operating in the Red.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Conley.

Senator CONLEY: Mr. President, I hope the good Senator from Cumberland, Senator Usher will tell them to tighten their belts the next time they come over.

Nobody has mentioned the fact that they're going to grab another 1/2 million dollars for the moose slaughter that's about to take place. I've never seen a department in my life that cries so loudly for money. There hasn't been a bill that goes before the Fish and Game Department that isn't going to milk the public a few more pesos every time they get before them. I hope this bill gets buried and buried deep.
The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pray.

Senator PRAY: Mr. President and Members of the Senate: I'm again amazed at my good seatmate, the Minority Leader of this Chamber, always seems to get emotionally involved on Fish and Game issues.

It reminds me of a few stories of when he came up to our area on a couple of occasions. The fact that he had problems sometimes telling what a moose was or a deer or even a bear was. Had to take him out one time with the then Attorney General, Joseph Brennan, in Baxter Park to show him a group of bears. There was about, I think, 13 or 15 of them there. When the good Senator from Cumberland got out of his car, he left his door open, which 2 cubs immediately climbed in. To this day he still says it was the Attorney General who got out last and left the door open, but the Attorney General was on the other side of the car.

But again we're addressing a matter which I think should be taken a little bit more seriously. The restoration of the Atlantic Salmon in the State of Maine has come to reality today. It's become a great sport. People are talking about the return of the Atlantic Salmon as it was 20, 40 and 50 years ago.

I think in fairness, and the quality of those fees for the sports that are provided to those individuals that a \$5 fee is not too much. I have seen the proposal for the increase in license fees across the board, and I'll state at this time, that I will oppose it. I think the Department should tighten its belt somewhat.

A new Commissioner has been nominated, it will have to go through the confirmation process, but I have faith that that will take place. I think that the new Commissioner, in light of the comments that have been made here today in reference to the Department tightening its belt, that they will do so.

But let's not forget that the Fisheries and Wildlife Department basically is a self-supporting agency. It is sponsored and financed by the sportsmen of the State, those who go out and enjoy the recreation and the sport and the harvesting of a natural resource that we have. Until the sportsmen of this State clamor down here to me and state that they think that Department is spending too much money, and I'm going to take into consideration the fact that they do need operational revenues, and revenues to a fair amount. I think that each individual sport that they provide for should be selfsupporting.

If a \$1 fee for a license doesn't take care of the printing, the services that are provided where the game warden's checking out and being sure the laws are followed, then I think that particular fee is one that should be addressed and not an across the board increase. So I would hope that we would defeat the

motion to Indefinitely Postpone and Enact this

Senator LOVELL: I hesitate to speak on Fish

and Game Bills. I never went fishing or hunting in my life, but I always worked. But being on the Retirement Committee, the Retirement Fund is in desperate financial condition, not in bankruptcy condition, but we need to save money. Now all the Fish and Game wardens are going to get a raise and also they're going to retire at the end of 30 years of service, and get 2% increase in pension each year after they

Now that's going to cost the State a good deal of money. We need the money from the Fish and Game Department in the Retirement De-Game Wardens, when they retire, so consequently I hope the Bill might pass.
