October 4, 1979 In compliance with a proclamation of His Excellency, Governor Joseph E. Brennan, the Senators convened in the Senate Chamber at ten o'clock in the morning.

The Senate called to order by the President.

Prayer by Reverend Bruce W. Meyer, Prince of Peace Lutheran Church, in Augusta. Reverend MEYER: I will lift up mine eyes

to the hills from where does my help come. My help comes from the Lord who made heaven and earth!

Good and gracious God, as we remember the words of your servant David, we too acknowledge the beauty of the hills, and the dazzling splendor of your creative hand, especially in our State in this autumn season

We thank you for all that speaks to us of the joy of life, and also to our responsibility as stewards of your creation.

We give thanks for the men and women gathered here and in this day and for this session give them strength and insight, as they seek with mutual conviction to uphold the dignity, the welfare, and yes, the human rights of all

#### The Secretary read the Proclamation: State of Maine **PROCLAMATION**

WHEREAS, there exists in the State of Maine an extraordinary occasion whereby Maine citizens are faced with the prospects of sharply increased prices and possibly inadequate supplies of the petroleum products essential to heat most homes during the coming winter; and

WHEREAS, adequate home heating is a necessary part of shelter and the lack of home heating poses a genuine and immediate threat

to life, health and safety; and WHEREAS, many Maine citizens particularly the elderly and other low-income citizens, will need help to meet the anticipated high cost of fuel during the coming winter; and
WHEREAS, the Project Fuel Task Force has

drafted a proposal to provide such assistance, to relieve the hardships caused by higher prices and to encourage energy conservation;

WHEREAS, there exists a need for the Legislature to act in a timely fashion on this pro-

posal;

NOW, THEREFORE, I, Joseph E. Brennan, Governor of the State of Maine, by virtue of the constitutional power vested in me as Governor, convene the Legislature of this State, hereby requesting the Senators and Representatives to assemble in their respective chambers at the Capitol at Augusta on Thursday, the Fourth Day of October, 1979, at ten o'clock in the morning, in order to receive communications and enact an emergency fuel assistance plan.

Given at the Office of the Governor at Augusta, and sealed with the Great Seal of the State of Maine, this Twenty-fourth day of September in the Year of Our Lord Nineteen Hundred and

Seventy Nine.

The PRESIDENT: The Chair recognizes the Senator from Knox, Senator Collins:

Senator COLLINS: Mr. President, the purpose of this bill that we have just given First Reading is to correct an error in the laws that relate to the suspension of drivers' licenses. This comes upon us quickly because of a decision filed the first of this week, by a judge of the District Court, which has ruled that the present procedures would require an additional hearing if they were to meet due process tests.

The proposal to correct this error in the statutes is simply to have the Court order the suspension of a license, send the papers along to the Secretary of State, as is now the case. The Secretary of State will then mail out the order notifying the licensee of the suspension. The licensee will be able to get a license back by curing his default, and paying a reinstatement fee, which is the same sort of thing that now prevails.

The importance of doing this at this Special Session is that there may be 3,000 or 4,000 suspensions between now and January that would otherwise either be defective or require a double procedure, greatly costing the Secretary of State and the taxpayers.

MAINE DEPARTMENT OF AGRICULTURE TO: Governor Joseph E. Brennan

The Maine Food and Farmland Study Commission was established by the 108th Legislature with specific instructions to study the problem of farmland conversion to other uses and to recommend actions which would strengthen Maine agriculture. The Commission membership included legislators, department commissioners, university administrators.

farmers and agricultural businessmen.
Initially the Commission held twelve public hearings at which representatives of the various agricultural industries in the state expressed their views of the primary constraints to the economic viability of agriculture. Following these hearings, the Commission studied the comments and then structured subcommittees to study each of the four problem areas which emerged. These subcommittees were specifically instructed to study and make recommendations on land preservation, entrance to farming, marketing and transportation, and

Early in the deliberations of the Commission there was considerable discussion concerning the feasibility of developing a food policy for Maine. The Commission members recognized the consumer interest in such a policy, but the majority did not feel it was feasible to undertake such a comprehensive study within the time and resources available to the project. Therefore there are no recommendations in this report relative to consumerism.

The reports submitted by the subcommittees were reviewed, modified and eventually combined by the whole Commission into a draft report which was released for public scrutiny.

Public reaction was gathered at three hearings and the comments were reviewed by the Commission and incorporated into this final report which is submitted to you.

The recommendations are intended to be specific and practicable. The Commission feels strongly that the vitality of the family farm is essential to the future of Maine agriculture and this report is aimed to that end.

Senator COTE: Mr. President and Members of the Senate: You notice that I voted "Nay" on the confirmation of Mr. Gibbons to the Liquor Commission.

The reason that I voted nay, first let me explain that I did not know the gentleman at the time, I just met him on the day of the hearing. I know nothing about him, that is bad, except that I am convinced and always have been, that the head of the Liquor Commission should be an individual who knows something about business. If we are going to operate a \$50,000,000. business in this State, I think that we should have a business man.

I questioned Mr. Gibbons and he told me and the committee, that he had no business background whatsoever, he had practiced law in Massachusetts, he had been a member of the FBI since 1954 I believe. For that reason I felt I could not vote to confirm him.

As I say I have nothing against the gentleman, I don't even know him. I only met him that day, but I feel very strongly that it should be a man who has business ability and a merchandiser in order to operate the Liquor business in the State of Maine. With this explanation I hope that you do whatever you

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Conley.
Senator CONLEY: Mr. President and Mem-

bers of the Senate: I appreciate the concerns of my colleague from Androscoggin, Senator Cote.

I would like to inform the Senate that I have known Mr. Gibbons for probably the last 20 or 25 years of my life, and he has established one of the finest records as referred to by the good Senator from Androscoggin, Senator Cote as a member of the FBI, a distinguished attorney at least in the legal profession. He would do one of the, I think, best jobs that we could ever expect of any Commissioner serving on the Liquor Commission.

He has a very lovely family, a devoted husband, and a very fine wife. I think Mr. Gibbons if confirmed by the Senate today, would do the citizens of Maine a justice in serving on the Liquor Commission.
