Senator CONLEY: Mr. President it is my understanding that this particular Bill came before the Legislative Council and that the 5 members of the Majority Party rejected this Bill, rejected it on partisan feelings, I understand. The partisan feeling was that they said that they could not get a republican to co-sponsor the Bill with the democrat that had submitted this Bill for consideration back sometime ago.

Now it seems to me to be a little bit ludicrous to be playing games on the first day of this session. It is obvious to me that the bill can be introduced through the Governors office and can have one sponsor or we are willing to sit down and talk about a co-sponsor for the Bill. it seems to me to start pursuing this type of avenue is a little bit ridiculous on the first day of the session, and I would hope that we would dispense with it.

The PRESIDENT: the Chair recognizes the Senator from Kennebec, Senator Katz.

Senator KATZ: Mr. President my good friend from Cumberland, Senator Conley is in error. The Bill sponsored by Senator Pray, a bill did come before the Legislative Council, the speaker pointed out very properly at the time that the Bill could not be introduced by action of the Legislative Council because a similar Bill has been considered and rejected in the First Regular Session last year. On that basis it was my understanding although no vote was taken that it had very broad support on both sides of the aisle.

I had hoped that there would be a Bill on the calendar to be considered by both Houses today. In the absence of any vehicle it seemed only reasonable to me to reassure all the retired State employees and teachers of the State that this Bill was a priority concern of this Legislature and that it should be introduced on the first day of this session, to remove any semblance of doubt.

As far as partisan implications are concerned it seems to me it is going to be a largely financial issue without partisan concerns, and probably the best way to approach it is to have a committee reaction rather than party reaction. On that basis I am asking you to allow, permit the bi-partisan committee to report a Bill out in any form that seems appropriate to the Committee

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Conley. Senator CONLEY: Mr. President I am cer-

tainly delighted to see the good majority Floor-leader charging to his feet to once again come to the aid of the former employees of the state. I think that we have several Bills, and I do not want to take your time to point them out today that will be coming before us, as far as Reference to Committees, and being ordered printed and such.

The fact is it is very simple the Bill that we are talking about is one that was submitted by Senator Pray from Penobscot in the last session and it died from lack of money on the Appropriations Table. It was not a bill that was defeated because of opposition in any other sense than that.

It was also stated at the Legislative Council, even though that the speaker may very well have raised a question that such legislation that was considered in the previous session, would have to take a two-thirds vote of both houses I believe to be introduced, would only take that if the objections were raised by any member of either branch. So again I submit that this Bill will be introduced and for us to

prolong this debate is nonsense.
