January 9, 1980 Senate called to order by the President.

Prayer by the Rev. George J. Plante of St. John the Baptist Church of Winslow. Reverend PLANTE: Let us pray!

Let the light of your wisdom direct all their deliberations and shine forth in all their proceedings that they may tend to the preservation of peace and happiness, to the increase of industry and useful knowledge for the common good of all, and that they may perpetuate to all the blessings of equal liberty

Give to us all the light we need to see our way. the strength to persevere in our good resolutions and the courage to change whatever needs to be changed in order to always do your will.
