Kennebec. Pending—Reference. The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Pierce. Senator PIERCE: Mr. President, I move this Bill be Indefinitely Postponed. The Senator from Kenne-

The PRESIDENT: The Senator from Kennebec, Senator Pierce, moves that L. D. 1772 be Indefinitely Postponed.

Is this the pleasure of the Senate?

The Chair recognizes the Senator from Pe-nobscot, Senator Trotzky.

Senator TROTZKY: May I inquire through the Chair as to what reason the Senator from Kennebec wants to Indefinitely Postpone this Bill?

I would also mention that I believe that we are setting a bad precedent in Indefinitely Postponing Bills, before they have public hear-

ing. There are going to be Bills, coming into Senate's not this one but other Senate's where the lobbyists are going to end up Indefinitely Post-poning, having Bills Indefinitely Postponed. I don't think the public is being served when Bills are Indefinitely Postponed, indiscriminately

The PRESIDENT: The Senator from Penobscot, Senator Trotzky, has posed a question through the Chair to any Senator who may care to answer.

The Chair recognizes the Senator from Kennebec. Senator Pierce.

Senator PIERCE: Mr. President and Mem-bers of the Senate. I would suggest to the good Senator that a precedent can't be set 3 or 4 times. It is either set or it isn't. Last week we did set a precedent, I did not agree with it but we set it, so we certainly are not setting another one now.

Checking with both management types, labor union types, and soforth, I can't find any kind of support for this measure, whatsoever

Last year, I think all of us will recall we had a record number of Labor Bills, both pro-management, and pro-labor, however you want to

call them, and we went round and round and round at great length on all of them.

It was generally agreed among many people, certainly not among all, but among many that it would not be appropriate for us to get back into a lot of labor management type hassels this session. As a result virtually no Labor Bills were allowed in.

This Bill evidently comes from the bureaucracy somewhere along the line. I can't identify any support for it, that is the reason that I did move for its Indefinite Postponement

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Conley. Senator CONLEY: Mr. President and Mem-

bers of the Senate.

Mr. President after listening to the good Sen-ator from Kennebec, Senator Pierce, and noting his remarks the other day about his Governor and your Governor and our Governor. how much he supported him, and I have always supported our Governor.

Supported our Governor. I pose a question through the Chair, to the good Senator from Kennebec, is this a Bill of the Governor? Our Governor's, that he is moving to Indefinitely Postpone this morning? The PRESIDENT: The Senator from Cum-berland. Senator Conley has posed a question through the Chair.

The Chair recognizes the Senator from Ken-nebec. Senator Pierce. Senator PIERCE: Mr. President, I under-

stand that this is a Bill of one of the Governor's commissioners, presented through the Governor's office

The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pray

Senator PRAY: I move that this item lie on

the table, 1 Legislative Day. The PRESIDENT: The Senator from Penobscot, Senator Pray, moves that L. D. 1772 be Retabled, for 1 Legislative Day.

The Chair recognizes the Senator from Ken-

nebec, Senator Pierce. Senator PIERCE: Mr. President, I would

ask for a Division. The PRESIDENT: A Division has been requested.

Will all those Senators in favor of Tabling L. D. 1772, please rise in their places to be counted.

Will all those Senators opposed, please rise in

Will all those Senators opposed, please rise in their places to be counted. 12 Senators having voted in the afffirmative and 14 Senators in the negative, the Motion to Table does not prevail. The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Trotzky. Senator TROTZKY: Mr. President and Mem-bers of the Senate: I have seen other Legis-latures such as the Legislature in

latures, such as the Legislature in Massachusetts, the Legislature in Rhode Island.

A lot of bills don't have public hearings, they are decided in committee and in smoke filled rooms. The one thing that I have always been proud of is the Maine Legislature, and whenever I see Legislators from out-of-state that is one of the first things that we talk about our Legislature. I say that it is an open Legislature and it is an honest Legislature.

I am proud of this and I feel we may have set somewhat of a precedent, as the Senator from Kennebec states, in Indefinitely Postponing a few Bills this session, but if we keep this up we few Bills this session, but if we keep this up we are really going to set up a strong precedent for the future and it is not going to be in the public interest, if we keep this up. So I would hope that the Senate would oppose the motion to In-definitely Postpone this Bill. The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pray. Senator PRAY: Thank you, Mr. President. Mr. President and Members of the Senate: I become concerned at the comments of the As-

become concerned at the comments of the Assistant Majority Leader when he states that the two sides of the aisle of this issue, those who are in labor and those in management, have come to an agreement that the Bill is not needed.

I have not heard from either side, and I do serve on the Labor Committee, in reference to the Bill, as to the fact that they all of a sudden have no desire to have the Bill before us.

That fact be as it may. I'm not down here at the beck and call of those who represent Labor in the halls or those who represent Business Management out here in the halls. My concern, as I look at the Bill are the number of issues that are being addressed. I think they should probably be addressed, as the Senator from Penobscot, Senator Trotzky, pointed out, at a public hearing.

The reason I moved a few minutes ago to Table this was to verify some of the statements that have been made, as to the reason that we will be Indefinitely Postponing this Bill. It's a Bill that set on the Table, not on one occasion, but on several occasions, by the Majority Floor leader, who isn't here today. I would only hope that somebody else would move to Table this Bill, so that we could find out definitely what the motives are behind the attempt to subvert the Legislative Process. The PRESIDENT: The Chair recognizes the

Senator from Kennebec, Senator Pierce. Senator PIERCE: Mr. President, I would only suggest to the good Assistant Minority Floorleader that undoubtedly he will have an opportunity to do that, because we probably will see the Bill again. The PRESIDENT: The Chair recognizes the

Senator from Aroostook, Senator Carpenter. Senator CARPENTER: Mr. President,

Ladies and Gentlemen of the Senate, back up on my feet for the same reason I was up last week, and probably with the same outcome. It's not all that often I get up to agree with the good Senator from Penobscot, Senator Trotzky, but hold on! What are we doing here?

Now let's stop and take a look at this, this bill love for the Bill, but as the Senator from Pe-nobscot, Senator Trotzky, has already pointed out; you know we have, okay, a reputation to protect.

I teased my floorleader this morning when he came in because the Maine Sunday Telegram this last week editorialized on the public's right to appear before the Legislature and let its voice be heard.

Now, all of a sudden, because last week the great human and cry was that it wasn't an emergency. This week the word seems to be that there is no support for it. Well, you know, the point is that the Bill is legitimately before us

We talk about precedents and I'm really concerned that the precedent may have been set last week, but it sure as heck is going to be strengthened this morning that because some-body in leadership doesn't like a Bill, and the samething could start to happen at the other end of the hall, and I really hope it doesn't.

We know some of these Bills aren't going anywhere when they come in here, but I guess I'm really hung up on the principle of this whole thing, that the public has a right to a public hearing, if a Bill is legitimately brought in before this Legislature.

By gosh, that's the way it's been for 5 years since I've been here. It is very frightening to me to see us start to reverse this trend and start to arbitrarily kill Bills for, I think, very capricious reasons.

I've heard two and I'll state them again; 1, it's not an emergency, and nobody's given me a definition of that word yet; and 2, there doesn't seem to be any support. We know that any group, the Majority Party in this body, or the Majority Party in the other body probably can bill the bill at env store

kill the Bill at any stage. But we've always kind of been judicious with that power and held off and let the Bills go to hearing. Let them come out. We go through the process and maybe we learn something by that process.

I've seen the Senator from Oxford, Senator Sutton, change his position on Labor Bills. I've seen the Senator from Penobscot, Senator Pray, change his position on Labor Bills, after a public hearing, or we work on a compromise, or we work out some kind of an accommodation

Well, there's darn little room for accommodation if you zap the Bill before it even gets to a committee for crying out loud! I'm really concerned about just exactly the direction this Legislature or this body in particular seems to be heading.

I've visited other Legislatures, too. Believe me, they aren't run anything like the Maine Legislature is run. This is one area, that I, like Legislature is run. This is one area, that i, have the Senator from Penobscot, have always been very proud of. I really wish, even though you may hate this Bill, if you do dislike this Bill, just because of the Title, or maybe because of who put it in, or whatever reason, you're going to have a chance to kill it, so let's let it go out and let the public say what they've got to say on it. Let's not kill it this morning before it even goes to a committee. Let's find out if there is any support out there for it. Thank you.
