The PRESIDENT: The Chair recognizes the Senator from Oxford, Senator O'Leary.
Senator O'LEARY: Mr. President, and Members of the Senate: Yesterday we had the nomination of John Walker before us for this position. I must say at this time, he was questioned extensively by the committee.

There was no one who appeared in opposition to his nomination. I was rather impressed by the credentials that this man brings to the position. I say he's perhaps the best nomination that any Governor of this State has ever made

to any position.

John Walker was born and raised in Springfield, Massachusetts. After serving with the United States Marine Corps during World War II, he received a B.S. Degree in Forestry from the University of Maine's School of Forestry. He worked for the Dead River Company, the

Sewall Company, and the International Paper Company as a timber cruiser, a land surveyor hypsographer, and aerial photographer inter-

He then came to work for the State where he served 25 years with the Maine Forest Service, during which time he was the sole person in charge of the State's public lots throughout the entire unorganized territory.

He was also the person who in the deep of winter ran the lines on the boundaries of

Baxter State Park.

I have a lot more here, Mr. President, but I think that I put in the record some of the words that I like to say about this gentleman. I believe he is the best qualified man that could be found for this position. I hope that everyone votes for his nomination.

Senator Katz of Kennebec was granted unanimous consent to address the Senate, On the Record.

Senator KATZ: Mr. President, and Members of the Senate: If there is one thing we have in common, it is that we are concerned about the education of our constituents' children.

Some years ago, when it was apparent that money was a real barrier, we actually amended the Constitution of the State of Maine

in order to guarantee loans so that our youngsters could walk into local banks and borrow money and help pay for the cost of their own education.

The program started, actually, in the private sector with a bunch of businessmen getting together and putting some seed money so that the loans to students could become bankable, but in those days they were dealing with small num-

Subsequently, Congress entered the act and passed a national program, which you read about now and then in the paper and sometimes it's not always advantageous, because you read about an extraordinary rate of default among

students who don't pay back their loans.

The thing the papers don't say is that those high default rates pertain to direct programs, operated by the Federal Government, and not to the kind of a program that's operated by the State of Maine, because the State of Maine oversees, within the State, the nature of the loans, the collection process. We hire a firm to administer the program for us. The default rate among your constituents and my constitu-

ents is among the lowest in the nation.
But listen to this! During 1979, 9,923, just short of 10.000 Maine kids walked into their local banks, borrowed money on their own signatures to help defray the cost of their own editor. It's an extraordinary record It shows ucation. It's an extraordinary record. It shows that Maine kids are willing to pay to pursue a course of education and training. This does not necessarily mean they are all going to the University, or Harvard or anyplace else. This involves the Vocational Schools. It shows, I think, extraordinary evidence that Maine kids still believe that an education is a vital asset if they are to succeed in life.

Just a handful of years ago in 1973 the number of loans was less than half that amount. I would advise each of you to become familiar with the loan program so that you can personally actively help kids in your communities to steer into the right banks to borrow the money to help pay for their education costs.
