Senator COLLINS: Mr. President, and Members of the Senate. This study came about as a result of a bill submitted last May by the Governor, which had as it's principle purpose the elimination of two trials in many cases that clog our courts.

The study, that was conducted during the interim period and briefly at the beginning of January, resulted in a decision in which the Governor and the committee of the Judicial Department, and the Judiciary Committee concurred, to use as it's mechanism in restructuring the courts a change in the system of requesting jury trials.

Thus, the purpose of the original Governor's bill and the study is carried out in the bill that is presented here, although the title which appears is somewhat more specific in it's nature than the original study indication. I can assure the good Senator that it is the combined judgment of those who worked with it that this is carrying out the very purpose that was indicated in the original study.

Senator USHER: Thank you Mr. President. Mr. President, and Members of the Senate, some people are commenting that we are getting too involved, starting to tell the youngsters what to do.

When you stop and think under 15 years of age, you don't have too much responsibility. I'm sure we've all throughout our districts have seen episodes of motorcycles going down the street where the operator might be having a helmet, picked up a rider, and on the back, he might be 12 years old or even younger, without a helmet

The people comment. Why don't somebody do something about this? It makes you feel ir-

responsible too. I have seen this in many cases.

We have a large populated area. We have many, many motorcycles, I'm sure all of you have many motorcycles in your area, due to the gas crisis. I too supported the repeal of the helmet law in the last session, but since then a lot of things have happened. Many, many people have contacted me about supporting this helmet law for the minors.

There were a large group that attended the committee hearing. The motorcycle clubs. Many saw it on the educational T. V. the Channel 10 episode of the hearing. Some of the Motorcycle operators said they wouldn't even let their sons ride with a helmet on. They claim

it's dangerous.

Well, I don't agree with them. I just feel that we should take some responsibility and pass this law

The Department of Transportation is conducting an on-going survey. Since repeal of the statutes which requires the use of helmets, which was taken out at the last session, it has been determined that 1 out of 3 motorcycle operators do not use helmets and 3 out of 4 or those killed in motorcycle accidents were operating without helmets.

Between January 1, 1978 and September 30, 1979, there were a total of 1,992 motorcyle crashes in Maine. A total of 51 people were killed, 1,701 were injured in these accidents. which is very costly to the families and also to the State. This is where we are involved.

On the total number of operators involved in motorcyle accidents, 8% were not wearing hel-mets. In addition, 7% of the passengers were not wearing helmets. Of the age limits, 1, was in the 15 and under category. I think that is enough right there, 1, also, 1,701 were injured. That is enough to vote too.

So I think it's a very serious matter. It's going to be very costly. It's costly to the families like I said before. I think this is the time we ought to be responsible and support this bill. I oppose the pending motion to accept the Majority Report.
