Senator O'LEARY: Mr. President, I'm not sure that I know what this bill actually does. It would seem to me that it was just in the last Regular Session of the Legislature that we passed a bill that permitted them to go throughout the State, and fill in at different courts

Now they seem to be before us asking for a Per Diem. I don't know whether I have my facts straight or not, I would like some explanation of the bill

The PRESIDENT: The Senator from Oxford, Senator O'Leary, has posed a question through the Chair to any Member of the Judiciary Committee who may care to answer.

Senator COLLINS: Mr. President, in response to the question from the Senator from Oxford, Senator O'Leary. I would advise that this is substantially the same bill which was before us last year which we placed on the Appropriations Table, which lost out there because of an absence of funds.

We have found an increasing need for judicial manpower in the State and one of the ways that we are filling it is by greater use of judges who become retired, but are willing to accept active status under which they serve at the assignment of the Chief Justice. If we did not have these Active Retired Judges serving us, I think it is certain that we would have to create 2 or 3 additional judgeships in our court system.

Up until now these Active Retired Judges have not been paid anything for their service. In fact, for some of them it actually costs them money out of pocket, because the cost of travel and meals sometimes exceeds the allowance which is paid them for that purpose

When a judge become retired he receives a retirement pay amounting to three quarters of a normal or full salary. This extra work that is accepted and requested from these active men has not been compensated for in the past, but because there has been an increasing demand on those judges, we feel it is only fair that they be compensated when they do work. This bill sets up a per day and per half-day stipend for such service.

There is also a provision in the bill that, regardless of how much work they may do, the total amount paid to these Active Retired Judges, shall not exceed the sum which would be a full salary of an Active Judge, when added to the Retirement Pay. In other words, they cannot be paid in the course of a calendar year cannot be paid in the course of a calendar year more than ¼ of a full judges salary, for this assignment work that they are carrying on.

We think that it is only fair that a judge be paid for his work. We think it is very important

that we have this service available on an even broader scale, than has been the case in the past. We therefore, recommend to the Senator the Passage of this Bill.
