Senator HICHENS: Mr. President, and

Members of the Senate, before we taken a vote on the nominations of these members of the Pesticides Board by the Executive Department, I would like to read this statement.

There has been a lot of talk going around that this special session of the Senate is an unnecessary expense to the taxpayers of the State of Maine. This report emulated from the Governor's Office and the blame is put on a fellow colleague and myself as chairman of our respective committees.

I, for one, will not accept the blame for this special session but assert that had the Governor's Office complied with the rules, and his nominations been made in reasonable time limits the confirmation session might have been held last week along with other confirma-

Just one week prior to the session last week, July 9, I was approached by a representative of the Governor who stated that committee hearings would be scheduled for the morning of the session day, for confirmation of seven nominees to the Pesticides Control Board. I declared that it would be impossible to hear seven nominations in a morning meeting and asked for a longer time in which to consider the nominations before the committee meeting.

It was agreed that July 23rd would be the date of the Committee Hearings. Upon my return home I was informed that I had 3 calls waiting to be answered, one from the Senate Secretary, the Representative of the Governor and a State Representative. I called the Senate Secretary and was told that pressure was being out on by the Governor's office and the cochairman of the Agriculture Committee to have the hearings July 16th. After being informed that this could be legally possible I consented to having the committee hearings July 16th provided that the senate confirmation date not be held until at least a week later. I felt the time between hearings and confirmation proceedings too short a time.

I am positive in my own mind that I probably should not have consented to the July 16th date as several people have informed me that they did not know about the hearing or were notified too late to testify.

Following the committee hearings during which the committee did not hear but one objection to the nominees, the Governor's representative informed me that the names would be presented to the Senate the next day. I did not agree and was told that I was responsible for unnecessary time and expense. I still do not agree.

Fellow members of the Senate, I do not believe that we should be expected to be rubber stamps for the Chief Executive of this State. I believe that both committees and Senate should have reasonable time to look into the qualifications of nominees and not be rushed into irresponsible actions. Even though the Committee on Agriculture has approved of all nominees to the Pesticides Control Board, if you as individuals have any reason to believe personally or by word from your constituents that we have erred in our judgment, I would request that you share your feelings with us before we vote and each one vote accordingly. Meanwhile, Mr. President and fellow col-

leagues, may I suggest to the Chief Executive that in the future he grant us ample time to consider his nominees in committee and finally by the Senate. Thank you.

The PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter. Senator CARPENTER: Mr. President, and

Ladies and Gentlemen of the Senate, I, like the good Senator from York, Senator Hichens sat through the confirmation hearings on these 7 members of the Board of Pesticides Control, 8 days ago, last Wednesday.

At that time I fully expected them to be acted upon by the Senate on the 17th, the following day, and was quite surprised in fact when they weren't, especially since they were all, ap peared to be all very non-controversial. I still am a little bit unsure as to why they are held over until today.

I'm not going to get into the middle of this little blames-men-ship contest, as to whose responsible for what or when, but it just seems to me that once the hearings were scheduled for last Wednesday, that the confirmation, the action by this body could very well have been taken up last Thursday when we met for approximately one hour. I do think it's too bad that we had to come back this week for the number of appointments that we have. As far as the 7 members of the Board of Pesticides Control, unless somebody has dredged up something on the 7 nominees since we met last week, I still don't understand why we couldn't have taken them up last week

As I say, I don't think anything is served, I don't think government is served by getting into a case of calling names or blames-menship. I guess as near as I can determine everything has been done perfectly legal. Perhaps there could have been better communication between the 2 branches of government, between the Legislative Branch and the Governor's Office. Perhaps we have learned something. Maybe in the future this sort of thing won't crop up again. I hope not.

Senator KATZ: Mr. President, I believe that the nominee under consideration is Delores Colburg. We've gotten off in other directions.
I've known Dolores Colburg for a number of

vears since I met her as a chief state school officer one day on a visit to Washington D.C. You may recall that she was under consideration as a Commissioner of Education and Cultural Services last year, and she withdrew from consideration

I remember when I first met her, I said. I hope inasmuch as you own property in Maine. that you will find at least some time to serve the people of the State. I'm delighted that she is finally going to serve the people of the State in this capacity. She is a good person

With respect to the responsibilities of the committee, this is a learning process. We're taking the place of the Executive Council. I must confess I don't think we've done a very good job. Too many committees are meeting with nominees, listening to the representatives of the Executive Department and a few witnesses, and then immediately voting with everybody right there in the room without any real chance to have any public input.

So far as I know the people of the State have not been burned by our inattention to duty and detail, but you remember when we did away with the Executive Council we screened out most all of the nominees of the Executive Department who needed confirmation except a relative handful. These are supposed to be the

extremely important ones. The Senate has a very clear duty involved here and the committees have too. I must confess that I sympathize with the good Senator from York and I tend to agree with him, that the procedure must not be rushed if we're to live up to our responsibilities. It takes a two-thirds vote of the Senate to overrule a vote of the committee. It places an enormous burden on the committee. I would recommend to members of a committee and to the chairman of the committee, that if they have a public hearing and then vote immediately, they had better darn well know a lot about the candidate, if they choose not to let the thing lie over-

have, and also a safeguard to the Governor. The Republicans have uniformly, universally, without exceptions, supported the Governor's nominees, but we also have a responsibility, in those rare cases where the Governor despite a best effort may be making a mistake. We have a responsibility, to protect him, ourselves, and people from that mistake

lished is basically a citizens board, but the qualifications of people like Dolores Colburg and Doctor Dimond from the University, Danny LaBrie, who is a farmer from up my way, just happens to have a masters degree, The qualifications of the people, who hopefully will be on that board, are really, really exceptional

I think that as we go through each one of these if anybody has any questions, I think either Senator Hichens or myself would be more than willing to answer them. I think that the Chief Executive has done an excellent job of appointing this board, who as you know, is going to take the place basically of a board of commissioners. The Commissioner of Fish and Game, Commissioner of Agriculture and they just do not have the time and in most cases the knowledge. All of these people came to us without exception, be they pro-chemical or anti-chemical, if you want to classify them that way, these people came to us and to a person stated, they were committing themselves to going into the individual cases with an open mind, and deciding each case on its own values and merits. So I think we are very fortunate to have these 7 members starting with Dolores Colburg. Thank you.
