Monday, January 5, 1981 The House met according to adjournment and was called to order by the Speaker.

Prayer by the Reverend Millett E. Cummings of the Bethel United Methodist Church.

The members stood at attention during the Pledge of Allegiance.

Dear Speaker Martin and President Sewall: As provided by 12 M.R.S.A. Section 685-A, Subsection 8, any amendments to the Land Use Regulation Commission's land use standards must be submitted to the Legislature. On behalf of the Commission, I am submitting to you amendments which the Commission adopted this past June. If the Legislature chooses to take no action, these amendments

will remain in effect as adopted. Attached to this letter is a document showing each of the amendments, as well as a complete set of the Commission's revised standards which incorporate these amendments. Many of the changes are relatively minor. To facilitate legislative review, I have also attached a summary of the major changes.

Prior to Commission adoption, all of these amendments to the standards were the subject of a full public hearing held in May 1980. The Commission responded to the oral and written comments made during that hearing process with appropriate changes to the proposed amendments.

Given our experience in dealing with these revised standards since they went into effect in July, we strongly believe that they are more effective in protecting the environment, while minimizing burdens on landowners, than were the standards prior to amendment. The Commission and its staff are committed to an ongoing process of reviewing and improving these standards in order to assure that they are fully responsive to LURC's statutory mandate. I will be happy to meet with the appropriate legislative committee and/or yourselves to further explain these amendments.

Mr. MARTIN: Madam Speaker, Members of the House: It was with great sadness this morning that I and members of this body learned of the death of Ken Mills as the result of a tragic fire. It is with sadness and some nostalgia that we remember him.

Ken and I arrived at the Maine Legislature together in 1965. I, as he would say, was almost too young to be here, not long out of college, and Ken was already the loveable old curmudgeon we all remember. He taught me much about what it really means to be a legislator, because Ken was truly a representative of the people.

For Ken, Washington County and his constituents came first. For those of you who remember how he fought for Eastport and for Washington County, when you were against him, you knew you might as well give up because you were going to lose. He was a relent-less fighter in the efforts to better the conditions and lives of the citizens in this economically depressed area of Maine. His unself-ish contribution of his time and energy will live

Besides Washington County, Ken had two great loves—the Maine Legislature and his wife, Irene. When Irene died a few years ago, a

part of Ken died with her.

Despite his own problems, Ken always had time to lend a sympathetic ear to his friends, neighbors and colleagues. He loved to share the benefits of his experience as a law enforcement officer in Massachusetts and wisdom with those of us who hadn't been around quite as long as he. Even after he retired from the Maine Legislature, he still called us. Not long ago he called my office to keep in touch with all of us and took an active interest in the problems facing our state and, in particular, those that faced Eastport and the surrounding area.

Many of us here have our own memories of Ken, and each of us will mourn him in our own way, but the best tribute we can pay him is try to emulate the kind of dedicated and caring legislator that he personified.

There is no one to whom we can more fittingly say: "Well done, thou good and faithful ser-

As an individual, I met Ken Mills for the first time my first term here in the 108th Legislature. As you pointed out your experience with Ken your first term here, I, too, came under Ken's tutoring, so to speak. He showed me the ropes and the ways to go about things. Despite that grizzly exterior, under that exterior laid

the heart of a pussycat.

The State of Maine can ill afford to lose public servants such as Ken Mills, but far more important, Washington County can ill afford it, and the City of Eastport. He was eternally involved in the problems of the county, the problems of Eastport and the people down in that

In respect to Ken, and repeating the words of our Speaker, all I can think of to say right now 'A job well done.
