JOINT RESOLUTION EXPRESSING
APPRECIATION TO THE CARTER
ADMINISTRATION FOR SECURING RELEASE OF THE AMERICAN HOSTAGES HELD IN IRAN

Whereas, the American Embassy in Tehran was seized on November 4, 1979 and a number of American citizens held captive against their will since that time; and

Whereas, President Carter has persistently pursued all avenues with great resolve and determination to secure in an honorable manner

the safe return of those being held hostage; and Whereas, hopes have again been raised by a flurry of meetings and optimistic statements that this crisis which is now in its 15th month

may be nearing an end; and Whereas, through the aid of the Algerian Government, negotiation teams from the United States and Iran, have reached an accord on President Carter's final day in office; and

Whereas, President Carter, Secretary of State Muskie, their advisors and negotiators have worked unceasingly to secure the safe release of the 52 remaining hostages and to answer the continuous prayers of heartbroken relatives and an anxiously awaiting Nation; now, therefore, be it

Resolved: That we, the Members of the 110th Legislature of the great and sovereign State of Maine, join our fellow citizens in expressing our gratitude to President Carter and his administration on this memorable day for his hard work and untiring determination to end this ordeal and to bring our countrymen safely home; and be it further

Resolved: That a suitable copy of this resolution be sent forthwith to Former President Carter in token of our sincere thanks.

The Resolution was read.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker, Ladies and Gentlemen of the House: I appreciate the fact, Mr. Speaker, that you acquiesced to my re-

quest to speak on this matter.

Yesterday, in my opinion, was a day of great happiness, a day of anxiety, and a day of anger. I think probably my feeling of anger started out back four days after the hostages were kidnapped and I was in Washington and got the first indication, with others, but I was alone in this instance, from the President himself and his wife as to what their feelings were. I had an op-portunity to speak with the President at a later date, and I never saw a man who had changed and couldn't appreciate the fact that a man could sit there himself as he did in this period.

My feeling of anger continued and grew to a boiling point a few days ago, when I walked arm and arm with the United State's Secretary of State, our friend Edmund S. Muskie, when he answered me with one sentence and I am not going to describe here, and that was good

enough for me.

Listening yesterday very attentively to the tube, I harked back to the words that were said by that great commentator, Walter Cronkite, when he said "they had needlessly been held over (they being the hostages) one day as they had been held over illegally and needlessly 444 days, and certainly held over for the last six and a half hours." And the proof of that pudding bore proof when we heard somewhere around 2:30 P.M. that they were out of the Iranian sector, and then came the signs, the signs for that 443 days had been "Down With America, Down with Carter." Immediately, we heard they were out of sight, out of range, and then it cropped up again among Iranians at the airport and there it was—"Down with America, Down with Reagan."

Those remarks truly frustrated me after I

had just heard the Inauguration of Ronald Wilson Reagan as the 40th President of the United States who has acted and did act, and even then was acting, like a true gentleman by leaving this program to the previous adminis-

tration.

I also heard with good attention, the Inaugural Address, and one comment in particular that President Reagan made was this, and I am going to try to quote verbatim- "Remember that the federal government did not make the states; the states made the federal government.

To that end, the thought occurred to me that when all things are broken down we got very little out of this. I got thinking, what would stop any downtrodden country or far country in Africa—three or four of them who call themselves countries—to get together, capture our Americans there and hold then up for ransom.

I harked back immediately to the words of President Reagan about three weeks ago, and some critized him-I am not of the same political faith but I sure bought his words when he used the word "barbarians." In my book, it was not only a good word but was a mild word. I thought then that this might be an opportunity for us to ask our leaders, and I particularly address myself to you, Mr. Speaker, to our majority leaders who share in the legislative council and our minority leader, I would like to appear before them sometime to have a meeting soon, not with the thought in mind of a congressional resolution but of doing something as a state with our representatives in the Congress, even if we had to send our leaders to Washington exercising our motto "Dirigo" and do something about it vocally because it could happen tomorrow like it happened over a year and a half ago.

I have spoken to more diplomats, members of the Congress, House and Senate, about this thing more than I have probably in all the years that I have been in government life put togeth-

I am extremely happy for the hostages, the families of the hostages, their friends and I am sure that they also recognize the fact that the previous administration had severe problems as to what to do—where it started and where it ended. It reminds me of something that happened back in the middle forties in Japanidentical situation, on a bigger level, however. I think a great many of these people should realize that the honor of the country was placed in a second slot to save the lives of these people.

Yesterday was the last day of their captivity; yesterday was the inauguration of a man who will be President of the United States for the next four years, and certainly the people of the country had a right to rejoice, and I wish that man well, and I want to commend him, his word has just reached me that President Carter and our own Secretary of State, Former Secretary of the United States Muskie and his entourage are on their way to Germany. I can't help but make this comment-God bless them, God bless America and God bless Jimmy

The SPEAKER: The Chair recognizes the

gentleman from Scarborough, Mr. Higgins. Mr. HIGGINS: Mr. Speaker, Ladies and Gentlemen of the House: I, too, would like to commend former President Carter in his attempts and the final fruition of getting the hostages home from Iran. Obviously, Secretary of State Muskie deserves a lot of the credit, as well as his office in Washington and those people who worked very diligently in the last two or three weeks of the Carter administration to get these people home.

I think it is unfortunate, part of the political stupidity, I guess, of the Iranian government, that they would not see fit to let these people come home while President Carter was still in office, but I guess that is perhaps indicative of the people and the mentality of those people that we had to deal with in the extreme delicate situation that was there for the last 444 days. I think it is perhaps easy at times for many of us to be Monday morning quarterbacks and have reasons and all that sort of thing of why the hostages weren't brought home and everybody had their own play end or their own reason or how they would have solved the situation, but I think it is to the credit of the administration that they did get the people home and no one was hurt, but I think we need not lose sight of the fact that we did lose eight people in attempting to get them home almost a year ago in the rescue attempt. I think we need to remember that.

I think it is really fitting that on their way home last night, the Air Force served them turkey dinners while they were high in the sky and high in spirit, I guess its Thanksgiving. I think we need to address ourselves to that and I think we need to thank and be thankful not only that these people are home but that they have a place to come to and the nightmare of the last 14 months is over.

So I, for one, on the other side of the aisle, also do wish to commend former President Carter. I think that obviously joy and happiness is instilled in us and I hope a new era has been brought about because of this and I hope that the American people will be uplifted by the whole situation here. We do have people who are concerned and have gone out on a limb and tried to help these people.

I thank the gentleman from Lewiston for introducing this memorial and I thank him also

for allowing me to be a cosponsor.

The SPEAKER: The Chair recognizes the gentleman from Auburn, Mr. Brodeur.
Mr. BRODEUR: Mr. Speaker, Members of

Yesterday, around noon, Jimmy Carter became a private citizen of these United States, a step I am sure will take a lot of getting use to, one that took a man from the position of the highest to the position of one of the everyday citizen.

History and our historians will tell us what kind of President Jimmy Carter was; today, I would like to address the kind of man that Jimmy Carter was. He was a kind man, an honest man, a caring man, a man who didn't accomplish all that he set out to do or all he would like to have done, but he tried and he gave us his best. He was an outsider when he came to Washington and he was an outsider when he left. He was elected at a bad time for politicians as we know them-it reminded me a little of our own James Longley here in Maine. They were non-political candidates the people turned to during trying times, yet they were elected and they served.

In these last few years, I have come to respect any one who runs for office, especially anyone who runs for the nation's highest office, and so I have come to respect Jimmy Carter.

I first met Jimmy Carter in 1975 at the Silent Women Restaurant in Waterville, Maine, where he was visting then with Ex-Governor, Ken Curtis. He looked very young at that time; he impressed me then and he impresses me now. I then had the honor of speaking to the Honorable Jimmy Carter on the telephone last February during our caucuses here in Maine, and as I watched and listened to him during the days of his Presidency, my respect is still growing for this man from Plains, who was our 39th President.

This morning I removed my vellow ribbon from the lapel of my suit and put it away, and as I did, I stopped to think of the courageous Americans affected by the Embassy takeover in Iran, the 52 held hostages and the eight that died trying to rescue them and how they were coming home. My thoughts then returned to Jimmy Carter, a man who had always put personal freedoms and basic human rights as a top priority, a man who had helped bring our people home. And as his time of rest comes to pass, I wish him the best, the blessing of God, peace, happiness and good health, for he had done all a man can do

I close by thanking Jimmy Carter for taking the time to run for office. I thank him for serv-ing in that office but, most of all, I thank James Earl Carter for taking the time to care.
