He no doubt gave the Maine State Police their 40 hours, but each week he gave a second 40 hours and more. All law enforcement agencies in this state could rightfully claim Eddie Marks as a part of their department.

In the days of the standard typewriters, he was a walking computer for law enforcement.

It is so easy to recall this centurion, who usually, between the hours of two and four in the morning, would walk into the Portland police headquarters and I would take him on a tour of the city. Conversation would center on his concern about a car that they parked near a business establishment at 3:10 a.m. near Caribou on the previous Friday. Eddie would already have learned that the car was registered to a not so popular Portland resident. He would complete this investigation and move on. Yes, Major Marks belonged to us all.

I feel that no greater tribute can be given to this man than to say "he was a good cop." And on that long ago day, back in 1925, when was heard, "I, Eddie Marks, do swear that I will faithfully discharge to the best of my abilities, the duties encumbered on me as a Maine state trooper according to the Constitution and the laws of this state so help me God."

Today, let us pause only to say: "Thanks, Major Eddie, for a job well done." The SPEAKER: The Chair recognizes the gentleman from Warren, Mr. Jordan.

Mr. JORDAN: Mr. Speaker, Ladies and Gentlemen of the House: I thank the gentleman who prepared and presented this very fitting remembrance in honor of Ed Marks. I vividly remember when I was running for this seat that I met Ed Marks at his home in Thomaston. He graciously invited me and was most friendly and encouraging. I join with so many others to express my sense of loss at his passing.
