The SPEAKER: The Chair recognizes the gentleman from Canton, Mr. McCollister.

Mr. McCOLLISTER: Mr. Speaker, Members of the House: The amendment that I am proposing changes the bill of Resource Development to the Bureau of Social Services. This describes the objectives and responsibilities better of this bureau but the amendment pertains to the state's integrity in the Bureau of Social Welfare remaining the Bureau of Social Welfare.

I will not go over the same arguments of yes-terday but I do wish to rebut the attempt to cloud the issue.

I said the bureau was going to ask to spend \$81 million on welfare, I was wrong — the amount is \$81,722,140. This can be verified on pages 336 through 346 in volume 2 of your budget document. If we are to disperse \$81 million for welfare, let the people know the generosity of Maine's working men and women and their willingness to share with the less fortunate fellow citizens, the fruits of their labors. Vote yes on the amendment before you and retain the bureau of social welfare.

The SPEAKER: The Chair recognizes the gentlwoman from Hampden, Mrs. Prescott.

Mrs. PRESCOTT: Mr. Speaker, Ladies and Gentlemen of the House: As the Chairman of the committee, we would have to oppose this amendment because the committee discussed changing one name and not the other and the committee rejected that idea. The major program units of this bureau are the income maintenance programs. The federal government requires that the bureau be called the Income Maintenance Program, so if you take a look at your Maine Annual Report and you look on Page 382, you will see the Bureau of Social Welfare discussed and under the purpose it says that the primary responsibility of the Bureau of Social Welfare are to administer state income maintenance programs as required by federal regulations.

If you look at the bureau's programs, you will see the reasons that the name is being changed. We are dealing in this bureau with medicaid eligibility, with SSI, with the WIN program, which is the work incentive program-this program was designed to reduce the dependence on welfare programs. We have a child support enforcement program in this bureau and last year, this child support program, increased the child support collections by nearly 20 percent. This bureau also administers catastrophic illness programs. It revised in the last year, the principles of reimbursement under the boarding home collection program. It operates a major computer program called the MMIS system, which is the Management Information System, which is simply a billing system which reimburses providers. These are all income maintenance programs and I see no

reason why we do not call the bureau, the Bureau of Income Maintenance and I would move the indefinite postponement of this amendment

The SPEAKER: The Chair recognizes the gentleman from Livermore Falls, Mr. Brown. Mr. BROWN: Mr. Speaker, Ladies and Gen-tlemen of the House: I rise this morning to commend the gentleman from Canton, Mr. Mc-Collister for bringing this very pertinent issue to our attention. He was, as I am sure you all know, the single signer of the 'ought not to pass' report — that takes a lot of courage, I think. It takes a lot of courage for a freshman in particular to stand alone in committee where pressure is obviously very great to ride with the majority. I think the comments that he made are apropos to the point and certainly relative to what we are talking about and relative to what the masses of the people in this country are talking about.

It was sparked to my attention yesterday when he mentioned the area of income maintenance - this was a term that we did hear several years ago — it is a term that scared many of us nearly out of our wits. Probably my seatmate is perhaps correct in that we are maintaining income now - unfortunately, I think that is an unfortunate thing that has happened in our society but it is probably true. But I don't think that we have to encourage it by renaming this bureau or adding to the bureau the name Income Maintenance, I don't think we have to go quite that far.

I would certainly oppose the indefinite post-ponement motion and I would hope that we could postpone or defeat the gentlelady's motion and go on to approve the amendment before us

The SPEAKER: The Chair recognizes the gentleman from Auburn, Mr. Brodeur. Mr. BRODEUR: Mr. Speaker, Members of

the House: I think the gentlelady from Hampden has expressed some of the reasons why we should change the Bureau of Social Welfare to the Bureau of Income Maintenance. The amendment would create now two bureaus, the Bureau of Social Services and the Bureau of Social Welfare.

I would like to speak a little bit to what the Bureau of Social Welfare used to do. They used to have two divisions, one of public assistance, one of child welfare services. In the Division of Public Assistance was Old Age Assistance, which is now in the Bureau of Maine's Elderly; Aid to the Blind and Aid to the Disabled, which is now in the Bureau of Rehabilitative Services and aid to families with dependent children. The Social Services were provided primarily so the Division of Child Welfare, which was to address the population of children in the custody of the state. What is now is that some programs people are targeting as welfare programs and very frustrated about, very angry, especially and almost consistently towards abuse of these programs and I share that anger and frustration when people abuse these programs. I don't think we address those angers or our frustra-tions by attacking a bill, I don't think the integrity of the department is put down when we try to change the name to the Bureau of Income Maintenance. I think it is very clear that income maintenance is a solution to the problem of people in need so the AFDC program will continue to be named the AFDC program and this bill does not change that.

The food stamp program will continue to be the food stamp program and this bill doesn't change that either. The general assistance program will continue to be the general assistance program and this bill doesn't change that. I don't see how the integrity of this department or what we are doing here will be changed by changing the Bureau of Social Welfare to the Bureau of Income Maintenance.

I would like to point out that the problem of welfare is one beyond that of giving people as-sistance and I think the Bureau of Social Welfare to be named hopefully, the Bureau of Income Maintenance, addresses that issue. The problem, for instance, of the AFDC question is a problem of spouses leaving their wives in most cases and not leaving them with child support payments, which the court has ordered the Support Enforcement and Location Unit enforces those court provisions by trying to find out absent spouses to make sure that they are following up on their court payments for child support.

Another program is the WIN program -awork incentive program - and this again is an income maintenance program, not a social welfare program. This is a program designed to get people off welfare, to make sure that they are able to find work working with the Department of Manpower Affairs, to make sure that working with the Department of Manpower Affairs again, they get training for skills for jobs to help arrange transportation to work, to help arrange child care for those people who do want to work.

Other problems that I think were arguments that I have heard in the halls, not before this that I have neard in the name, not before this House, is that this will cost some money. That question was addressed in the public hearing when I asked if it would cost money to change over the stationery and I called up about five minutes before the House went into session this maximum and asked again if it would cost any morning and asked again if it would cost any money and the director of the Bureau of Social Welfare said that simply is not true. The stationery will be used until it is all used up; in fact, most of the stationery in the department or the Bureau of Social Welfare says: The Department of Human Services and not Bureau of Social Welfare so there is no costs that will be made for this bill.

I hope you will vote yes and indefinitely postpone this amendment.

The SPEAKER: The Chair recognizes the gen-

tleman from Enfield, Mr. Dudley. Mr. DUDLEY: Mr. Speaker, Members of the House: I would like to support the amendment. I come from an area in the state where most people that I represent or a good part of them work for a living and they would strongly say that this is not in the best interest of the working people of Maine and they see nothing wrong with the title we have now. It has worked nicely down through the years and I see no need of changing something just for the sake of a change. I think the same people that would change it in this manner would also change to the Department of Recreation, because where I come from, most of these people work seven days a week down in the paper mill and the people from this other department we are now trying to change the name, don't work at all — they have skidoos, go skiing and skating, hunting in the Fall and fishing in the Spring while these other noor neople that I represent while these other poor people that I represent, or try to here, are working hard to try to pay these bills. So, I suspect if they amend it in this term of the legislature to what they are trying to do today, I wouldn't be a bit surprised in the next legislature, they would try to make it the Department of Pleasure or something in that area, so I do hope that the House, in their good judgment and good sense, will leave it as it is and do that, you would vote in favor of the

amendment. The SPEAKER: The Chair will order a vote. The pending question before the House is the motion of the gentlewoman from Hampden, Mrs. Prescott, that House Amendment "A" be indefinitely postponed. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken.

55 having voted in the affirmative and 79 in the negative, the motion did not prevail. Mr. Kelleher of Bangor requested a roll call. The SPEAKER: For the Chair to order a roll call, it must have the expressed desire of more than one fifth of the number of the number of the system. than one-fifth of the members present and voting. Those in favor will vote yes; those opposed will vote no.
