Monday, February 2, 1981 The House met according to adjournment and was called to order by the Speaker.

Prayer by Father Thomas Joyce of St. Mary's Catholic Church, Augusta.

The members stood at attention during the playing of the National Anthem by the Mon-

The Chair recognizes the gentleman from Dexter, Mr. Sherburne.

Mr. SHERBURNE: Mr. Speaker, Ladies and Gentlemen of the House; I am on the other side of the vote by the committee. I am not strongly opposed to this bill but we do have some con-

The price of registration in the last year or two has gone from \$10 per pesticide to \$50, which was a 500 per cent increase, and this bill is proposing another \$10 increase, which would make a 600 per cent increase.

I think we do need to study the results of pesticides, but I am concerned about the big increase in the registration fees. Naturally, these fees will be passed on to the farmer, and from the farmer they have got to be passed on to the consumer. This is my main concern with this

The SPEAKER pro tem: The Chair recognizes the gentleman from Canton, Mr. McCollister

Mr. McCOLLISTER: Mr. Speaker and Members of the House: We are dealing here with hidden taxes. If a department wishes to provide a new service or new program, let them go through the normal channels of asking for an increase in taxes instead of putting them under the table and applying these in the manner which they have done here.

The SPEAKER pro tem: The Chair recognizes the gentlewoman from Sebec, Mrs. Locke. Mrs. LOCKE: Mr. Speaker, Men and Women of the House: Yes, it is true that the pesticide registration fee has gone up quite a number of per cent in the last year, but the reason for that was, last summer the Board of Pesticide Control was put into effect and that additional money, \$40 as opposed to \$10, is used for the Board of Pesticide Control. They have to use that money in order to function. They have staff and they have expenses and whatever. This additional \$10, which would be paid by the manufacturer who registers his pesticide within the state, and, by the way, there are about 3,000 who register in the state each year, will be used solely for research into the com-plaints that the department has every year. That is all that it is supposed to be used for. It will be used for a little bit of research because actually, probably the \$30,000 that it would generate would not cover everything and all of the research that should be done

But it seems to me that the people who register their pesticides, such as Dupont, Union Carbide, should be bearing the cost of research into the safety of the pesticides they register.

Now, we know that that money will trickle down to the consumer, but if you take into consideration that the \$10 is spread over a large portion of the population, for instance, every body who buys a can of Raid will share in that \$10, the amount of money that the consumer will bear will be minimal; it may be a few cents or it may be a portion of one cent. It seems to me that maybe we, the user of the pesticides, should be contributing a little bit of money toward research into the safety of the pesticides we use. That research would hep us as a family if we are using Raid to know whether we are using a pesticide that is safe or if we are applying it correctly, and it should be a help to the farmer to know whether or not they are using it correctly.

Also, it may do away with some of the com-

plaints. If good research is done and we find that some of the complaints are empty and perhaps the reason that the tops of the gardens in Dennysville were brown for some other reason, I am sure that the Department of Conservation and the users of the pesticides that were used at that time, which was the budworm spraying, would be happy to know that that was not the cause of the defoliation or whatever happened

to the gardens in Dennysville. I can't see what the complaint is to add \$10 to

the registration of 3,000 pesticides that are used in the state each year, or registered. The SPEAKER pro tem: The Chair recognizes the gentlewoman from Cape Elizabeth, Mrs.

Masterton. Mrs. MASTERTON: Mr. Speaker, the question that I would like to pose to anyone who would care to answer—in the past two years in this legislature, we have had a lot of discussion about an environmental health team, and my question is whether laying on this additional fee at this time would not preclude our consideration of that health team again in this legis-

lature—is it a little premature? The SPEAKER pro tem: The gentlewoman from Cape Elizabeth, Mrs. Masterton, has posed a question through the Chair to anyone who may care to answer.

The Chair recognizes the gentlewoman from Sebec, Mrs. Locke.

Mrs. LOCKE: Mr. Speaker, I don't think we can wait. If the environmental health unit is put together and if they can do the job reasonably, at a reasonable cost, most likely it would be used, but there is no assurance that that will happen, and the complaints continue and the use of pesticides continue every day, winter, summer, whatever, and we feel that we have to start, we have to get going on this project because we don't have the answers. So, it would not preclude that particular unit.

The SPEAKER pro tem: The Chair recognizes the gentleman from Presque Isle, Mr.

Lisnik

Mr. LISNIK: Mr. Speaker and Members of the House: First of all, Mr. McCollister, this is not a new program. Research is presently being done but by volunteers from the Maine Medical. We cannot expect these doctors to continue this effort indefinitely.

As to the cost, first, the manufacturers will be asked to pay the \$10 registration fee, not the distributors — I want to make that clear. When you take into account the worldwide nature of sales and the widespread use of pesticides by housewives, store personnel, pet owners, foresters, farmers, florists and weekend gardeners, the added cost, if any, would be minimal.

I took the liberty of checking on the various companies and corporations that we register in this state, such as Abbott Laboratories, Agway, Chevron, the sales of these companies are staggering — \$1.4 billion for Abbott; \$2.4 billion for Agway; \$8.2 billion for Dow Chemical; Hart's Mountain Corporation grossed \$14 billion in annual sales. I think you can see the registration fee will affect these companies very little

The SPEAKER pro tem: The Chair recognizes the gentlewoman from Presque Isle, Mrs. MacBride.

Mrs. MacBRIDE: Mr. Speaker, Ladies and Gentlemen of the House: Just to answer Representative Masterton's question, we do have an environmental health bill coming in very shortly. It is ready to be printed and you will have a report, which should have been on your desks last week but I guess that isn't quite ready yet either, but that will be on your desks sometime in the next week or so with a presentation for their future.

The SPEAKER pro tem: The Chair recognizes the gentleman from Mechanic Falls, Mr.

Callahan.

Mr. CALLAHAN: Mr. Speaker, Members of the House: I am in opposition to this bill mainly because we are one of the poorest states in the nation and this fee will be the highest in the nation; California will be second at \$40 for a

I would like to request a division.

The SPEAKER pro tem: The Chair recognizes the gentleman from Limerick, Mr. Carroll. Mr. CARROLL: Mr. Speaker, Ladies and Gentlemen of the House: It so happens that I

buy pesticides. We have an agricultural enterprise known as Alderwood Farms, Inc., and the chemical companies and Agway, who have grown by leaps and bounds, have ripped us off now for the last five years, socked it right to us. They have made tremendous profits and they haven't hestitated to up the ante every year. They have walked it right to us, don't you think, they haven't and don't you think we ought to take a little bit away from them? I say, let them ante up at the table just like the rest of

They charge us 181/2 percent and they will even tack interest on interest. They will take and figure out what you owe them for a 30 day period, then walk right back over it and charge you interest from the 1st and 31st. If you don't think we are being ripped off, you come down and look at my books. They walk it right to us. Looking at their profits. I get a 1 percent dividend from Agway and when I belonged to East-ern States, I got about 15 percent, and you say they are working for the farmer. Who is working for the farmer? That is what I want to know. Where are all these farmers here that belong to Agway? Why don't they get up and tell you just what I am telling you, how they are ripping us off? They have lobbyists out here running around. He isn't running around for us farmers; he is running around making sure those that run Agway do the same as some of

our state bureaucrats, rip off us people.

I can tell you that \$10 isn't going to break them.

The gentleman over here on the right, Mr. Sherburne, I think he is a fine man, but I think they are misleading him, because when you talk about a 600 percent increase on what they are paying, when they started off paying nothing, how can you hurt them? All we are asking to do is pay a little bit into this fund so when they come around to tell me - now Carroll, you should use this spray, it is going to kill all them weeds, and I use this spray and it doesn't kill any of the weeds, I want them to know it is going to be a two way street. We are going to protect the health of the people but also let them know whether they are selling anything that is any good. I think that is what is worring them, they don't want anybody looking over their shoulder and find out what they are selling isn't any good.

I say that the Agricultural Department not only should be doing this but they should be weighing every grain truck that goes down the road. They weigh that truck up, send it out to the farm — how do you know what they are getting out there, we don't? They pour it in bins and say you have 6,000 pounds - maybe I have 4,800. That truck has never been weighed, no sir. In New York state, they weigh them, they almost put them out of business out there because they found they were rooking the farmer.

I am all for this bill and I don't think we should hide behind 600 percent interest, because 600 percent of one cent isn't anything. We are not asking them to pay anything, we are just asking them to ante up at the table just like they ask me to and don't you think they don't walk it to me because they do. They put the old interest right to me.

The SPEAKER pro tem: The Chair recognizes the gentleman from New Sweden, Mr.

Nelson.

Mr. NELSON: Mr. Speaker, Ladies and Gentlemen of the House: I was a spray material salesman for about 35 years and we had many meetings with representatives from the pesticide and spray material companies showing us how it was put together and the research that was put into it. There were millions of dollars and there is still millions of dollars put into research. Like my friend Mr. Carroll says, \$10 isn't going to hurt anybody but it has to stop somewhere.

I don't think this bill is necessary, and I would like to see you vote with the minority.
The SPEAKER pro tem: The Chair will

order a vote. The pending question before the House is on the motion of the gentleman from Easton, Mr. Mahany, that the House accept the Majority "Ought to Pass" Report in concurrence. Those in favor will vote yes, those opposed will vote no.

The minimum number of valid signatures required to initiate this legislation is 37,026. On January 22, 1981, our office received 1,767 petitions said to contain 43,268. After extensive review we have determined the number of valid signatures to be 43,214.

In view of the foregoing determination, I hereby certify that these petitions have met the constitutional requirements of the minimum of 37,026 valid signatures. Since the petitions have previously satisfied the constitutional requirements in all other respects, under the provision of Article IV, Part Third, Section 18, of the Constitution of Maine, I do hereby declare this initiative petition to be valid.

In the event that the Legislature rejects this iniative proposal, a referendum election will be

called for November, 1981.
