The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Tarbell.

Mr. TARBELL: Mr. Speaker, Ladies and Gentlemen of the House: This measure before us today, in the form of a divided report out of Transportation Committee, is the first of many measures that we will have to entertain and deliberate in trying to resolve the highway fund-ing problem and the highway problems that face us in the state of Maine over the next two years.

I would just like to go back a little bit in history to the last legislative session, not only to the last legislative session but the session prior to that, when this plaguing problem which has confronted us, how to fund highway system, has been patched up with bandaids, with patchwork over the last several years. We were promised last year that if we did go ahead with another bandaid proposal, which we ultimately adopted in a special session, that we would have before us a very comprehensive solution proposed by the Chief Executive and the De-partment of Transportation for the long-term resolution of the highway problems with a new program to serve us through the 1980's, a new decade.

The understanding was that this particular fee increase, which our Governor has repeatedly said is not a tax increase, whether it is driver license fees, motor vehicle registration

fees, which we have all increased as a legislature in state government over the last several years, our understanding was that if we went along once again with this fee increase that it would be sunseted, not too early in the session but early enough into this session in which we now find ourselves, so as to force us, the legislative branch, as well as the executive branch and the Department of Transportation to meet this problem head on in realistic and sensible fashion once and for all and not in a piecemeal, bandaid approach that we have adopted in the

Well here we are, one week prior to the sunsetting of this particular fee measure, and we do not have before us a comprehensive, realistic proposal for meeting these problems of our highways for this decade, let alone for this year

or next year or this biennium.

I would like the members of the House to look beyond this particular issue of driver license fee increases to the broader issue and put this matter that is before us today in a larger perspective. That is, we are going to need a massive, comprehensive program, not bit by bit, or piece by piece, or fee by fee, or tax by tax, or cut by cut, or raid here or raid there to the general fund, but a comprehensive, overall package that makes sense fiscally and highway-wise for the next couple of years for us to vote on, for us to analyze and to ultimately adopt one way or the other for the next couple of years. We don't have that, and this measure before us was intended to sunset to force us to confront this problem early on and head on and to work on in a sensible fashion, but we don't have that. We may never, and we may continue to go along the road as we have in the past, pushing the major problems in the legislative session off to the very last weeks or very last few days of the session. I predict today, that is where we are at right now by not confronting this thing head on. Enough fees — they can't patch up the situation by not a long term solution and proposal and I urge you, at this point in time, not to continue this charade.

The SPEAKER: The Chair recognizes the

gentlewoman from Vassalboro, Mrs. Mitchell. Mrs. MITCHELL: Mr. Speaker, Men and Women of the House: I listened carefully to my colleague in the opposite corner trying to determine one single, valid reason that he is leading his caucus against this good piece of legislation before us today. I hear him trying to attack the executive, trying to attack the people that are planning transportation by saying it is a bandaid, a piecemeal approach. Well, I suggest to you, my good friends in the legislature, that he is attacking you as legislators, because he is asking you to be irresponsible, he is asking you to come out with some great package which I interpret to mean a gas tax or something to that effect that he has designed or his caucus has come up with, perhaps, as the overall answer to the highway problem. But I am suggesting to you that we have a process here. We are all elected representatives, we are all serving on committees - speak to the chairmen of the various committees, the chairman of Transportation, the chairman of Appropriations, the chairman of Audit and Program Review, who is studying the highway department this very year, speak to all of the chair-men who are trying to deal with the complex problems of state government and tell me if here today, in early February, you can come up with a comprehensive package of any kind.

The Governor, however, has presented his package and I think we, as responsible legislators, should look at that package. How do you know how much money you need until you set a level of funding?

We passed this bill last year not because we thought it was the best thing to do but because it was the only thing to do demanded by certain leaders in the other party. The sunset was realistic then, it is unrealistic now, because we cannot do our jobs as legislators if we try to

shortcircuit the process.
Go through your calendar sometime and look at the many bills that the Governor has before us already. I won't bore you with all the details now, but you will find at least six or seven of them already presented. In fact, we heard one yesterday to undedicate the highway fund.

Just what is a comprehensive package? You do have one; you may disagree with it but how do you even know that responsibly? The only responsible thing to do is to continue this with a sunset provision, if you wish, until we have had time to really look at the state's finances, the state's highway department and all the needs of state government.

Mr. Diamond of Windham requested a roll call

The SPEAKER: For the Chair to order a roll call, it must have the expressed desire of one fifth of the members present and voting. Those in favor will vote yes; those opposed will vote

A vote of the House was taken, and more than one fifth of the members present having expressed a desire for a roll call, a roll call was ordered

The SPEAKER: The Chair recognizes the gentleman from Scarborough, Mr. Higgins.

Mr. HIGGINS: Mr. Speaker, Ladies and Gentlemen of the House: I guess it bothers me a little bit that the gentlelady from Vassalboro today is trying to perhaps point to us who intend to vote against this issue as irresponsible or perhaps even obstructionists.

I think we all there know that our highway department is in serious financial straits, and I think we all here know that the fees that we are talking about today could well be used by that department but there is something perhaps bigger, larger than this question, and that is the principle. The principle with which this program was sold to this House on May 22 or 23 of last year was that by the end of February we would have some sort of solution or proposal which made some sense to this body

There is no question that we have a tremendous investment in our road system in the state of Maine and I, for one, don't want to see that particular system deteriorate beyond the state that it is in right now. But I think if there is one thing that our caucus is saying, that is, we have to look at the total picture now, not wait until the end of the session when things tend to get clouded and confused. We can do it in a rational and an unhurried basis right now. I don't think any of us here expect to come up with a total answer by the end of February, but I do think we expect to have some program that deals effectively and rationally with our highway situa-

Now, the Governor has sent us a budget and that is the package to which my good counterpart in the other corner alluded to. But I would remind her and members of this House that the \$26 million which the Governor has asked for out of the general fund to plug the gap that we need to fund our highway system adequately was refused by the Appropriations Committee and, as far as I know, member of leadership is opposed to taking money from the general fund, so I guess when I look at it, I say, that is not a reasonable and rational approach to solving our highway situa-

I think our intent today is to focus our attention on the seriousness of the problem. We are all here, we all want to solve the problem, it is not going away, but I think we need a longer term solution and I think we need some flexibility, if you will, between all the parties involved, not only the Republican party, the Democratic party, the legislature and the Governor's office, but to sit down and try to come up with some answers. We may not know the total budget that is required, but we know that we need additional money in that department and where is it going to come from?
The SPEAKER: The Chair recognizes the

gentlewoman from Vassalboro, Mrs. Mitchell. Mrs. MITCHELL: Mr. Speaker, Members of the House: I would like to respond briefly to several comments that have been made. One was the idea that leadership was opposed to taking money from the general fund; obviously, that is an initial reaction. Until the Appropriations Committee has heard the entire budget, we don't know if there is money there or not. We must deal with the process, we must hear the entire budget, and we must know for sure, and I defy any members of your caucus who say that there is no general fund money available to tell me why. What says to you, at this point of the legislative process, why there is no money there?

The other comment that was made is that everybody here knows that additional money is needed. I would like to ask everyone who is planning to vote against this bill, do you believe that the highway department does not need money from this funding source, and if you vote today to say that they cannot continue the license fee increase, will you come back in June and then vote to put the license fee increase back on, having excluded a small portion of people whose birthdays happen to fall between now and June 1? That is ridiculous logic and I do hope that is not part of your comprehensive plan.

I suggest that you go back again, look at the Governor's plan and let's indeed, work together, but why cut off our noses today to spite our face? We have a revenue source, we all admit we need it, why should we throw it away?

The SPEAKER: A roll call has been ordered. The pending question before the House is on the motion of Mr. Carroll of Limerick to accept the Majority "Ought to Pass" Report.

The Chair recognizes the gentleman from Augusta, Mr. Paradis.

Mr. PARADIS: Mr. Speaker, I would like to pair my vote with the gentleman from Monmouth, Mr. Davis. If he were here, he would vote no and I would be voting yes.
