Mr. MURPHY: Mr. Speaker, Men and

Women of the House: I would like to speak in opposition to the "ought not to pass" report. L. D. 536 proposes a four-year term for the attorney general. The attorney general presides over the largest law office in the state, with a staff of almost 70 lawyers. He also serves as the legal advisor to the legislature.

During the last century, the attorney general's responsibility to the people has grown as he represents the state and its agencies in all civil actions in which the state is a party. His written opinions are requested by the Governor and the legislature. The Criminal Division, Civil Division and chief medical officers are within his office. His office also has branches in state agencies, and also reporting to him are the fulltime district attorneys.

As our society has become more complex, sadly, litigation has become more complex and lengthy. With a two-year term, the attorney general must now face the fact that he will not be able to bring to court the case he has prepared or be able to follow it to completion. The people of Maine deserve the continuity of representation in their cases. The people are not well served by the present situation where Maine has three attorney generals in three and a half years. No firm in this state would tolerate that type of turnover in administration.

Luckily, all three men have been of the highest caliber and integrity, and I would like to make it absolutely clear that this proposal is in no way a criticism of any past or present attor-

The effect of this every two year disruption of the people's business creates a climate within the attorney general's office where attorneys cannot make long-range plans either about the nature of their work or their role. This has to affect their cases.

As litigation increases in complexity, a greater need is there for a corps of experienced

attornevs

The election of the attorney general in joint convention strengthens the two-party system; a change to a four-year term would not threaten that spoil system. Indeed, after the partisan battle is over and the blood is mopped up off the floor, the new attorney general can get down to his larger responsibility, representing the people of Maine

The precedent for extending the attorney general's term is there. In 1879, the legislature and people of Maine amended the Constitution to extend the tenure from one year to two years. Amending the Constitution is serious business and should not be taken casually. The changes that have occured during the past 100 years warrant a new look at the term. The attorney general, one elected by these two legis-lative bodies, serves the people. L. D. 536 proposes strengthening the stability and continuity of that office.

I urge you to accept the "ought to pass" report and send this proposal out to referendum, to the clients served by the attorney general, the citizens of Maine.

Mr. CONNOLLY: Mr. Speaker and Members of the House: Even though I am in opposition to the bill, I don't think that there is any doubt

that this bill is going to pass.

This amendment that I am offering today is not, I don't believe, a controversial amendment. It has been run by the people who led the fight for the bill in this body, as well as the sponsors in the other body, and they have no obiections

What the amendment does is, number one, it takes a provision that is currently in the law that mandates scripture reading in the schools, that provision of the law has already been ruled unconstitutional, so it removes that from the law. Then it adds a sentence to make it very clear that the study of the Bible can be taught in classrooms when the Bible or other similar materials are considered literature, so that there is no mistake about the study of the

The first section repeals an already ruled unconstitutional provision in the law. The rest of the bill, as we debated it yesterday, stays the same.

Thereupon, House Amendment "A" was adopted.

Mr. DAVIES: Mr. Speaker and Members of the House: The amendment that I am offering today corrects an inadvertent omission from the bill. The amendment will allow those members of the committee, who are not members of the legislature sessions. These are four members of the public who would be included here, and if we do not include them, they will have to come down on their own expense, and we think that it is unfair for them to have to participate and not be reimbursed for their actual ex-

The money has already been appropriated, it is available in the legislative fund. It was not expended last year, so we are not going to need any additional funds, but we do want to have the ability to pay these people for the work that they are going to be doing.

Thereupon, House Amendment "A" was

adopted.

The Bill was passed to be engrossed as amended by Committee Amendment "A" (S-36) and House Amendment "A" (H-93) in non-concurrence and sent up for concurrence.
