The SPEAKER: The Chair recognizes the

gentlewoman from Portland, Mrs. Beaulieu. Mrs. BEAULIEU: Mr. Speaker, Ladies and Gentlemen of the House: During our last oneday special session, you concurred and agreed to pass a sentiment order commending four members of the Portland Fire Department for above and beyond the call of duty action during a fire in my district which resulted in the saving of the life of a 17-month old child. Since then, those four firefighters, namely John Bellino, Stephen Newcomb, Harold Stoddard and Stephen Hastings have been cited by the City of Portland for bravery and just recently firefighters Stoddard and Hastings have been named firefighters of the year by the Cumberland County Firemen's Association.

Every once in a while some of you tease me unmercilessly at times because of my activities and my promotional work re firefighters. I tend to get sassy once in a while and tell you that I love firefighters because they still make house calls. However, if you get me to talk about it seriously, you all learned that I contend that every firefighter becomes a hero the moment they board a truck and leave that firehouse.

When a firefighter enters a burning building where the temperatures hover at 150 to 220 degrees, where smoke fills rooms and ruins visibility, where gases give off toxic fumes and fire weakens buildings making floors and ceilings unsafe, and wearing 65 pounds of gear, is it any wonder that people like myself do get serious and extremely impressed? In the Munjoy Hill fire, not only were the be-

forementioned conditions in place, but these four men were also placed into a flashback situation and they were in fire from head to toe. And firefighters Bellino and Newcomb found themselves in a heap in the first floor hallway even though the fire was on the third floor.

Firefighter Bellino, for example, for the next year and a half will have to wear special gloves on both hands, the result of skin grafts from his thigh; and firefighter Newcomb was out with burns for over nine weeks.

In our neighboring community of Westbrook, two firefighters, Clyde Chapman and Gregory Peters, also were cited by the association as firefighters of the year. They saved the life of an adult male. Through terrific heat and a smoked filled room with visibility of less than six inches, they located John Sinclair and brought him out to safety.

While all six men I have talked about have said that other firefighters would have behaved exactly as they did, I feel that while we, the citizens, expect firefighters to do their job of saving lives and property, that these public servants did theirs under extremely hazardous situations and at risk above and beyond the call of duty

Mr. Speaker, all of those six men are present today with Chief Winslow from the Portland Fire Department, they are in the balcony and I would ask that they be introduced to my fellow legislators.

Therepuon, the firefighters were asked to stand to accept the greetings of the Maine House of Representatives. (Applause)

The Honorable Camille V. Bedard, of Saco, who served with great distinction as a member of the 100th, 101st, 102nd, 103rd, 104th and 105th Legislatures of this State; (H. P. 1897) by Representative Hobbins of Saco. (Cosponsors: Representatives Roberts of Buxton, McSweeney of Old Orchard Beach, Martin of Eagle Lake and Senators Kerry of York and Wood of York

The SPEAKER: The Chair recognizes the gentleman from Saco, Mr. Hobbins.

Mr. HOBBINS: Mr. Speaker, Men and Women of the House: I do not feel that I could let this Resolution pass without asking us to reflect upon an individual who was a former colleague of ours who passed away on November 20, 1981, at the young age of eighty-nine.

Camille Bedard was one of Saco's finest citizens and one of the state's most dedicated public servants. He served with honor during the 101st, 102nd, 103rd, 104th and 105th Legislatures

I received from Camille Bedard back in 1972 one of the things that I will cherish forever, and that was. I received the faith and confidence from Mr. Bedard to openly endorse my candidacy for my election for the first time at the

ripe age of 20. The reason I mentioned earlier that Camille died at a young age of eighty-nine is because chronologically Camille was eighty-nine years old buy anyone who knew him, I know many colleagues here in this chamber who served with him can tell you that he had a great faith and confidence in the youth of our state.

He also was a man of common sense. He was not educated through formal education or receive his degree from hard knocks more than he received any type of academic degree from any school, but it was that sheer common sense and sense of commitment to the working people of our state that I feel made him a unique individual and someone who the state will miss in the years to come

Before I took my seat in the Legislature, he told me, "There is one thing you must remember in your service to the state of Maine, and that is, you put the state first and yourself second." That is one little lesson I think all of us, upon reflection, realize is what it takes to be a dedicated public servant.

Camille Bedard had an interest in politics that went back to the early 1920's as an early labor organizer. He was an individual who served in the Labor Committee not because he wanted to warm a chair but because he had a deep commitment in the labor movement and for ensuring the rights of working people. He served on the City Council in the city of Saco and was very active in many social service organizations, and I am proud to say that his niece. Deborah Bedard Wood, is our Assistant Clerk of the House

I would hope that all of us can reflect upon the accomplishments of such a dedicated public servant and when the House adjourns, I hope we do so with respect for Camille Bedard. Thereupon the Resolution was adopted and

gentleman from Madawaska, Mr. McHenry. Mr. McHENRY: Mr. Speaker, I would like to pose a question through the Chair. I would like to know what this bill does. Is it going to start a conglomerate through the banking industry of the state of Maine? I wonder if it is necessary? Is that six-months waiting period for a merger such a hard task for the banking industry to take care of? I am sure that the banking industry can see six months ahead of time. I can't see the reason for this. The only reason I think this would be necessary is to start creating conglomerates in the banking industry. The SPEAKER: The gentleman from Mada-

waska, Mr. McHenry, has posed a question through the Chair to anyone who may care to answer

The Chair recognizes the gentleman from Portland, Mr. Brannigan.

Mr. BRANNIGAN: Mr. Speaker, Men and Women of the House: This bill does not deal with ordinary mergers or mergers with the normal course of business in the banking industry. This deals only in an emergency situation, and I use the work emergency in a very formal manner. It would only take place when the superintendent of the Bureau of Banking and his staff made a formal finding that an emergency existed in a situation where a bank was in difficulty, and it was necessary for the merger to take place and to take place immediately in order to save the depositors and the members of that bank. It would not bypass other procedures other than the waiting period. It would not bypass the decisions of the boards of directors and so forth. It would merely bypass the long notice and waiting periods that are required in a normal merger and will continue to be required in a normal merger.

I would also point out that this has nothing to do with a bill that will come along later dealing with out-of-state situations. This is only in the normal course of our own banking industry but in those situations only where there are emergencies and emergencies that are found formally by the Bureau of Banking.

This is a very important piece of legislation in a very isolated case where we must protect the depositors of a particular bank. The SPEAKER: The Chair recognizes the

gentleman from Madawaska, Mr. McHenry.

Mr. McHENRY: Mr. Speaker, I would like to pose another question through the Chair. I would ask if any such emergency has ever occurred in the state of Maine and if so, where?

The SPEAKER: The gentleman from Madawaska, Mr. McHenry, has posed another ques-tion through the Chair to the gentleman from Portland, Mr. Brannigan, who may respond if he so desires

The Chair recognizes the gentleman from Mechanic Falls, Mr. Callahan.

Mr. CALLAHAN: Mr. Speaker, Ladies and Gentlemen of the House: There are 16 independent banks in the state of Maine. The one in Augusta that was organized in 1971 is in trouble. It hasn't broken even financially. This bill will let them merge with banks outside of the state; there is quite a restriction there

There are emergencies. A good portion of the

small banks are suffering in this high interest rate period of time. This is a good piece of legislation. It has nothing to do with individual accounts or banking procedures, it is just to allow larger banks to merge soon enough to save a small bank from being taken over by the F.D.I.C. or going bankrupt.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Brannigan.

Mr. BRANNIGAN: Mr. Speaker, Members of the House: Because this has not been in effect at this point, it has not been used, we have only come, fortunately, into situations like this very recently. The toll of the high interest rates of the last few months, in the last year or so, are taking their toll and banks have been very reluctant to even think about having to be in an emergency situation; I am reluctant to think about them. There are banks right now that are waiting and need this kind of legislation within the next few weeks.

The SPEAKER: This being an emergency measure, it requires a two-thirds vote of all the members elected to the House. All those in favor of this bill being passed to be enacted will vote yes; those opposed will vote no.

A vote of the House was taken.

123 having voted in the affirmative and 2 in the negative, the Bill was passed to be enacted, signed by the Speaker and sent to the Senate. By unanimous consent, ordered sent forthwith.

Emergency Measure An Act Converting West Forks Plantation into the Town of West Forks (H. P. 1784) (L. D. 1774)

Was reported by the Committee on En-grossed Bills as truly and strictly engrossed. This being an emergency measure and a twothirds vote of all the members elected to the House being necessary, a total was taken. 131 voted in favor of same and none against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate. By unanimous consent, ordered sent forthwith.

The SPEAKER: The Chair recognizes the gentleman from Saco, Mr. Hobbins. Mr. HOBBINS: Mr. Speaker, Members of the

House: To enlighten fellow members of my actions, there is another bill which will be presented to the Legislative Council by the Senate Chair, Senator Devoe, and myself which deals basically with the same area as the contents of the title. However, the draft of the bill does not reflect the same title as what the title of the bill intends, and therefore I withdraw the motion and move the indefinite postponement

of this bill and all its accompanying papers. Thereupon, on motion of Mr. Hobbins of Saco, the Bill and all its accompanying papers were indefinitely postponed in non-concurrence and sent up for concurrence.

By unanimous consent, ordered sent forthwith to the Senate.

JOINT ORDER (S. P. 803) re amending Joint Rule 24-A -- which was tabled and later today

The SPEAKER: The Chair recognizes the gentlwoman from Vassalboro, Mrs. Mitchell, Mrs. MITCHELL: Mr. Speaker, Men and Women of the House: As you know, when the House proposes a change in the House Rules. they are automatically tabled one day to give the House an opportunity to take a close look at that rule to make sure they know how they wish to vote. It is not true in the case of Joint Rules, but at least you have had until later in today's session to look at this particular rule.

It is a rule change of little or no consequence because it was the understanding of most people that any Governor's bill could be sponsored by anybody without such a designation as Governor's Bill, so forth and so on. Take a look at 24-A. in dark print you will see the minute change that is being made. It is done in the spirit of cooperation, although many of us felt that the rule was quite clear on its face without this change: however, it does no harm and I urge your support on this rule change. The SPEAKER: This amendment to the Joint Rules requires a two-thirds vote. If you

are in favor of the Order receiving passage in concurrence you will vote yes; those opposed will vote no.

A vote of the House was taken.
