I have the honor to transmit herewith an initiated bill, "An Act to Repeal the Control of Milk Prices at the Wholesale and Retail Levels," and the results of the examination by this office of the initiative petitions relative to it

The minimum number of valid signatures required to initiate this legislation is 37,026. On January 28, 1982, our office received 274 peti-tions said to contain 44,003 signatures. After extensive review we have determined the number of valid signatures to be 44, 414.

In view of the foregoing determination, I hereby certify that these petitions have met the constitutional requirements of the minimum of 37,026 valid signatures. Since the petitions have previously satisfied the constitutional requirements in all other respects, under the provisions of Article IV, Part Third, Section 18, of the Constitution of Maine, I do hereby declare this iniative petition to be valid.

In the event the Legislature rejects this initi-

ative proposal, a referendum election will be called for November, 1982.

#### Passed to Be Enacted **Emergency Measure**

An Act to Amend the Maine Potato Quality Control Program (H. P. 1942) (L. D. 1918)
